Re: Report of the Renewal Application of LaDerle R. Williams for a Public Passenger Vehicle Driver License.

## FINDINGS OF FACT

- 1. LaDerle R. Williams (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license will expire at midnight, October 31, 2014.
- 2. An application to renew said license was filed with the Office of the City Clerk on August 5, 2014.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report that could form the basis of non-renewal or suspension of this license.
- 4. On September 23, 2014, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 1, 2014 at 2:00 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel. This was the applicant's second non-appearance



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Notice was sent to LaDerle R. Williams at P.O. Box 250596, Milwaukee, WI 53225, along with a copy of the police report on September 23, 2014 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of P.O. Box 250596, Milwaukee, WI 53225 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing of October 1, 2014 and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.

## CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, LaDerle R. Williams, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license based upon a second nonappearance.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by LaDerle R. Williams based upon a second nonappearance.

### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of LaDerle R. Williams be denied based upon a second nonappearance.

Vehicle Driver License.

## FINDINGS OF FACT

- 1. Rajdeep S. Grewal (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license will expire at midnight, October 31, 2014.
- 2. An application to renew said license was untimely filed with the Office of the City Clerk.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report. That report could form the basis of non-renewal or suspension of this license.
- 4. On September 23, 2014, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 1, 2014 at 2:00 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel.



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Notice was sent to Rajdeep S. Grewal at 6508 South 27<sup>th</sup> Street, No. 125, Oak Creek, Wisconsin 53154, along with a copy of the police report on November 22, 2013 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of 6508 South 27<sup>th</sup> Street, No. 125, Oak Creek, Wisconsin 53154 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.
  - B. On July 15, 2014 the applicant was charged in Fond du Lac County with operating while intoxicated (third offense) and operating with PAC (third offense) both of these charges are pending.
  - C. On July 26, 2014 the applicant's driver's license was suspended for six months regarding the operating while intoxicated listed in item "B" above. A check of the License Division records indicates that the applicant has yet to return his PPV license to the City Clerk as required by City Ordinance § 100-59-1-b.

## CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Rajdeep S. Grewal, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license based upon nonappearance and the police report.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by Rajdeep S. Grewal based upon nonappearance and the police report.

# RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Rajdeep S. Grewal be denied based upon nonappearance and the police report.





Re: Report of the Renewal Application of Sukhdeep Singh and Amarjit Kaur for a taxicab permit renewal application partnership for "Yellow Cab."

## FINDINGS OF FACT

- 1. Sukhdeep Singh and Amarjit Kaur (hereinafter the "Licensee") are the holder of a taxicab permit in the City and County of Milwaukee, Wisconsin. Said license will expire at midnight, October 31, 2014.
- 2. An application to renew said license was filed with the Office of the City Clerk.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a citizen complaint submitted to the License Division for consideration at the Public Works meeting on October 1, 2014.
- 4. On September 23, 2014, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a citizen complaint that could form the basis for suspension or non-renewal of the license of the licensee. The matter was scheduled for a hearing on the citizen complaint on October 1, 2014 at 2:15 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Erich Hochman, 2636B North Buffum appeared in opposition to the license and stated the applicant picked him and his wife from the hospital, as his wife has a foot injury. He stated the applicant first nearly drove



away without him and then his wife asked for the window to be closed several times before it was closed. As his wife was exiting the vehicle, the applicant began closing the automatic door and it hit her foot. He stated the applicant said "I pray to God that she breaks her other leg."

The applicant stated that as the door was closing the woman called him names and told him to go back to his own country.

### CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensees, Sukhdeep Singh and Amarjit Kaur, have not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of the taxicab permit license without a ten (10) day suspension based upon a citizen complaint.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the taxicab permit license held by Sukhdeep Singh and Amarjit Kaur with a ten (10) day suspension based upon a citizen complaint.

# RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the taxicab permit license of Sukhdeep Singh and Amarjit Kaur be renewed with a ten (10) day suspension based upon the citizen complaint.

Said suspension is to be in effect between 12:01 a.m. on November 1, 2014 through 11:59 p.m. on November 10, 2014.
