Part 1. There is added to the Milwaukee Code of Ordinances

Section 295-907(2)(a).0065. (1) In accordance with the provisions of Section 295-907(2) af the Cade relating to the procedures and establishment of planned development districts, the Common Council approves the subject General Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the City Clerk and made a part as though fully set forth herein.

(2) The zoning map is amended to change the zoning for the property located at 2760 Narth 1st Street, Tax

(3) The requirements set forth in said general plan attached to this Common Council File as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described, provided further, that the effect of the appraval of such general plan is that such plan shall limit and control construction. location, use and construction, location, use and operation of all land and structures included within the general plan to all conditions and limitations set forth in such general plan.

Part 2. Any persons, firm, company or carporation owning, controlling or or carporation owning, controlling or managing any building or premises wherein or whereon there shall be placed or there exists anything in violation of the terms of this ordinance; or who shall build contrary to the plans or specifications submitted to and approved by the Cammissioner of the Department of City Development, or any person Cammissioner of the Department of City Development, or any person, firm, company, or corporation who shall omit, neglect or refuse to do any act required in this ordinance shall be subject to the penalties provided in Section 200-19 of the Code.
