Facts of Accident/Loss


On the morning of February 21, 2009 at approximately 9:00 a.m. (Potawatomi Casino made an incident report with the specific time), Odis Lovett was walking a crosswalk on the street of W. Potawatomi Circle from the parking garage to the Potawatomi Casino, Milwaukee Wisconsin, when he slipped on ice and fell causing his leg to break. This crosswalk is located by Potawatomi Casino and is heavily used by casino patrons who go from the parking garage to the casino. Winter precipitation dripping off the heated skywalk located directly above the crosswalk created an "artificial" condition of ice on the crosswalk. This "artificial" condition of ice combined

with the natural condition of snow negligently created the condition that caused Odis Lovett's injury. Potawatomi Casino made an incident report regarding Odis Lovett's fall caused by the ice on the crosswalk. This claim is filed so that Odis Lovett does not waive his rights.

Odis Lovett demands the following itemized relief sought:

Past, current, and future medical bills	\$250,000.00
Pain and suffering	\$500,000.00
