My formal complaint against Yellow Cab driver #442 that took place 10/6/2016:

Cab #442 picked me up from work around 4:27 pm. I have had this driver before but didn't recognize him until I got in the cab. He picked me up previously about a month ago and demanded that I let him scan my card on his personal cell phone. I refused, citing that the company doesn't allow that. He then demanded cash. I told him I just had my card. I asked why I couldn't use the Verifone system and he lied and said it was out of order. He kept demanding cash at that point and became angry that I did not accommodate his wants. He began shouting in the cab and people at the grocery store started to stare. He was loud and belligerent. Demanding to come inside the store with me so I could get cash.

This behavior continued until I called the company while still sitting in his cab. He told me to get out and pay him 5 bucks extra in cash the next time he picked me up.

10/6/2016: Today he asked if I had cash when I got in the cab. I told him I just had my card. He said "this is a problem". When we arrived to my destination he pulled out his phone and just like previously demanded that I let him scan my card on his phone. I refused and he again asked for cash. I told him I don't normally carry cash and I was not required to as the cab is equipped to take cards. He became angry screaming that he "likes money!" He was loud and acting very erratically. I begged him to let me scan my card on the Verifone because he was harassing me and essentially keeping me hostage in his cab. He would not allow me to do that. He

again screamed that he "liked money". I said let me scan my card and let me out of this cab. I told him I was going to call his company. He finally relented. The charge went through fine.

He printed the receipt and said "look, look, I don't get this money, I like money, GIVE ME MY MONEY!" I exited the cab and he was screaming at me "give me my money". People were staring at me as though I hadn't paid my fare. I ran inside Walgreens hoping that he did not follow me in.

I was terrified because he was screaming at me and turning around trying to get in my face from the front seat. It was humiliating and harassment. I was just a woman who wanted to get home after a day of work. I did not deserve that treatment simply because he wanted payment HIS way. He is a danger to the city and I'm almost positive he has displayed this anger before with others. His license needs to be revoked.


