PLEASE TAKE NOTICE that Larry D. Witter, by his attorney, states that the following circumstances give rise to a claim:

1. That on April 19, 2001, at approximately 1:49am he was driving his vehicle in a safe manner West bound on W. Locust St. in the City of Milwaukee, when a police vehicle without its siren or emergency lights on was driving in a reckless and careless manner at an exceedingly high rate of speed Southbound on N. 36th St. when it went through a stop sign controlling Southbound traffic on North 36th St and West Locust Streets causing it to collide with the claimants vehicle.
2. That as a direct result of the negligence of Craig D. Sarnow, then and there a police officer for the City of Milwaukee, the claimant sustained personal injury and property damage.
