

**NOTICE IS HEREBY GIVEN** to the **CITY OF MILWAUKEE**, its agents, servants, employees and contractors, that on or about the 27th day of July, 2001, **MS. SULTANA BRILLOWSKI** sustained injuries to her leg and ankle when, while stepping out of a motor vehicle and over a curb on the property in front of 2000 West Forest Home Avenue, she stepped into a hole concealed by grass. The owner of said property maintains that the area of the fall is City of Milwaukee right of way and the said curb was installed by or for the City of Milwaukee. The accident and resulting injuries were due to holes left in the areas adjacent to the curb and concealed by overgrown grass, causing a dangerous, concealed condition to pedestrians.

The injuries sustained by **MS. BRILLOWSKI**, the extent of which are yet to be determined, were caused in whole or in part by the carelessness and negligence of the **CITY OF MILWAUKEE**, its agents, servants, employees and contractors, and the owner of said property.

**NOW COMES THE CLAIMANT**, Sultana Brillowski, 301 Lincoln Avenue, Mukwonago, Wisconsin 53149, by her attorney Richard H. Hart; and

**HEREBY GIVE NOTICE OF CLAIM** to the City of Milwaukee. The basis for said claim is that on or about the 27th day of July, 2001, the Claimant, while stepping out of a motor vehicle at the street curb in front of 2000 West Forest Home Avenue in the City and County of Milwaukee, State of Wisconsin, stepped into a hole that was immediately adjacent to the curb and concealed by grass. As such, this created a concealed and dangerous condition.

Further, upon information and belief and pursuant to the owner of the property located at 2000 West Forest Home Avenue, said holes were left in their condition by the City of Milwaukee, its agents, servants and employees, during construction of the street and curbs in that location. The City of Milwaukee, its agents, servants, employees, contractors and subcontractors knew or should have known of this condition and that said condition was unreasonably dangerous. The City of Milwaukee, its agents, servants, employees, contractors and subcontractors were negligent, which negligence was the cause of the damages sustained by the Claimant.


As a result of the aforescribed negligent conduct of the City of Milwaukee, its agents, servants, employees, contractors and subcontractors, the Claimant sustained injuries and damages, including, but not limited to, bruises, abrasions and a disability to her leg and ankle, injury to her nervous system, she was required to seek medical attention, related services and expense, and sustained losses, including personal injury, and pain and

suffering in the amount of Twenty-Five Thousand Dollars (\$25,000.00). The Claimant sustained medical bills, including, but not limited to, the following: Associates Orthopaedic Surgery, \$395.00; Emergency Medicine Specialists, \$161.00; National DME, \$28.00; and St. Francis Hospital, \$591.00; for total specials of One Thousand One Hundred Forty-Five Dollars (\$1,145.00).



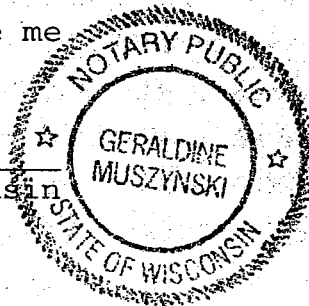
