## Dear Alderman Herron:

This is in response to a request we received from Ms. Flora Colson to install the above-captioned traffic control restriction.

Our traffic engineering staff has investigated this request and found that the accident data received from the Milwaukee Police Department revealed an increase in accidents at this intersection that would warrant the above-captioned control. Our inspection revealed that a sight obstruction on the northwest corner reduces the available safe approach speed. We, therefore, in the interest of public safety, recommend the installation of Stop signs on North 71st Street and West Bobolink Avenue.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.
