

### Statement of Abatement

In response to the incident which occurred on June 2<sup>nd</sup>, 2023

Gas N Go Enterprises, Inc took the following actions:

- On the night of the incident, the trained employee who was working at that time cooperated with police by promptly showing the CCTV recording of the incident. Our cameras were able to see far enough to aide the police by showing the suspects passing by on the street since the shots fired occurred off the premises of the business.

In response to the incident which occurred on August 25<sup>th</sup>, 2023

Gas N Go Enterprises, Inc took the following actions:

- The employee who was working at that time cooperated with police by promptly showing the CCTV recording of the incident.
- We worked with the police to get the suspect arrested.

In response to the incident which occurred on November 11<sup>th</sup>, 2023

Gas N Go Enterprises, Inc took the following actions:

- The store clerk who sold the tobacco product was immediately terminated from employment.
- We make sure to have all our employees trained on all laws regarding tobacco sales. We especially emphasize the importance of verifying the age of the customer being greater than or equal to 21 before conducting a tobacco sale by checking photo identification.
- All our employees go through the WISCONSIN WINS tobacco training program. Certificates of passing examinations for all my employees as well as myself are attached. Please reference.
- Since this incident, there have been no further underage tobacco sale violations.

These actions demonstrate that Gas N Go Enterprises, Inc does and will always prioritize community safety.


