The hearing before the Licenses Committee will take place on 5/16/2023 at 3:00 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

5. On 11/18/2021 at 8:05pm officers were dispatched to an Armed Robbery at McDonald's, 2700 W. Capitol Dr. The officers spoke with the employee, who stated a subject walked up to the drive-thru window, displayed a gun and demanded money. The employee put the register drawer on the counter. The subject took the drawer and fled the scene on foot. The staff called in the manger to assist officers in obtaining video. The investigation revealed the drive-thru window did not lock, and the manager stated he would address that issued the next business day.

6. On 07/12/22 at 4:01pm, Milwaukee Police were dispatched to 2700 W. Capitol Drive for a battery complaint. Investigation revealed that the caller was out of town and did not want to make a report. There was no contact with the business.
7. On 07/22/22 at 1:52pm, Milwaukee Police were dispatched to 2700 W. Capitol Drive for a theft complaint. Investigation revealed that an employee stole money from the business and the company only wanted the money returned. All employees at the location was cooperative.

On Tuesday, July 12th, 2022, at approximately 4:01 PM, P.O. TIERNEY and I were dispatched to a battery complaint at Mcdonald's at 2700 W Capitol Dr, which is located in the city and county of Milwaukee.

In the call for service, it stated, "CLLR STS SHE WAS IN THE MCDONALDS DRIVE THRU WHEN A HOMELESS SUBJ ASKED HER FOR MONEY. CLLR STS SHE GAVE HIM SOME CHANGE HE THEN THREW THE CHANGER AT HER CAR THEN SNATCHED A \$80 GIFT CARD FROM HER HAND, SUBJ LEFT ON FOOT WAS LAST SEEN ACROSS THE STREET FROM THE CLARKE GAS STATION. WORKERS STATED SUBJ KNOWN TO FREQUENT THE AREA. CLLR STS SHE WAS TOLD THE WORKERS OF MCDONALDS ABOUT THE INCIDENT AND THE WORKERS BECAME UPPSET BECAUSE SHE CALLED THE SUBJ AFRICAN AMERICAN AND THEY SLAMMED HER HAND IN THE DRIVE THRU WINDOW. MFD REFUSED. SUBJS STILL ON SCENE. CLLR WAITING IN FRONT OF THE STORE IN VEH1".

Upon arriving on scene, I called the caller who stated that she was out of town from where the incident happened and stated that she did not want to make a report regarding the workers. The caller stated that she would be able to make a report at a later date due to her not being in Milwaukee.

This call was given a C10 to the caller and P.O. TIERNEY and I did not make any contact with the workers inside.

On the listed date, at approximately 12:18 AM, at the McDonalds (2700 W Capitol Dr.), Squad 5434 (PO Justin SILKEY and PO Kimberly KENEKEO) responded to a ShotSpotter complaint. Upon arrival, officers learned that just prior to the time of the ShotSpotter, a gray '06 Pontiac G6 arrived (n/b) in the parking lot of the listed address (McDonald's parking lot). The vehicle parked prior to pulling into a parking space and before going into the drive-through. At that time, the driver (victim of this incident) of the vehicle then exited the vehicle and walked to the front of it.
