LEASE AMENDMENT

This Lease Amendment ("Amendment") is made by and between the City of Milwaukee, a municipal corporation ("Lessor"), and St. Joseph Regional Medical Center, Inc., a Wisconsin nonstock, nonprofit corporation, formerly known as St. Joseph's Hospital of Franciscan Sisters, Milwaukee ("Lessee"), as of the ____ day of March, 2003.

RECITALS

- A. Lessor and Lessee are the parties in interest in and to a lease dated March 20, 1989 ("Lease"), for the demising of certain space located over North 51st Street in the City of Milwaukee, Wisconsin, as more particularly described in the Lease.
- B. Lessor and Lessee desire to amend the Lease on the terms and conditions provided in this Amendment.

AMENDMENT

Lessor and Lessee agree as follows:

- 1. Section 11 of the Lease is deleted and replaced in its entirety with the following:
 - 11. SIGNS. Lessee shall not place or maintain any signs or cause them to be placed in or on the structure so as to be readable from the street, without permission of Lessor's Commissioner of Public Works.
- 2. Except as modified herein, the Lease is ratified and confirmed in all respects.
