Attorney Joshua Whiteside of Schueler, Dallavo & Casieri Attorneys at Law is representing Greater Northern Insurance Company as subrogee of Associate Bancorp regarding damages allegedly sustained from a water main break that caused water backup in the basement that occurred on February 12, 2022. Attorney Whiteside has submitted a demand for \$130,950.30, for damages that include emergency basement cleanup and restoration at the subject property located at 5350 W. Fond Du Lac Avenue.

We have completed an investigation into this matter with both Milwaukee Water Works (MWW) and Infrastructure Sewers Maintenance. MWW reported that, on February 12, 2022, they responded to a leak in the street at the intersection of W. Fond du Lac Avenue and W. Maxwell Place. An 8" water main was taken out of service, a contractor was hired to complete the repairs, and the water main was placed back in service.

On February 14, 2022, Sewer Maintenance reported to the subject location, and video examined the City's 8" sanitary sewer main that services the subject property. The sewer was reported flowing properly and in good condition. There were no other backwater calls reported in the area.
