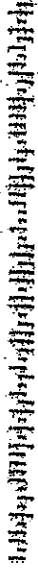


We have received your claim in the amount of \$1,502.95 in relation to damage to your vehicle that allegedly occurred between February 23, 2023 and February 24, 2023, while parked in front of your residence. You claim the damage was the result of City of Milwaukee snow plow operations.


Our investigation reveals that the City of Milwaukee was engaged in snow plow activity during the time frame referenced in your claim, however none of the City drivers reported or noted any damages to your vehicle. In addition, it should be noted that several other non-City plowing vehicles were also in the area.

There is no evidence that the City was negligent in this matter. As such, the City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed
