Whereas, Several states and municipalities have enacted legislation requiring equity impact statements; and

Whereas, Equity impact statements expressly assess the positive or negative impacts of legislation, contracts or grants on minorities; and

Whereas, The city of Milwaukee is the largest and most racially-diverse city in the state of Wisconsin, with 35% white residents, 39% African-American, 19% Hispanic or Latino, 4% Asian, and 4% of two or more races, according to the U.S. Census Bureau Quick Facts estimate as of July 1, 2019; and

Whereas, Thirty-six percent of African- Americans and 31% of Hispanics live in poverty in the city of Milwaukee, compared to 15% of whites, according to the 2017 American Community Survey (ACS); and

Whereas, Fourteen percent, or 80,843, of Milwaukee's population has some type of disability according to the 2017 ACS; and

Whereas, The 2010 U.S. Census found that 13% of African-American men and 8% of Native American men of working age are incarcerated in state prisons or local jails in Wisconsin, compared to national averages of 7% and 3%, respectively; and

Whereas, Forbes Magazine's March 2011 edition listed the Milwaukee Metropolitan Area as 52nd among 52 cities in the United States for minority entrepreneurship; and

Whereas, The development of an equity impact statement process ensures that at-risk minority populations are carefully considered when the City expends taxpayer

2 resources; now, therefore

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 50-6 of the code is created to read:

- 50-6. Equity Impact Statement. 1. DEFINITIONS. In this section:
- a. "City agency" means a department, division, bureau, office, board or commission, or other entity established by the city.
- b. "Minority group" means any group comprised principally of:
- b-1. African-Americans.
- b-2. Hispanics.
- b-3. Asians and Pacific Islanders.
- b-4. Native Americans and Alaskan Natives.
- b-5. Persons with disabilities.
- b-6. Persons identifying or describing their sexual orientations or gender identities as lesbian, gay, bisexual, transgender, queer or questioning.
- c. "Equity impact statement" means an evaluation and description of any impact that the types of common council legislation specified herein may have on a minority group.
- 2. REQUIREMENT. a. An equity impact statement shall be submitted by each city agency for every proposed common council resolution or ordinance involving:
- a-1. A development agreement.
- a-2. A grant.
- a-3. A city contract a primary purpose of which is direct service delivery to residents.
- a-4. Creation of, or change in, a penalty provision in the code.
- b. The chair of any common council standing committee may also request that an equity impact statement be submitted for any other file assigned to the committee.
- c. Equity impact statements shall be submitted to the city clerk on a form prepared by the city clerk according to a schedule determined by the city clerk.
- 3. CONTENT. The equity impact statement submitted by each city agency shall include:
- a. A description of the proposed ordinance or resolution.
- b. A description of any anticipated equity impacts of the resolution or ordinance.
- c. An identification of any minority groups who may be negatively or positively impacted by the resolution or ordinance.
- d. A description of any engagement efforts with minority communities potentially impacted by the resolution or ordinance.
- e. A description of how any equity impacts will be documented or evaluated.
- f. A description of strategies that will be used to mitigate any equity impacts.
- 4. EXCEPTIONS. No minority impact statement shall be required for the following:
- a. An ordinance amending the salary or positions ordinance.
- b. A resolution approving attendance at conventions, seminars and other meetings.
- c. A resolution canceling property taxes.
- d. A resolution granting, amending or repealing a special privilege.

- e. A resolution relating to claims against the city.
- f. A resolution appropriating funds from the common council contingent fund.
- g. A resolution authorizing the return of real estate.
- h. A resolution authorizing city sale of neighborhood property (one-4 unit residential) without city funding attached.
- i. A resolution granting an easement.
- j. A resolution allowing property acquisition and transfer under s. 75.106, Wis. Stats.
- k. A resolution or ordinance related to changes to the zoning map or zoning text, and vacations or dedications of public right of way, unless an impact statement is requested by the council member representing the district in which the property impacted by the proposed action is located or the chair of the committee that file is assigned to at the time of introduction.
- L. A resolution relating to certified survey maps and subdivision plats.
- m. A resolution or ordinance approving any action for which compliance with local, state or federal laws, including applicable purchasing or bidding requirements, precludes consideration of impact on minority communities.

Part 2. This ordinance takes effect on September 30, 2020.

Substitute resolution urging the federal government to disclose the identities of the recipients of the taxpayer-funded coronavirus business loans.

Whereas, U.S. Treasury Secretary Steven Mnuchin has refused to disclose recipients of the taxpayer-funded \$600-billion-plus coronavirus business loans; and

Whereas, Many lawmakers and members of the public view the claim that the information is confidential as an attempt to dodge accountability for how the money is spent; and

Whereas, Businesses struggled to obtain loans in the early weeks of the program; and

Whereas, Several hundred publicly-traded companies received loans despite their likely ability to get the money from private financial sources; and

Whereas, Due to public scrutiny, some big corporations have stated they would return their loans; and

Whereas, The loans may be forgiven if businesses use the only to keep employees on payroll or rehire workers who have been laid off; and

Whereas, It is imperative for taxpayers to know whether the money is going where Congress intended to small businesses; and

Whereas, The administration's resistance to transparency raises suspicions regarding how the funds are being distributed and who are benefitting from them; and

Whereas, Nearly a dozen news organizations sued the U.S. Small Business Administration in federal court for not having released the loan data despite several requests under the Freedom of Information Act; and

Whereas, Taxpayers have a right to information regarding the way their money is spent; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the federal government is urged to disclose the identities of the recipients of the taxpayer-funded coronavirus business loan; and, be it

PASSAGE OF THE FOLLOWING:

7. <u>200176</u> A substitute ordinance relating to the regulation of extraordinary events.

Whereas, On July 7, 2020, the Common Council passed File Number 200310, an ordinance relating to the extraordinary event of the Democratic National Convention; and

Whereas, The Common Council finds that, in order to protect the public health, safety and general welfare during this extraordinary event, it is necessary to prohibit the possession of certain items, the obstruction of public right-of-way, the abandonment of certain items, and camping within the security footprint during the convention period; now, therefore

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

- Part 1. Section 1 of File Number 200310 is amended by adding the following:
- u. "Public access areas" means any spaces in the security footprint that are open to access by the general public, including streets, sidewalks and public grounds.
- Part 2. File Number 200310 is amended by adding the following sections:
- 13. Prohibition of Possession of Certain Items in the Security Footprint during the Convention Period. a. Within all public access areas, the following items are prohibited during the convention period:
- a-1. Lumber larger than 2 inches in width and 0.25 inches thick, including supports

for signs.

- a-2. Metal, plastic, or other hard material larger than 0.75 inches thick and 0.0125 inches in wall thickness, including pipe and tubing.
- a-3. Any air rifle, air pistol, paintball gun, blasting cap, switchblade or automatic knife, knife having a blade 2.5 inches in length or longer, cestus or other combat glove, billy club, blackjack, sword, saber, hatchet, axe, slingshot, BB gun, pellet gun, wrist shot or wrist rocket, metal knuckles, nunchucks, iron buckle, axe handle, shovel, or other instrument potentially used to cause damage to persons or property.
- a-4. Any dangerous ordnance, weapon, or firearm that is prohibited by the laws of the state of Wisconsin under ss. 941.26, 941.28 and 941.298, Wis. Stats.
- a-5. Any explosive, explosive device or incendiary device.
- a-6. Any firework or rocket.
- a-7. Any drones or other unmanned aircraft system or device.
- a-8. Any containers of bodily fluid.
- a-9. Any aerosol can.
- a-10. Mace, pepper spray, OC spray or other chemical irritant.
- a-11. Any umbrella with a metal tip.
- a-12. Any projectile launcher, such as a slingshot, wrist rockets, water gun or water cannon.
- a-13. Any rope, chain, cable, strapping, wire, string, line, tape or similar material, in a length greater than 6 inches.
- a-14. Any glass bottle, ornament, light bulb, ceramic vessel or other frangible or brittle container, regardless of whether the container holds any substance.
- a-15. Any lock, including, without limitation, any padlock, bicycle locking device, chain lock or similar device, but not including:
- a-15-a. Any integral component of a conveyance or structure.
- a-15-b. Any lock when utilized by the owner of private real property to secure

temporary or permanent fencing.

- a-15-c. Any lock attached to a bicycle.
- a-16. Any gas mask or similar device designed to filter all air breathed by the wearer in an attempt to protect the respiratory tract or face against irritating or noxious gasses or other materials. This prohibition shall not apply to law enforcement and emergency personnel acting in their official capacities, any person wearing a medical oxygen mask that fits over the person's nose and mouth to provide oxygen from an oxygen tank to that person, or any cloth mask used as personal protection equipment to avoid transmission of viral infection.
- a-17. Any tent or other shelter, sleeping bag, sleeping pad, mattress, cot, hammock, bivy sack or stove.
- a-18. Any cooler or ice chest.
- a-19. Any backpack or bag exceeding the dimensions of 18 inches by 13 inches by 7 inches.
- a-20. Any laser.
- a-21. Any non-plastic container, bottle, can or thermos.
- a-22. Any ladder.
- a-23. Any grappling hook, sledgehammer, hammer, crowbar or prybars.
- a-24. Canned goods.
- a-25. Tennis balls.
- a-26. Any other item determined by the chief to be a clear and present danger to the safety of others.
- b. The prohibitions of par. a shall not be applicable to:
- b-1. Any person possessing an item listed in par. a when both of the following are true:
- b-1-a. The person or the person's employer maintains a place of employment within the security footprint.

- b-1-b. The possession of the item is in the normal course of the person's licensed business or employment and to be used within that business or place of employment.
- b-2. Any person possessing an item listed in par. a when both of the following are true:
- b-2-a. The person resides within the security footprint.
- b-2-b. The item is kept and used within the person's residence.
- b-3. Any law enforcement personnel or other local, state or federal government employee possessing a prohibited item in the course of that person's authorized duties.
- b-4. Any licensed medical professional in the performance of that professional's medical duties.
- 14. Possession of Obstruction Devices; Abandoning Objects and Camping in the Security Footprint Prohibited. a. It is unlawful for any person within the security footprint, with the intent to obstruct the public's ability to freely move about on rights-of-way, sidewalks or other areas to which the public has access, to possess or place any tool, object, instrument, or any combination thereof, that is adapted, designed, or intended to be used for obstructing the public's ability to freely move about on rights-of-way, sidewalks or other areas to which the public has access. This shall include, but is not limited to, the maneuver commonly referred to as the "Sleeping Dragon," tripods, bipods, poles, any sections of pipe or containers filled with or wrapped in weighted material, such as concrete, or containing handcuffs, chains, carabiners, padlocks, road stars, or other locking devices.
- b. It is unlawful for any person, other than law enforcement, or an individual properly authorized and credentialed by law enforcement, to inhibit, for any reason, the movement of other persons on streets, rights-of-way or sidewalks.
- c. It is unlawful for any person to place any instrument, tripod, bipod, or other pole or object with the intent to obstruct the public's ability to freely move about on rights-of-way, sidewalks, entrances and exits to private property, or any other areas to which the public has access.
- d. It is unlawful for any person to attach themselves to another person, building, vehicle, or fixture with the intent to obstruct the public's ability to freely move about on rights-of-way, sidewalks, entrances and exits to private property, or any other areas to which the public has access.
- e. It is unlawful for any person to abandon or place any container or object on the

rights-of-way, sidewalks, entrances and exits to private property, or any other areas to which the public has access, and remove themselves from immediate proximity of the container or object. Any container or object so abandoned or placed shall be subject to immediate search, removal or disposal.

- f. It is unlawful to camp in the security footprint during the convention period.
- g. Any government employees performing the employee's official duties shall be exempt from this section.

Resolution relating to the application for, and acceptance, funding and expenditure of, a Wisconsin Department of Transportation 2020 Multimodal Local Supplement Project grant for Port Milwaukee's South Shore Cruise Dock.

Whereas, The City of Milwaukee appears to be eligible for 2020 Multimodal Local Supplement Project funds from the Wisconsin Department of Transportation (WisDOT); and

Whereas, It is the mission of Port Milwaukee to enhance the overall economic environment of the region by stimulating trade, business, and employment through its commercial, recreational, and cruise ship operations; and

Whereas, Milwaukee realized a sharp increase in cruise passenger traffic in 2019 and anticipates further cruise-related growth in the future; and

Whereas, Milwaukee has positioned itself as an international turnaround port for the embarkation and disembarkation of passengers on Great Lakes cruise itineraries; and

Whereas, Port Milwaukee owns and maintains the South Shore Cruise Dock; and

Whereas, In order to accommodate the expanded safe, secure and efficient use of the South Shore Cruise Dock, it is necessary to rehabilitate the parcel and procure additional equipment as required by the U.S. Coast Guard; and

Whereas, The proposed improvements at the South Shore Cruise Dock are estimated to cost \$484,367, of which \$201,531 (41.6%) will be provided by WisDOT (Grantor share) and as much as \$282,836 (58.4%) will be provided by the City budget (Capital Fund PT180000200, City Share); now, therefore, be it

Resolve, By the Common Council of the City of Milwaukee, that Port Milwaukee is authorized to apply for and accept the WisDOT 2020 Multimodal Local Supplement Project grant in accordance with the terms of the attached Agreement # 1009-49-43/1009-51-43 by and between the Port and WisDOT without further Common Council approval unless the terms of the grant change in a manner described in s. 304-81 of the Milwaukee Code of Ordinances; and, be it

Whereas, The recent death of George Floyd in Minneapolis, Minnesota has brought public scrutiny to police tactics related to de-escalation and restraint; and

Whereas, In order to reduce systemic racism in the City of Milwaukee, it is crucial to take a coordinated city-wide approach to implement data-driven best practices to reduce violence at the hands of law enforcement officers; and

Whereas, Campaign Zero, a nationwide police reform platform, completed a 2016 study that found that police departments with more restrictive use of force policies kill fewer people per 100,000 arrests and per overall population; and

Whereas, Campaign Zero's national "Eight Can't Wait" campaign seeks for Police

Departments across the country to introduce eight policing policies which, in jurisdictions where they have been implemented, have contributed to reducing deaths at the hands of law enforcement by 72 percent and decreasing the likelihood of assaults on police officers and police deaths in the line of duty; and

Whereas, Only three Milwaukee Police Department Standard Operating Procedures (SOP) align with the eight policy recommendations promoted by the "Eight Can't Wait" campaign, including requirements for officers to issue verbal warnings before using force, to intervene when fellow officers use excessive force, and utilization of a use of force continuum; and

Whereas, While the Milwaukee Police Department does not train its members to use chokeholds, strangleholds, carotid restraints, or any maneuver which restricts movement of the head or neck, there is no SOP that explicitly bans these techniques; and

Whereas, The Milwaukee Police Department's "SOP 460 - Use of Force" does not provide detail on de-escalation techniques that officers should use in tense situations, such as methods of using verbal communication and maintaining physical distance from a subject; and

Whereas, SOP 460 states that "force that is intended or likely to cause great bodily harm or death, may only be used as a last resort," but does not explicitly state how use of force must be graduated and which lesser uses of force should be attempted prior to discharging a firearm; and

Whereas, By order dated March 24, 2020 in Docket No. 5-UI-120, the Public Service Commission of Wisconsin ordered that no public utility may disconnect service to any customer for nonpayment; and

Whereas, As set forth in a June 26, 2020 order, on June 11, 2020, the Public Service Commission of Wisconsin voted to authorize utilities to resume disconnections effective July 25, 2020; and

Whereas, Based on the increasing spread of COVID-19 in Wisconsin since the June 11 vote, by order dated July 24, 2020, the Public Service Commission of Wisconsin extended the moratorium on residential customer disconnections for nonpayment until September 1, 2020; and

Whereas, The Public Service Commission of Wisconsin will meet on August 20, 2020 to discuss whether further modifications or extensions should be provided beyond September 1, 2020; and

Whereas, The Public Service Commission of Wisconsin is requiring that any

comments from utilities and stakeholders be filed by no later than August 10 to be considered by the August 20 meeting; and

Whereas, We Energies reported that approximately 32,000 customers, a significant number of whom are likely city of Milwaukee residents, were eligible for disconnection as of the time of its July 2020 report to the Public Service Commission of Wisconsin; and

Whereas, Based on recent trends, it is likely that Wisconsin will continue to face a surge of COVID-19 cases throughout August; and

Whereas, As the majority of Commissioners determined in the July 24 order, energy utility disconnections for nonpayment put customers at risk by denying them access to basic services in their homes that are needed to meet hygiene standards and social distancing guidelines necessary to protect the customers and public health during this COVID-19 public health emergency; and

Whereas, When residential disconnections are scheduled to resume on September 1, thousands of City of Milwaukee households will depend on secure housing and basic energy utility services as their children begin the school year at home through virtual learning; now, therefore, be it

Whereas, According to the White House website, President Trump and the Department of Justice plan to deploy federal law enforcement officers to Milwaukee, Detroit and Cleveland in the near future; and

Whereas, U.S. Representatives Alexandria Ocasio-Cortez, D-N.Y., and Eleanor Homes Norton, D-D.C., have introduced a bill entitled the Law Enforcement Identification Transparency Act of 2020 to require federal law enforcement officers to wear visible identification markers while on duty; and
