

RE: Administrative Positions Ordinance change

In the Salary Ordinance, under Pay Range 856, a footnote pertaining to the titles "Paramedic Field Lieutenant" and "Fire Paramedic Field Lieutenant" reads as follows: "4/ Positions to be reclassified to Fire Lieutenant upon becoming vacant." This footnote was created in a job evaluation report approved by the Fire and Police Commission on April 24, 2003; passed by the Finance Committee on May 7, 2003 (File #021610) and by the Common Council on May 13, 2003 (File #021593 & #021594). Five vacant positions were initially reclassified to Fire Lieutenant with the understanding that as future vacancies occur, the necessary Positions Ordinance changes will be handled administratively.

The attached letters from the Fire and Police Commission and the Fire Department request that one vacant position of Fire Paramedic Field Lieutenant be reclassified to Fire Lieutenant. Since the procedure to reclassify vacant positions of Paramedic Field Lieutenant/Fire Paramedic Field Lieutenant to Fire Lieutenant was recommended by the Department of Employee Relations, approved by the Fire and Police Commission and authorized in the Salary Ordinance by Common Council action, we are requesting that the Positions Ordinance amendment necessary to implement the requested classification change for this recent vacancy (and future vacancies) be handled administratively.

In order to implement this change, the Positions Ordinance needs to be amended as follows:

Under "Fire Department, Firefighting Division Decision Unit", add one position of "Fire Lieutenant" and under "Paramedic Service" delete one position of "Paramedic Field Lieutenant (C) (I)/Fire Paramedic Field Lieutenant (C) (I)."

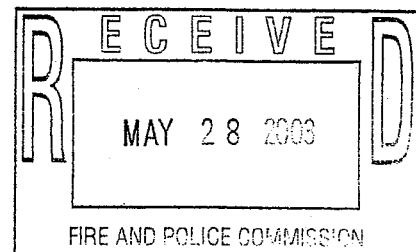

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 20 of ordinance File Number 020486 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Pay Range 856, add footnote designation "4/" following the titles "Paramedic Field Lieutenant" and "Fire Paramedic Field Lieutenant" and add the following footnote: "4/ Positions to be reclassified to Fire Lieutenant upon becoming vacant."

Part 2. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 3. The provisions of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Substitute ordinance to further amend the 2003 offices and positions in the City Service under control of the Common Council.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 1 of ordinance File Number 020487 relative to offices and positions in the City Service is hereby amended as follows:

Under "Fire Department, Firefighting Division Decision Unit", add five positions of "Fire Lieutenant"; under "Paramedic Service", delete five positions of "Paramedic Field Lieutenant(C)(I)/Fire Paramedic Field Lieutenant(C)(I)."

Part 2. Section 1 of ordinance File Number 020487 relative to offices and positions in the City Service is hereby amended as follows:

Under "Health Department, Home Environmental Health Division, Childhood Lead Poisoning Prevention Program(W)", delete one position of "Office Assistant II(W)" and add one position of "Office Assistant III(W)"; under "Childhood Lead Detection Program(Z)", delete one position of "Office Assistant IV(Z)" and add one position of "Program Assistant I(Z)"; amend footnote "(F)" as follows: "To expire 12/31/03 unless the Sexually Transmitted Diseases Grant, available from the State of Wisconsin Division of Health and Family Services is extended."

Part 3. Section 1 of ordinance File Number 020487 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2002 - December 22, 2002):

Under "Police Department, Administration/Services Decision Unit, Technical Services Bureau, Communications Operations Division", delete two positions of "Police Alarm Operators" and add two positions of "Police Dispatchers."

Part 4. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 5. The provisions of Part 3 of this ordinance are deemed to have been in force and effect from and after Pay Period 1, 2002 (December 22, 2002).

The provisions of all other parts of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 6. This ordinance will take effect and be in force from and after its passage and publication.
