TWO OPTIONS FOR LEASING MALL REGISTRATION

OPTION 1: FULL CONVENTION REGISTRATION

To participate in ALL Spring Convention functions, you must register and pay the appropriate fee for each attendee.

ICSC members are eligible for a \$30 discount off the \$315 registration fee, if registration for the Spring Convention is received on or before November 16, 2002. This discounted offer does not apply to non-member employees of member companies. The non-member advance convention fee is \$630.

OPTION 2: LEASING MALL STAFF BADGE

All companies participating as exhibitors in the 2003 Leasing Mall are entitled to free Leasing Mall Staff badges as part of the space rental fee based on the following formula:

- One (1) free badge for every 100 square feet of space leased rounding to the nearest hundred [i.e., a company leasing 680 square feet would be allowed seven (7) free Leasing Mall Staff badges.] A minimum of four (4) free badges will be provided even if less than 400 square feet of space is leased.
- Allocation of Leasing Mall Staff badges will be based upon the amount of square feet your company occupied in the 2002 Leasing Mall. Where differences occur between square footage occupied and amount actually assigned, badge entitlement will be adjusted accordingly.
- These staff badges should be utilized by the Leasing Mall company employee(s) who is not

attending the Convention sessions or meal functions. This badge does not gain access to Convention sessions, receptions and meal functions. **Leasing Mall staff using staff badges will not have their names and hotel locations listed in the Advance Registrants Directory.**

- The Leasing Mall Registration Form is to be used for registering the leasing staffs of exhibiting companies. All Leasing Mall Staff badges will be prepared from the information contained on the registration form. Please take special care when completing this form to ensure accuracy. The individual from your company responsible for your Leasing Mall exhibit will handle all staff badges.

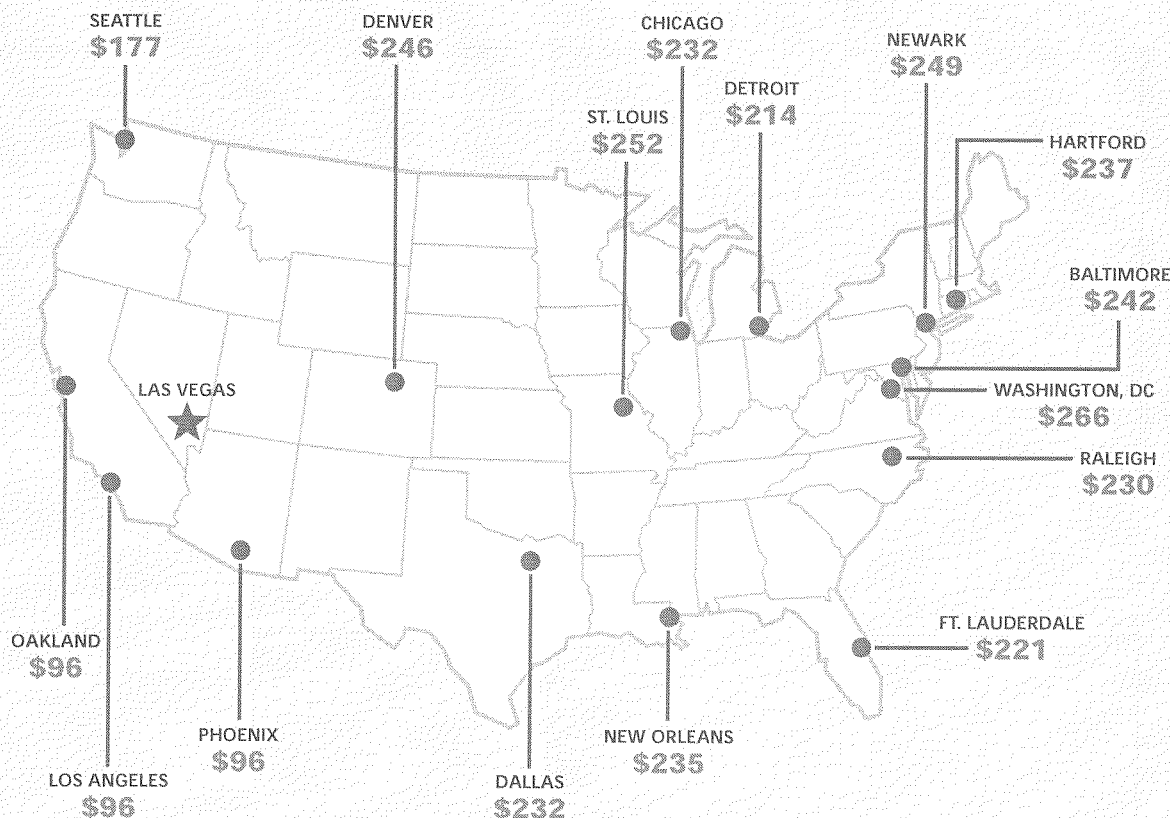

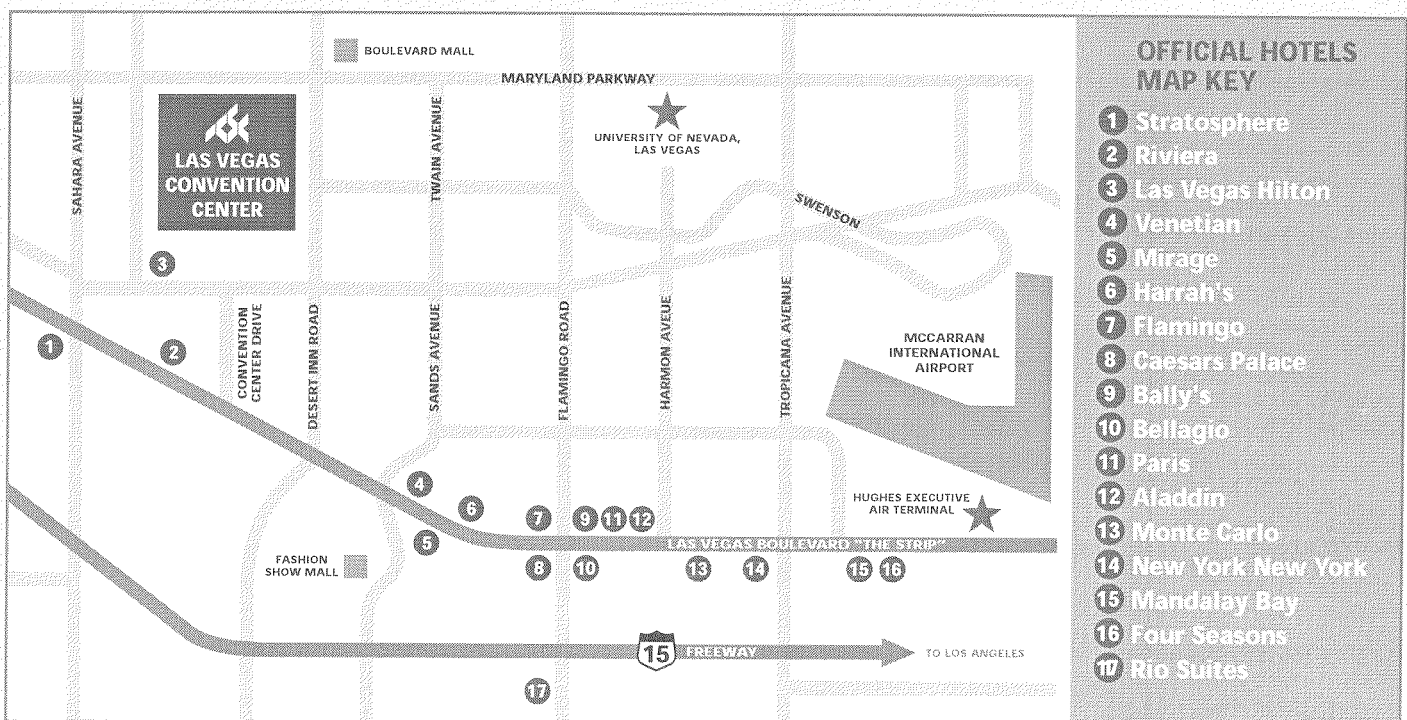
