If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/15/06, officers along with a 19 year old Police Aide entered the Encore Tavern 101 S. Dana Ct. The Police Aide was able to order and purchase two beers from the bartender. The bartender was cited for Sale of Alcoholic Beverages to Underage Person.
- 2. On 02/22/07 officers responded to an injury accident at the Encore, 101 S. Dana Ct. Officers' investigation revealed that a patron was ejected from the tavern for fighting. The fight continued outside where another patron armed himself with a baseball bat. The bat was taken away by a bouncer and the fight quieted down. The applicant learned from a bouncer, that the person with the baseball bat was a longtime friend of his named Reginald, and that Reginald was going to come after him with the bat. The applicant became enraged at this and went outside to confront the friend. Reginald was now in a vehicle and he accelerated that vehicle towards the applicant, striking him and knocking him several feet. Reginald backed up towards the applicant, but struck a bouncer instead, breaking his leg. The applicant stated to officers several times during the investigation that he knew better, not to leave his bar to escalate the fight.

Officers reviewed the tavern's exterior cameras, which showed that the applicant's actions escalated the fight outside. The applicant was cited for Disorderly Premises Prohibited.

## A check with Municipal court on 03/11/08 found citation from incident # 2 was never issued.

- 3. On 02/16/08 at 2:42 am, Milwaukee police were dispatched to 101 S Dana Court for a Call For Police. Investigation found several patrons inside the tavern were involved in a heated argument. Officers were able to view video provided by the owner, Nicholas Monreal, which showed a patron pushing another and the argument continued outside of the tavern where is escalated. Police were called and one of the patrons involved received a resisting/obstructing citation for failing to cooperate with police regarding the investigation.
- 4. On 06/18/08 at 12:02 am, Milwaukee police were dispatched to 101 S Dana Court for a Battery complaint. Police spoke to the owner Nicolas Monreal who stated the victim was seated inside the club when he saw his ex-girlfriend with another man. The victim began to provoke the ex-girlfriends boyfriend and a fight ensued. Security broke up the fight and removed the victim from the tavern. The victim waited for the couple to leave the tavern and confronted them both once they left. Another fight occurred and the victim was knocked unconscious. The victim was treated and later released for his injuries at a nearby hospital. The victim was uncooperative with police and did not want to press charges.
- 5. On 08/01/08 at 12:57 am, Milwaukee police were dispatched to 101 S Dana Court for a Fight complaint. Officers spoke to the caller/victim who stated she and friends were at the Encore drinking and having some fun when security came up to them and asked them to leave because they were receiving complaints that she and friends were soliciting patrons at the bar. The victim stated she didn't argue and that she finished her drink and just "slid" her glass towards the waitress when the waitress grabbed a towel and threw it at the victim, striking her face. The victim stated she got angry and lunged at the waitress when security grabbed the victim from behind and walked her out of the bar along with her friends. Officers spoke with security officer Richard Hayes as well as the bartender Ashley Gonzales who both stated they wanted no citations issued and just wanted the caller and friends out of the tavern. No injuries were reported.

6. On 03/13/10 at 7:52 pm, Milwaukee police were dispatched to 101 S Dana Court for a Sick and Injured. Officers were met by MFD who stated a subject from Montreals was incapacitated by alcohol and subsequently conveyed to a nearby hospital for treatment. Officers located the victim at the hospital and interviewed her. The victim stated she was drinking an unknown number shots of tequila at the bar and would not provide information to the officers as to who the bartender was that served her. The victim was an employee of the tavern. Medical personnel at Page 3 Monreal, Nicolas S

the hospital found her blood alcohol level to be at .28, which is three times over the legal limit. Further investigation found the identity of the bartender who served the victim but she was no longer on scene when officers returned. The licensee Nicolas Monreal was not on scene either and officers contacted him by phone and advised him of what occurred and that he would be receiving a citation.

- 7. On 09/22/12 at 1:00 am, Milwaukee police investigated a battery that occurred at the Monreal's Encore located at 101 S Dana Court. Investigation found an employee of the bar was battered by her husband outside of the business causing minor injuries. A report was filed.
- 8. On 04/13/2013 Milwaukee police responded to a Battery complaint at 101 South Dana Court (Monreal's Encore). Investigation revealed two patrons of the business became involved in an argument while sitting in a car after they left the business. This argument escalated and resulted in one of the involved parties receiving a citation for Battery.
- 9. On 08/22/2013 Milwaukee police conducted a licensed premise check at 101 South Dana Court (Monreal's Encore). During this check, it was discovered the bartender did not possess a valid class D operator's license. Both the bartender and the applicant were cited.

- 10. On 03/19/2014 the Wisconsin Department of Transportation revoked the applicant's driver's license for 6 months for Prohibited Alcohol Concentration.
- 11. On 02/18/2015 Milwaukee police responded to a theft complaint at 101 South Dana Court (Monreal's Encore). The victim, Veronique Brown, told officers that around 7:00pm a subject Brown knows as Michelle Harris stole her purse. Brown is employed at Monreal's Encore and knows Harris from a relationship she (Harris) had with the father of Brown's child. Harris left in a Grey Hyundai prior to officer's arrival. Milwaukee police incident report #150490126 filed.

12. On 03/09/2019 officers were dispatched to a battery at Encore, 101 S Dana Ct. The caller stated he was thrown out of the business and punched, but had no injury. Security stated they removed the subject for attempting to steal other patrons alcohol and money from tables.

- 13. On 03/16/20 at 11:02pm, Milwaukee Police conducted a license premise check at 101 S. Dana Court. The reason for the check was to make sure the business knew of the county and city mandated closures. The staff stated that they understood the rules.
- 14. On 06/17/20 at 11:05pm, Milwaukee Police were dispatched to 101 S. Dana Court for a battery complaint. Investigation revealed that two females (one a former employee) were in a verbal argument with the bartender who asked them to leave because they were causing a disturbance. Video surveillance shows security standing by two females who were trying to go around him, so security wraps his arms around one and moves her towards the door. While at the entrance, it appears that there is a struggle between both parties to get the door closed and security is able to close the door.
- 15. On 02/07/21 at 1:50am, Milwaukee Police were dispatched to 101 S. Dana Court for a shots fired/subject with a gun complaint. Investigation revealed that someone fired shots outside that establishment with one shot going through the front door, hitting the back counter of the bar, and then ricochets into a glass shelf that holds liquor bottles. Two other bullet strikes were found in the building but did not enter the establishment. Employees believe that a group of patrons that were kicked out earlier in the night might have fired the shots into the building.

16. On 02/27/21 at 1:29am, Milwaukee Police were dispatched to 101 S. Dana Court for a subject with gun complaint. Upon arrival, officers interviewed security who stated that they were informed that a subject was beating another subject inside a vehicle, outside the establishment, and the subject was armed with a firearm. Security went outside to investigate, observed the incident, and called police. The subject left the scene before police arrival.

17. On 04/11/22 at 12:00am, Milwaukee Police were dispatched to 101 S. Dana Court for an Accident. Both vehicles left the scene before police arrival and the employee on scene was cooperative with any and all questions.

18. On 01/21/24 at 11:11p.m., Milwaukee Police took a walk-in Battery complaint that occurred at 101 S. Dana Ct. The victim stated they are employed as a bouncer and an employee had reported a customer had threatened to shoot them. The victim advised the subject they had to leave, however, was then threatened by the customer and their spouse, they would shoot the victim. The victim escorted the two out and slipped down the stairs, at which time both subjects began to kick the victim, causing the victim to go to the hospital for their injuries. Officers attempted to retrieve video surveillance of the incident, however, were told the agent would contact them to provide video. (2 reports)

#### LICENSED PREMISE REPORT

This report is written by P.O. Aaron FROH, assigned to District Three, Late Shift.

This incident notification is written by P.O. Sisouphanh KEOVILAY, assigned to District 5, Early Shift.

On Sunday, January 21st, 2024, I was working inside as Acting Desk Sergeant. At approximately 11:11 PM, Morgan E. BOURNE (W/M 10/15/1977), walked into the District 5 lobby to report a battery.

BOURNE stated on 1/21/2024, he was working at 101 S. Dana CT. (Encore Gentlemen's Club), which is located in the City and County of Milwaukee, as a bouncer. BOURNE stated at 1/21/2024 at approximately 1:00 AM, a dancer that goes by the name of "Jamie" informed the DJ, Brian that a bar customer, unidentified W/F threatened to shoot her. BOURNE stated Brian then told the bouncer to escort the female subject out of the club. BOURNE stated the unidentified W/F was with an unidentified W/M at the time. BOURNE stated he told the female subject to leave and her and her husband threatened to shoot him. BOURNE stated he tried to walk the husband out by the shoulder, he became combative so he pushed the husband out and slipped, fell down the steps of the entrance. BOURNE stated his friend, Donavon B/M, came to try to pull the wife off of BOURNE after she put her hand on his neck, took his shirt, and pulled it over his head. BOURNE stated the wife fell on him. BOURNE stated he couldn't see but he believes the husband and or both the wife were intentionally and without consent, kicking him, while the three of them were on the ground, BOURNE stated Brian and Donavon were still standing and helped stop the suspects from kicking him. BOURNE stated he did not know who the husband and wife were. BOURNE stated the husband was wearing a pink anime sweatshirt, has short curly black hair, was approximately 5'6" tall, and wearing sweatpants. BOURNE stated the wife had shoulder length brown hair, heavy build, and was approximately 5'3" tall. BOURNE stated he went home.

BOURNE stated he was in pain on 1/21/2024 at 5:00 PM he went to Froedtert Hospital to receive medical care. I observed BOURNE wearing white sling on his right shoulder and arm, bruises on the inside of his lower lip, red bruising on his forehead, lacerations on both knees, and bruising on his left arm, redness on his left upper arm, and skin loss on his left pinky finger, still causing him pain. I observed the discharge papers BOURNE gave me and the paperwork's diagnosis was a fall, assault, glenoid fracture. BOURNE stated he left the hospital at 9:30 PM on 1/21/2024, stopped somewhere to grab some food and came to District 5 to report the incident. BOURNE stated he did not go to the hospital initially because he didn't think his injuries were that bad but after speaking with a friend, he went to the hospital.

On Tuesday, January 23rd, 2024 at approximately 1:03 A.M., P.O. Joseph MACK and I, Squad 3321 were dispatched to 101 S Dana Ct. (Monreal's Encore Gentlemen's Club) for follow up regarding a battery complaint that occurred there on 1/21/24.

During this investigation, I was equipped with a body worn camera which was activated.

Upon arrival, P.O. MACK spoke to the bartender, Karri D. VOGT (W/F, 05/17/73). VOGT stated that she wasn't working the night that the battery occurred. VOGT stated that she had spoke to her manager, identified as "Nick" over the phone regarding the incident. VOGT stated that the manager was going to reach out to the police regarding the video.

VOGT stated that she was bartending today and showed P.O. MACK her driver's license and valid bartender's license.

P.O. MACK and I didn't observe VOGT serving drinks.

I asked VOGT multiple times if I was able to try to look at the video myself, seeing if I could get it to work and VOGT stated that she was afraid that she would get in trouble if the video got screwed up.

I spoke to the bouncer, identified as Daniel J. WAFFENSCHMIDT (W/M, 07/19/82) who also stated that he wouldn't have access to the video or have me to try to figure out the camera system after asking. WAFFENSCHMIDT showed me the posted licenses which were posted within view.

I observed the following licenses:

Class B Tavern License: Current

Food Dealer License: Current

Public Entertainment Premises License: Expired on 6/20/2023

A check through LIRA revealed that the public entertainment premises license is current and expires on 6/30/24.

I explained to WAFFENSCHMIDT that he needed a current posting of the public entertainment license.

#### LICENSED PREMISE REPORT

This report is written by P.O. Joseph MACK assigned to District 3, Squad 3321, Late Shift, along with P.O. Aaron FROH. P.O. FROH and I were in full duty uniform equipped with an Axon body worn camera activated and in a marked squad vehicle.

On Monday, January 22, 2024, at approximately 12:17 am P.O. FROH and I were dispatched to conduct a canvass in an attempt to identify a suspect at Encore Gentlemen's Club 101 S Dana Ct. regarding a walkin battery complaint at District 5 that occurred yesterday, Sunday, January 21, 2024, at this location.

Upon arrival I spoke to the bartender, Jacqueline Y MURPHY (B/F, 6-27-71), who stated she was working the night prior and did witness the beginning of the incident. MURPHY informed me she was working behind the bar, which is located approximately 5-10 feet near the business' front entrance. MURPHY stated a white female and white male were sitting at the bar and the female was being verbally offensive to the other female employees. MURPHY stated she saw their bouncer go to them and start to escort them to the front door. MURPHY stated she then observed a scuffle between the unknown male subject and the bouncer. MURPHY said she then went to get the manager on duty and did not further see the incident.

MURPHY stated she did not have access to review surveillance video, but I could see a camera on the outside front door facing west. I also observed on a monitor screen behind the bar other surveillance video located throughout the property. MURPHY stated the manager, who was not currently present during the canvass, would be the one able to review video. MURPHY was given a community card along with the investigating officer's information to give to the manager that has access to review surveillance video to call.

I did not observe MURPHY serve any drinks while we were at the establishment nor did I ask to see her bartending license. I did not check to see the licenses of the bar.

Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
