We have received your client's claim for \$499 in cash that was confiscated incident to his arrest.

As you know from representing Mr. Stribling at the property return hearing, the Milwaukee Police Department never inventoried the cash in question. It was placed, along with other property of your client, in a bag which was then sealed. The amount of the cash and the other property were duly listed. The bag, along with your client, was then transported to the Milwaukee County Criminal Justice Facility. Milwaukee County acknowledged receipt of the sealed bag and booked your client. The sealed bag was then given to your client upon his release. This information was attested to in affidavits filed in the circuit court.

There is no evidence that the City of Milwaukee was negligent in this matter. As such, the City is not liable and denies your claim.
