There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/24/74 the applicant was arrested by the West Allis Police Department for Disorderly Conduct. He was found guilty on 01/24/74 and fined.
2. On 03/02/74 the applicant was arrested by the Greendale Police Department for Contribute to Delinquency of Minor. He was found guilty on 03/02/74 and fined.
3. On 06/07/95 the applicant was charged in Racine County with Disorderly Conduct §947.01 (misd).

4. On 01/28/2005 at 11:25 pm, officers made a lawful inspection of the licensed premises at 813 S 1st St, Club Paradise. Officers discovered 3 underage patrons in the bar.

5. On 02/12/2005 at 11:20 pm, officers made a lawful inspection of the licensed premises at 813 S 1st St, Club Paradise. Officers discovered an underage patron in the bar. The doorman checked the ID which the underage person had, indicating he was underage, but the doorman said he apparently misread the ID information.

Charge: Presence of Underage
Finding: Dismissed without prejudice

6. On 01/20/09 at 2:05 pm, Milwaukee police were dispatched to 813 S 1st Street for a Reckless Use of Firearm complaint. Police spoke to Lisa D Whyte who is employed as an accountant for the club. Whyte stated she discovered bullet holes in a window of the building and that the window was intact on Saturday 01/17/09 at 2:20 am. Business security cameras did not cover the area of incident and there were no security cameras on nearby buildings to view possible surveillance. A report was filed.

7. On 01/14/10, Milwaukee police were dispatched to 831 S 1st Street for a Property Damage complaint. Investigation revealed a patron from the club had been in an unrelated physical altercation in the parking lot with the driver of an unknown vehicle. After the altercation, the patron intentionally drove at the subject as he exited the business. The patron missed the victim but struck the building causing extensive damage. The suspect was later found and arrested.

8. On 06/17/12 at 12:16 pm, Milwaukee police were dispatched to a Battery complaint at St Francis Hospital. Police spoke with the complainant who stated she was a dancer at the Solid Gold located at 813 S 1st Street and that on 06/18/12, at 2:00 am, she was approached by another dancer who punched her multiple times in the face without provocation, causing pain and bruising without her consent. Officers did observe bruising to the victim's right eye. On 06/22/12 at 4:46 pm, follow up was conducted and police spoke with the manager, Ryan Urban, who stated he was at the club on the night of the incident and that he was not aware of anything taking place, but that the complainant had appeared to be highly intoxicated, and as a result, the bartender drove her home. Police spoke with the alleged suspect, Carmen Gely, who stated she was working that night and that the complainant was extremely intoxicated and that they did get into an argument, but that Gely never touched the complainant. Gely provided no witnesses to police and a citation was issued for assault and battery.

9. On 02/10/2013 at 9:25pm, Milwaukee Police were dispatched to a battery complaint at Columbia St Mary's Hospital. The investigation revealed the victim; an exotic dancer at Solid Gold Gentlemen's Club, 813 S 1st St was attacked in her dressing room after closing by six fellow co-workers. The attack caused a laceration under her right eye that required adhesive glue to close. The bouncer and manager said they observed "Mona" strike the victim in the face with a set of keys, which they believed caused the laceration. The victim was able to identify all suspects by their stage names that in turn helped the manager supply officers their correct names and dates of birth. The case was taken to the district attorneys office on 02/15/2013 for processing and pended to 03/20/2013 at which time the case was no processed due to the victim not showing up.

10. On 02/22/2014 Milwaukee police responded to a fight complaint at 813 South 1st Street (Solid Gold Gentleman's Club). Investigation revealed two patrons of the business were involved in an altercation in the parking lot after leaving the business. No violations were observed and no citations or other reports were written.

11. On 09/08/2014 Milwaukee police overheard gunshots in the area of South 2nd Street and West Walker Street. As the officers drove past the parking lot of Solid Gold Gentleman's Club (813 South 1st Street), they observed two subjects. One subject was bent over at the waist while the other subject held a handgun to the first subjects head. Both parties were arrested and it was later determined that the subject holding the handgun had been a patron of the business prior to walking outside and becoming involved in a fight with the other subject. A vehicle parked in the lot of the business as well as a building across the street from the business were damaged by the gunfire. Milwaukee police incident report #142510006 filed.

12. On 01/16/2015 officers went to Solid Gold, 813 S 1st St, for a licensed premises check. They observed no violations and the son of the owner was on scene and cooperative.

13. On 02/10/2015 at 11:05pm officers went to Solid Gold, 813 S 1st St, for a licensed premises check. The officers noticed the name had changed to Texas Jays Gentleman's Club. The manager stated the applicant had completed the necessary work to change the business name. No violations were observed.

14. On 03/30/2015 at 1:30am officers went to Texas Jays Gentleman's Club, 813 S 1st St, for a license premises check. When officers arrived they saw cars in the lot and music coming from inside. When they tried to enter the door was locked. After several knocks the applicant opened the door. When officers entered they observed dancers performing on stage and approximately six patrons inside. The applicant stated he was in the process of closing and didn't want anyone else coming inside. The applicant was cited for Licensed Premises-Open Entry Required.

15. On 04/02/16 officers were dispatched to St. Francis Hospital to investigate an Aggravated battery that occurred at Texas Jays (813 South 1st St) on 04/02/16 at approximately 2:00am. The victim, Jeremy CALTEUX, was unable to provide a statement at the time because of his injuries, which included a skull fractures, subdural hematomas and contusions. Offices spoke to a second victim, Jonathan RUTTER, who stated he had gotten into an argument with a bartender at the premise, when bouncers began to push him toward the door. RUTTER further stated the next thing he remembered was waking up on the floor next to CALTEUX. He did not call for police nor did they arrive at the location. On 04/02/16, at 5:31pm, officers responded to the location to review video. The bartender stated he did not have access to the video and they would have to come back at 8:00pm to speak with the manager. Officers came back and spoke to the manager, Ryan URBAN, at 8:30pm. URBAN stated he was unable to retrieve the video and the technician who could was unavailable. URBAN was present during the fight and stated that RUTTER was intoxicated and was arguing about a credit card. When Rutter was being escorted from the establishment he attempted to strike URBAN. Security controlled RUTTER until a fight broke out in the vestibule. URBAN lost sight of RUTTER and when the fight stopped he observed two subjects on the ground. Both subjects got up and continued to fight until they left. On 04/03/16 officers drafted a search warrant to retrieve the video system. Video depicted RUTTER in a physical confrontation with security. CALTEUX is seen standing when he is struck by a subject who causes him to fall and hit his head. Rutter was then struck to the head and falls to ground. Both CALTEUX and RUTTER are dragged toward the door. Both individuals appear to be unconscious for approximately 8 minutes. Both CLATEUX and RUTTER are helped up and leave the establishment. At no time was medical services called to the location.

16. On 05/25/16 a meeting was held at the request of the Licensee, John Urban. The meeting was attended by Alderman Jose Perez, Captain Heather Wurth, Sergeant Chad Raden, ACA Nicholas DeSiato, Nick Anton, License Division Manager Jason Schunk, Attorney Michael Maistelman and Attorney Michael Whitcomb. The licensee was served revocation papers. ACA DeSiato provided a list of potential witnesses. Anton expressed regret that the incident had occurred and Urban stated he had viewed only a portion of the incident. Officers requested the passwords to the DVR systems they had seized and as of 05/27/16 they had not received them.

17. On 06/30/2016 Milwaukee police responded to a fight at 813 South 1st (Texas Jays). The agent, John Urban stated there was fight between two patrons inside of the establishment. The victim of battery refused to provide any information regarding the incident. The employees were cooperative. There was no camera footage of the incident because the cameras were not recording. Milwaukee police incident report #161820151 filed.

18. On 07/07/2016 Milwaukee police conducted a licensed premise check at 813 South 1st Street (Texas Jays). The applicant was on scene and cooperative. No violations were observed.

19. On 05/21/2017 at 2:20am an officer investigated a theft complaint at 813 S 1st St. The victim stated he was walking outside of Texas J's when he observed the bouncer escorting a couple out of the bar. The victim was videotaping the incident when the bouncer approached and took his phone. He attempted to get it back but the bounce would not return it. The victim attempted to GPS locate his phone which showed it on the freeway. MPD report filed.

20. On 06/20/2018 at 2:00am an officer observed an altercation at Texas Jay's, 813 S 1st St. The investigation revealed a patron became unruly when asked to leave at closing time. The subject was escorted out and began kicking the door, damaging it. The subject then began running at the security guard with metal item in his hand. The security guard used his Taser to stop the subject, who was then taken into custody by the officer. The subject was arrested for Disorderly Conduct.

21. On 12/01/2020 at 1:16am officers were dispatched to a Shooting at 813 S 1st St. The officer spoke with an employee, who stated a subject was in the bar and assaulted a dancer. The subject was escorted out but returned and had to be escorted out again. At this time the employee heard 3 gun shots. The employee chased after the subject who fired 2-3 additional shots. No one was hit but the building was struck 3 times. The employee stated the camera system did not work at the establishment.

22. On 03/07/21 at 1:52am, Milwaukee Police were flagged down for an alleged battery at 813 S. 1st Street. The intoxicated subject told officers that he was inside the tavern when he became sick and started throwing up inside the bathroom. He then said that dancers and security began to attack him and throw him out of the establishment. A security guard was interviewed at the tavern and he said the subject entered the premise highly intoxicated and began throwing up within minutes of his arrival. Security then told the subject that he could not stay at the tavern and the subject became irate and began screaming. He was escorted out without any physical altercation. The subject was told repeatedly to leave the property but he returned inside and poked one of the security guards in the chin. The security guard stated that the subject then left and was falling down outside. There were no functioning cameras at the establishment and due to the level of the subjects intoxication, officers wanted to speak to the subject on a later date.

23. On 06/13/23 at 1:44a.m., Milwaukee Police were dispatched to an Accident at 813 S. 1st St. On arrival officers observed the victim inside the location and injuries being tended to by employees. Investigation revealed an employee had issues with the suspect and a physical fight ensued outside the establishment, at which time the suspect got in their vehicle and intentionally hit the victim, smashing their leg in between two cars. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

24. On 08/06/24 at 2:28a.m., Milwaukee Police on patrol observed a Fight at 813 S. 1st. Officers initially observed the group leave the business, but then a physical fight ensued. The officers broke up the fight and spoke to employees, who stated they closed at 2am and were unaware there was a fight outside.

25. On 07/22/25 at 7:15p.m., Milwaukee Police conducted a License Premise Check. Assisting in this assignment were Special Agents from Wisconsin Department of Revenue Alcohol and

Tobacco. This was due to Holds on their license regarding outstanding balances owed to whole sellers. The business agreed to close for the night and a check on 07/23/25, revealed the balances had been paid and the License was issued.

26. On 03/18/26 at 1:25a.m., Milwaukee Police were dispatched to a Theft. Investigation revealed a patron's vehicle was towed due to parking in the employee parking lot.

This report is written by P.O. Kevin VODICKA assigned to District Two, Day Shift. On Tuesday, July 22, 2025 at or about 7:15 pm, Squads 2166 (myself), 2474 (P.O. Jack CARLONI and P.O. Daniel FINN), and 2416 (Sgt. Daniel STACHOVIAK) along with Dept. of Revenue Special Agents conducted an inspection of Texas J's, located at 813 S 1st St. A routine check of city licensing the previous week had revealed that the Class B Tavern License was in a "Granted not Issued" status since March of 2025 due to two holds placed upon the license by liquor wholesales for unpaid bills. Officers were in full duty uniform and equipped with body worn cameras.

Upon arrival officers found the "open" sign to be illuminated, the doors to be unlocked, no customers present, and numerous employees including the manager for the location, Amber JACQUES. I explained the nature of the inspection and JACQUES stated that she was unaware of the licensing issue but stated that she was also having a problem with her City of Milwaukee Manager's license. A check of LIRA revealed that license had expired and that JACQUES had applied for a renewal. JACQUES showed me several emails to City of Milwaukee License Div. where she and employees were trying to fix the situation with an PIN associated with her account.

JACQUES then called the authorized contact person for Le Cabaret LLC, Ryan URBAN, and put the call on speaker phone. URBAN stated that he believed all of the outstanding balances had been paid and he was waiting for the Class B license to be mailed from the City. I explained to URBAN that the Dept. of Revenue also reported that wholesalers continued to list outstanding balances and the premises could not sell alcohol until the license issue was corrected. URBAN and JACQUES opted to close for the night rather than remain open without alcohol sales.

On 7/23/25 I followed up with the City of Milwaukee License Division and learned that the balances had been paid and the license for Texas J's had been issued. No citations were issued.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 5/19/2026 at 9:50 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
