Dan,

According to the city's zoning code of ordinances 295-407-b-4-c, "A projecting sign shall not project more than 4 feet from the building face to which it is attached."

The plan examiners do not consider the projecting bay to be the building face, therefore the sign projects well beyond the 4 foot limit over the city right of way. I would suggest relocating the sign to one of the masonry piers at the north or south ends of the storefront.
