
An application was recently submitted to the Historic Preservation Commission to designate the Holy Mt. Carmel Missionary Baptist Church at 2127 W. Garfield Avenue, in the 15<sup>th</sup> aldermanic district, as a historic site or structure (see map on back of this page).

A public hearing has been scheduled for Monday, March 11, 2013 at 3:00 p.m. in City Hall, 200 East Wells Street, Room 301-B to determine whether or not the proposed designation of the Holy Mt. Carmel Missionary Baptist Church at 2127 W. Garfield Avenue satisfies the criteria for historic designation in accordance with Section 320-21 of the Milwaukee Code of Ordinances.

If the Commission determines the building meets at least one criterion, a favorable recommendation for nomination can be forwarded to the Milwaukee Common Council.

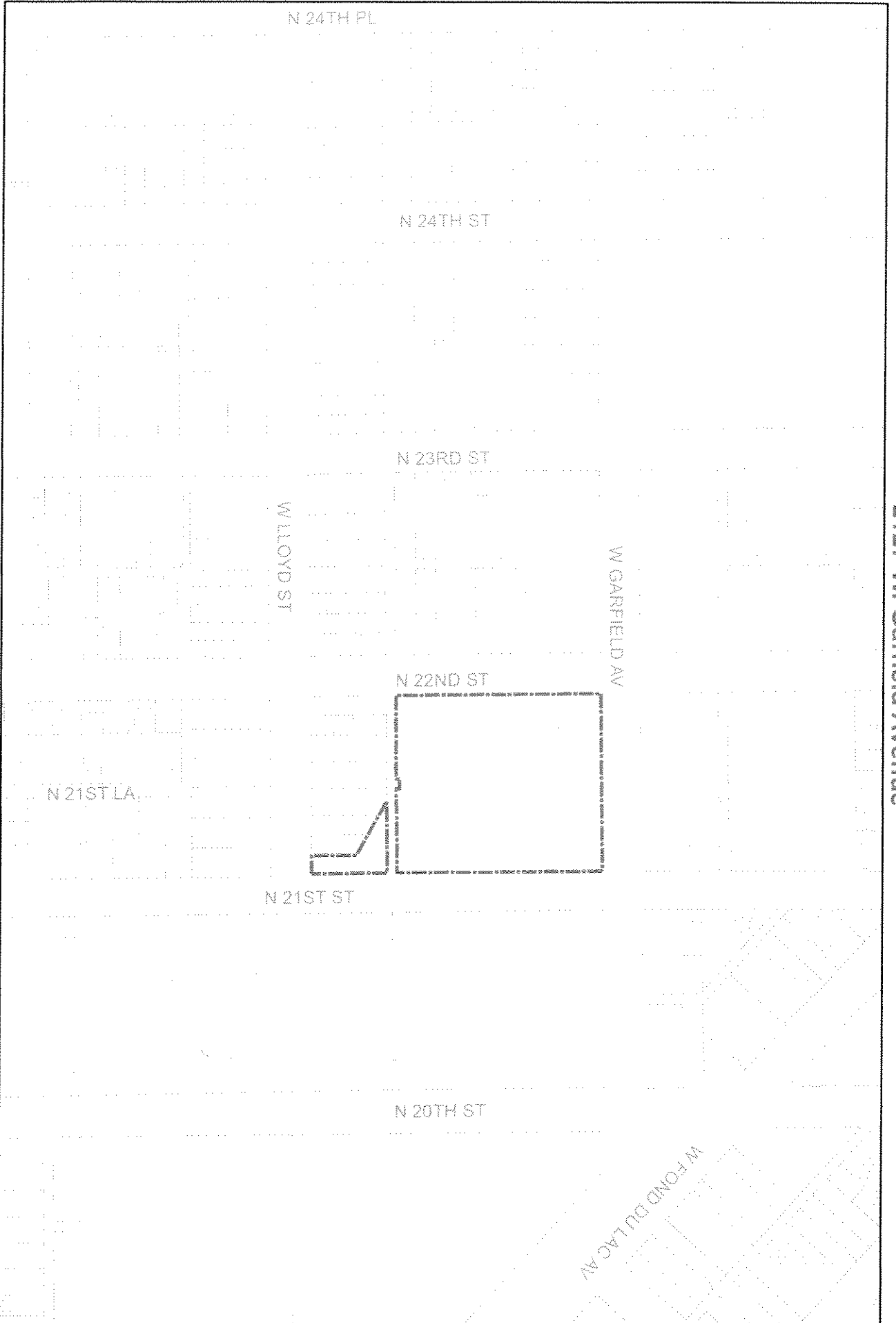

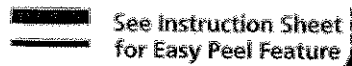


Holy Mt. Carmel Missionary Baptist Church
