This office is in receipt of your claim in the amount of \$4,371.03, relating to your subrogation interest and the interest of your insured arising from an August 27, 2002 loss in which your insured's vehicle collided with a City vehicle near East Kenwood and North Maryland.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report and the Fleet Accident Report completed as a result of this accident notes that the City vehicle was travelling west. Your insured pulled out into traffic from the curb area and made contact with the City vehicle. Your insured failed to yield the right-of-way. The liability for this accident is upon your insured, and as such, the City cannot accept liability for the loss. Accordingly, we are denying your claim.
