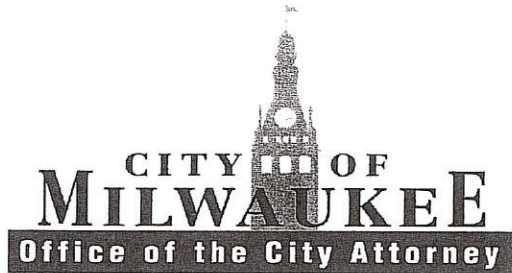

Dear Attorney Phebus:

We have now received your notice of claims in the amount of \$500,000.00 from a loss on June 9, 2017.

The Wisconsin Motor Vehicle Accident Report completed as a result of this incident notes that the Milwaukee Police Department squad car was operating as an emergency vehicle with lights and siren activated. It entered the intersection. The car driven by your client failed to yield the right of way to the squad car and was cited for this. The liability for this accident is upon your client. As such, the City cannot accept liability for the damages. Therefore, we are denying your claims.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.


