# PUBLIC SAFETY COMMITTEE ITEM 9, FILE #081422

**FEBRUARY 25, 2009** 

File #081422 authorizes the Milwaukee Police Department to apply for, accept and fund a Milwaukee Metropolitan Drug Enforcement Grant ("MMDEG") from the U.S. Department of Justice – Bureau of Justice Assistance in the amount of \$276,117, with a grantor share of \$179,938 and a City share of \$96,179. The MMDEG funds 3 sworn positions who, in concert with other participating jurisdictions, concentrate on reducing the volume of controlled substances in the greater Milwaukee area via increased enforcement activity and drug seizure. This one-year continuing project grant runs from January 1, 2009 through January 31, 2009.

## **BACKGROUND**

The Milwaukee Police Department has been a long-standing participant in the MMDEG program, which is administered through the Wisconsin Office of Justice Assistance and the Milwaukee County District Attorney's Office. Grant proceeds are used to fund Police Department positions that participate in a multi-jurisdictional task force, whose goal is to prevent and suppress illegal drug activity in the greater Milwaukee area. Current participants in this project include the City of Milwaukee, Milwaukee County District Attorney's Office, South Milwaukee and West Allis.

Through the years, the Milwaukee Police Department positions funded by this grant have varied, from Office Assistants only (1998) to Police Officers only (2003 and 2004). Beginning in 2006, this grant has funded 3 positions: a Lieutenant of Detectives, a Detective and a Police Officer.

## > Funding

City participation will increase to approximately 35% of grant proceeds in 2009 versus roughly 25% in recent years, as displayed below. While grantor participation included "confidential" funds (requiring no City in-kind match) of \$40,000 in both 2006 and 2007 and \$26,241 in 2008, no such confidential funds are included in the 2009 grant.

## FISCAL IMPACT

Acceptance of the \$276,117 Milwaukee Metropolitan Drug Enforcement Grant requires and includes City participation of \$96,179.

The 2009 Positions Ordinance will be amended to reflect that position authority for the impacted positions shall expire on December 31, 2009 unless the MMDEG is extended.
