Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/21/2018 officers were dispatched to a fight at Denny's restaurant, 3801 S 27th St. The investigation revealed two employees were fighting inside the restaurant. The manager wanted citations issued because the fight occurred in view of the public. Both subjects were issued a citation for Disorderly Conduct and they were fired by the manager.

- 2. On 07/11/20, Milwaukee Police were dispatched to Denny's Restaurant, 3801 S. 27th St., for a fraud complaint. Investigation revealed two patrons left without paying the bill totaling \$75.76. Management allowed officers to view the surveillance of the suspects and suspect vehicle leaving the scene. Management was cooperative with police.
- 3. On 11/15/20, Milwaukee Police were dispatched to Denny's, 3801 S. 27th St., for a fight. Investigation revealed there was a confrontation between patrons and the suspect threw plates at the other patron and tore a decoration off the wall, causing damage. The uncooperative suspect remained on scene and was cited for vandalism. Management was cooperative with police.

- 4. On 03/19/2021 at 10:56pm officers were dispatched to a Fight at Denny's, 3801 S 27th St. The officers spoke with the manager, who stated there was a large fight in the dining area but all the subject were now gone.
- 5. On 03/26/2021 at 3:43am officers were dispatched to a Trouble with Subject at Denny's, 3801 S 27th St. The officers spoke with the employee who stated there was a group of people being loud and refusing to leave. The officer made several attempts to get the subjects to leave but they refused until the officer threatened to arrest them for Trespassing and Disorderly Conduct. The subject then left in an auto but threatened to run the officer over.
- 6. On 05/02/2021 at 10:23pm officers were dispatched to a Trouble with Subject at Denny's, 3801 S 27th St. The officer spoke with the manager, who stated a subject was sleeping in a booth and refused to leave. The officer attempted to wake the subject but were unsuccessful. The officer called MFD and they conveyed the subject to the hospital for treatment for intoxication.
- 7. On 07/19/2021at 6:49am officers were dispatched to a Fraud at Denny's, 3801 S 27th St. The officer interviewed a waitress, who stated a subject ordered food and left without paying for the items. The subject left on foot but got on the bus prior to the arrival of the police.
- 8. On 12/14/2021 at 10:16pm officers were dispatched to a Trouble with Subject at Denny's, 3801 S 27th St. The officers spoke with the manager, who asked for a subject to be removed from the business. The officers removed the subject and advised him to not return.
- 9. On 12/21/2021 at 8:29pm officers were dispatched to a Trouble with Subject at Denny's, 3801 S 27th St. The officer spoke with an employee, who wanted a subject removed for not paying and sleeping on the bench for an hour. The subject was conveyed to the hospital for medical treatment.

10. On 03/26/23 at 11:10pm, Milwaukee Police were dispatched to 3801 S. 27th St, for a trouble with subject complaint. Officers spoke with the manager who stated that she had to terminate an employee. The employee then engaged in a verbal argument with the manager. The employee left prior to police arrival. The manager was advised to call the police if the subject returns, and a citation could be issued.

- 11. On 04/01/23 at 9:52pm, Milwaukee Police were dispatched to 3801 S. 27th St, for a subject with gun complaint. Officers spoke with the manager who stated that a group of customers got into a verbal altercation with another customer at a different table. The single subject at one point stated that he was going to get his gun from his vehicle. The subject returned and acted like he had a gun in waist band. Both parties eventually paid their food bills and left with no further incident. No handgun was observed by staff.
- 12. On 04/03/23 at 9:40pm, Milwaukee Police were dispatched to 3801 S. 27th St, for a damaged to property complaint. The manager stated that an employee damaged the door to the business. The incident was captured on video but the manager could not provide it for officers, at that particular time.
- 13.On 04/13/23 at 2:34am, Milwaukee Police were dispatched to 3801 S. 27th St, for an armed robbery complaint. The caller stated that he was robbed at knife point. Police arrived at the location and the business was not cooperative with officers regarding the incident. Staff did not

answer questions asked by the officer regarding the incident. Eventually officers discovered the business had nothing to do with the complaint, and the caller just used the business phone to call for the police.

- 14. On 04/27/23 at 3:00am, Milwaukee Police were dispatched to 3801 S. 27th St, for an injured/sick complaint. The caller stated that a person is in the parking lot laying on the ground. Officers located the subject who was not responsive and it was determined he was over dosing. Officers administered Narcan and Milwaukee Fire arrived at the location, and transported the subject to the hospital for further medical evaluation.
- 15. On 05/01/23 at 12:38am, Milwaukee Police were dispatched to 3801 S. 27th St, for suspicious/other complaint. Officers arrived at the business and it appeared to be opened but no employees were on scene. Officers got a hold of the key holder and the manager stated that she thought she closed the business properly but had the wrong keys. The business is not opened after 12:00am on Sunday or Mondays.
- 16.On 05/19/23 Milwaukee Police were dispatched to 3801 S. 27th St, for an injured/sick complaint. Officers spoke to the caller who stated that he fell outside the location and wanted to go to the doctor. The caller was conveyed to the hospital by ambulance.
- 17.On 05/21/23 Milwaukee Police were dispatched to 3801 S. 27th St, for loud music complaint. Officers did not locate the vehicle playing the loud music and there was no answer on call back to the complainant.
- 18. On 05/22/23 at 3:30pm, Milwaukee Police were dispatched to 3801 S. 27th St, for a fight complaint. Officers spoke with the caller who was a grub hub driver, and stated that an intoxicated subject struck him in the face several times. Both subjects fought in the lobby area of the business. The victim stated that he would seek medical attention on his own. The business was cooperative with the investigation providing video and witness statements. The suspect was transported to the hospital and issued citations regarding the incident.
- 19. On 06/15/23 at 3:09am, Milwaukee Police were dispatched to 3801 S. 27th St, for a trouble with subject complaint. Officers spoke with the caller who stated that a subject was in the restaurant refusing to leave. The subject was at the location for the last four hours. Officers located the subject and advised her that the management wanted her to leave the premise. The subject gathered her belongings and left without any further incident.
- 20. On 07/09/23 at 5:12am, Milwaukee Police were dispatched to 3801 S. 27th St, for a fraud complaint. Officers spoke to the manager who stated that five subjects left without paying for their food. The subjects left in three different vehicles. The manager stated that he captured the incident on video. The security was off duty at the time of the theft.
- 21. On 08/04/23 at 4:09am, Milwaukee Police were dispatched to 3801 S. 27th St, for an armed robbery complaint. Officers spoke with the manager who stated that a suspect armed with a handgun demanded the money from the cash register. The suspect obtained money and exited the business south from the location. Video that captured the incident was recovered as evidence.
- 22. On 11/05/23 Milwaukee Police were dispatched to 3801 S. 27th St, for a battery complaint. Officers arrived and located a subject unable to get up from the floor. Investigation revealed that the subject was intoxicated and a fight did not occur.

- 23. On 11/28/23 at 12:48am, Milwaukee Police were dispatched to 3801 S. 27th St, for a welfare check. Officers spoke with a subject inside the restaurant that seemed to be in distress. The subject stated he was faint and dizzy, then became irate hitting a chair inside the location. Officers conveyed the subject to the hospital for medical and mental evaluations. The business was cooperative with the investigation.
- 24. On 12/09/23 at 4:22am, Milwaukee Police were dispatched to 3801 S. 27th St, for a subject with gun complaint. Officers spoke to the suspect who stated that she fired her gun in the air to stop a fight, then during the altercation her gun was stolen. The suspect's action resulted in Reckless Endangering Safety and the suspect was detained for the incident. Investigation revealed that a fight occurred between her party and another party. The suspect fired one shot in an attempt to stop the fight. During the commotion the suspect was wrestled to the ground and her gun was taken by people from the other party. The business was cooperative with the investigation providing video of the incident and witness statements from staff.
- 25. On 01/27/24 at 7:08am, Milwaukee Police were dispatched to 3801 S. 27th St, for a threat complaint. Officers spoke with the manager who stated that an employee on video stole money from the safe. The supervisor was going to allow the employee to return the money but the employee had not returned phone calls. The business was cooperative with the investigation and provided video of the theft.
- 26. On 01/30/24 at 1:35am, Milwaukee Police were dispatched to 3801 S. 27th St, for a theft complaint. Officers spoke with the employee who stated that a group of six ate at the business but only two subjects of the six paid for their meals. The other subjects left the location without paying. The theft was not captured on security cameras.
- 27. On 03/05/24 at 3:35am, Milwaukee Police were dispatched to 3801 S. 27th St, for a trouble with subject complaint. Officers arrived and were informed by the manager that the subject just left prior to officer's arrival. The subject initially refused to leave after smoking in the restaurant area.

On Scene/License Premise -

Upon arrival at 11:17 PM, at the listed location, I was met by caller/later identified as restaurant manager; Chavallia C. ANDERSON (B/F, 11-09-1989) who stated she just fired an employee; Geraldine SIMONSON (A/F, 04-19-1980) for allegations of illegal drug use. ANDERSON stated she did not observe SIMONSON doing illegal drugs but was told by someone that she was using drugs while at work. ANDERSON stated when she advised SIMONSON that she was firing her, SIMONSON and she engaged in a mutual verbal argument. ANDERSON stated SIMONSON left the property prior to my arrival on scene. I provided ANDERSON with information in regard to a protection order. ANDERSON stated she called for police because she did not want the incident to escalate. I advised ANDERSON that if SIMONSON returns, I would issue a citation for trespassing and may issue a citation for disorderly

This case is pending a future Citation if ANDERSON states SIMONSON comes back to the restaurant without her consent.

Upon arrival, we spoke to Store Manager Chavallia C. ANDERSON B/F 11-09-89 Address: 3801 S. 27th St. Phone: 282-7946 who stated there was a table of Puerto Rican males and a table with a single Black male looking back and forth at each other like they knew each other. The Puerto Rican males finally asked the Black male if he knew them (the Puerto Rican males). The Black male responded by throwing his cell phone to the floor, removing his shirt, and taking up a position to fight them. The Puerto Rican males stated they didn't want problems with the Black male. The Black male at one point stated he was going to go to his vehicle and get a gun from the vehicle. The Black male walked out the front door, and returned shortly after holding onto his waistband like he had a handgun in his waistband. ANDERSON stated she never saw a handgun.

After some more communication between them, the Puerto Rican males and the sole Black male paid their bills and left the location without any additional incidents.

There are cameras at the location. There are no security officers at the location. Milwaukee Police Officers have been to this location 12 times since 02/01/23.

No other violations were observed by officers.

Sherley (b/m, 7/5/06) intentionally and without consent damage their entrance door and caused a disturbance inside the restaurant. Damage to window was \$438.00.

The location did have video that captured the incident however, the video was not available for officers to view with the manager on scene.

The suspect approached the front counter pointed a black firearm at the manager and stated "open the register" "I'm going to shoot" the suspect then walks behind the counter and the suspect and manager get into a scuffle. During the scuffle the suspect was able to obtain the cash drawer from the register containing between \$300.00-\$500.00 US currency in unknow denominations.

After obtaining the drawer from the cash register the suspect exited the business and fied southbound on S. 27th St. on foot.

The suspect was described as a MALE, HISPANIC, 5'11", 170-230LBS, DARK SKIN, wearing a BLACK HOODIE, BLACK JEANS, and armed with a black handgun.

Video surveillance was recovered by the responding forensic investigator.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the Armed Robbery, I did not observe any violations in the licensed premise.

David CONNER, both in full duty uniforms, equipped with BWCs, and operating a marked MPD squad #574) was dispatched along with additional squads to 3801 S. 27th Street (Denny's), in the City and County of Milwaukee, Wisconsin for a Subject With Gun complaint that became a Shots Fired complaint.

Upon arrival, we observed some vehicles leaving the parking lot and some people exiting the restaurant. License plates for the leaving vehicles were advised to dispatch.

I spoke to two females outside the front door. One of the females was suspect, Shantil A. GARY (B/F, 01-11-89), the other was her sister, Oshameka L. NORRINGTON (B/F, 08-02-80). GARY stated she and her friends had been assaulted and she also had her gun stolen from her. I observed facial bruising and swelling to both females' eye area. I attempted to get some of the people leaving to stop and stay, and confirmed if they witnessed any of the incident. I then went inside the restaurant with GARY and NORRINGTON.

Inside the restaurant, GARY stated that she fired her gun inside the restaurant intentionally into the ceiling to stop the assault. I detained GARY after she admitted to me that she shot her gun inside the restaurant, and after she was also pointed out by waitress, Staci M. MCDADE (W/F, 09-18-79), as the person who fired the gun.

GARY became distressed after being handcuffed, and stated she was having difficulty breathing. I summoned medical for her, and MFD Engine 12 and MED 17 arrived and assessed her. All her vitals were

"Federal .380" casing and a live "Federal .380" round on the floor inside the restaurant.

I filed an Incident Notification and was advised by LT. Joseph HALL that this case was mine to handle.

GARY was arrested on scene and conveyed to District 6 for booking.

Squad 6390 (P.O. Nathan LOCICERO) had manager EBERHARDT show him the surveillance video, which I also observed. It should be noted that the video appears to be approximately one hour ahead of actual time (4:04AM actual time = 5:04AM video time).

In the video (which began approximately 5:04AM on Camera 11), I observed the parties involved in their respective groups seated at their table and standing near the register counter. It appeared that GARY was filming the subjects with her phone. About a minute into the video, a male (likely GARY's brother, DAVIS) got up from the table and walked over toward the counter area retrieving something and then walked back to the booth. Shortly after that, GARY got up and walked over to the group by the counter followed shortly after by the other members of her party. The B/M suspect then squared up to the group and DAVIS and struck DAVIS, causing DAVIS to fall backward on the ground toward their table. DAVIS stays down and appears to be dazed and unable to get up right away. The B/M suspect then struck NORRINGTON and LISAREFACH and bends over toward DAVIS pushing the females out of the way. During this, GARY went back to her table and appears to be getting something from where she had been seated. While standing over DAVIS, the B/M suspect then appeared to strike DAVIS two more times in the face before GARY appeared to hold an object (likely the gun) which she retrieved from the seat area. GARY then appeared to hold the gun in her right hand and fired up in the air (at 5:06AM). GARY then chased after the subjects toward the front entrance area. DAVIS got up from the ground slowly after the people cleared the area around the table. On Camera 3, in the entrance area, GARY confronted the B/M suspect, and the B/M suspect violently grabbed and slammed GARY into the walls in toward the bathroom hallway area. It appears the B/M suspect emerged from the area having picked something up from the ground near GARY (likely the gun), and then tried to leave. Another unknown party attempted to stop the B/M suspect and it appeared the B/M suspect may have pointed the gun at the party before leaving. The video shows most of the people exiting by approximately 5:08AM.

I placed a preliminary recording of the surveillance video on Evidence.com. P.O. LOCICERO will contact the GM for actual footage.

The B/M suspect appears to be approximately 25-35 yoa, medium complected, with longer braided hair, heavy build, wearing a black hooded sweatshirt with a white "U" shaped design on the right chest and another more faded white design on the left chest, dark jeans, and two-toned white and gray shoes.

The stolen firearm was teletyped #MWP6-0009, and will be updated later with a S/N # when available.

After booking, at 6:33AM, Squad 6350 (P.O. Juan GARCIA) read GARY her Miranda Rights from the State of Wisconsin Constitutional Rights Card verbatim. GARY understood her rights and did not wish to add anything to what she stated on scene.

This report was submitted by Police Officer Rafael LOPEZ assigned to District 6, Late Shift, as Squad 6390.

During this call for service, I was in full Milwaukee Police Department uniform with my badge and last name affixed to my outmost garment and equipped with an AXON body worn camera which was activated during the course of the investigation. I was also operating marked Milwaukee Police Department squad #658 with functional red and blue emergency lights and audible siren also equipped with an AXON camera system.

On Tuesday, March 5, 2024, at approximately 3:35 a.m., Squad 6313 (Sgt. Kimberly ANDERSON), Squad 6350 (Police Officer Nash DATHE), Squad 6320 (Police Officer Nashata NORWOOD) and I were dispatched to the address of 3801 S. 27th St., which is the DENNY'S Restaurant establishment located in the City and County of Milwaukee for a Trouble with Subject call for service.

Upon our arrival, we were informed by an employee that the subject was no longer on scene and that he left the DENNY'S Restaurant five to ten minutes ago. I then spoke to the manager who identified herself as Jessica K. LENTZ (w/f, 9-14-1994) who stated that she called police because an unknown subject was refusing to leave the DENNY'S Restaurant.

LENTZ stated that the unknown subject described as a black male, 50-55 years of age, 5'6", 140 lbs., wearing a black hoodie, grey t-shirt, and blue jeans was seating at a table in the dining area of the DENNY'S Restaurant eating his food. The unknown subject was then observed smoking a cigarette while still seated at the table in the dining area. The unknown subject was notified he could not smoke inside the DENNY'S Restaurant and he then got upset towards staff. LENTZ stated that the unknown subject was then observed smoking inside the vestibule located in the main entrance of the DENNY'S Restaurant. LENTZ told the unknown subject he had to leave the DENNY'S Restaurant due to him smoking a cigarette inside the establishment. The unknown subject got upset at LENTZ and began to call her names in an aggressive manner. LENTZ stated she went to her office located towards the back of the DENNY'S and called 911.

LENTZ stated that the unknown subject was given a carry out box for his remaining food and he exited the DENNY"S Restaurant before police arrival. LENTZ stated that the unknown subject got on a Milwaukee County Transit bus and was last seen traveling northbound on S. 27th St.

The employees at the above listed establishment were cooperative during the investigation.
