The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/26/2007 the applicant was charged in Milwaukee County with Carrying a Concealed Weapon.

2. On 11/23/2017 officers observed subjects entering Point's View Boite, 1619 S 1st St, after 2:00am. The officer also observed subjects drinking at the bar after closing time. At 2:25am an officer entered and found a large group of about 40 patrons inside. The applicant was on scene and stated he thought he could close at 2:30am on Thanksgiving. He was advised closing time was 2:00am. He was cooperative and apologetic.

- 3. On 03/30/2018 officers were dispatched to an indecent exposure at Points View Boite, 1619 S 1st St. The caller stated she observed 12 strippers inside the tavern. The officer went to the business and observed several women dressed in lingerie but no one unclothed. The applicant stated they were throwing a lingerie party and there were no strippers. No violations were observed.
- 4. On 03/31/2018 at 2:41am officers conducted a licensed premise check at Points View Boite, 1619 S 1st St. When the officer attempted entry they found the door locked. Security opened the door and the officers observed a group of patrons inside consuming alcohol. The bar was cleared and the officers counted 16 patrons inside after hours. The applicant stated he was having issues closing out customer tabs which resulted in them being inside after hours.

5. On 04/06/2018 a meeting was held at District 2 with the applicant regarding the after-hours incident from 03/31/2018 at Point's View Boite, 1619 S 1st St. Captain RAMIREZ stated he was concerned because this was the second after-hours violation under new ownership. The applicant was advised the premise is not licensed for "dancing by performers" and he needed to obtain special event permits from the alderman. He was also advised occupancy includes employees and performers. The applicant stated he would start closing earlier in order to have patrons out by 2:30am. He also stated he would obtain the necessary licenses to have employees dance.

- 6. On 07/30/2018 at 2:22am officers were dispatched to Points View Bar, 1619 S 1st St for an Assist the Officer complaint. The officers spoke with the applicant who stated there was a female that was trying to pick fights and attempted the jump over the bar. Other patrons, who were off duty police officers, restrained the female and escorted her outside. The applicant did not wish to prosecute.
- 7. On 10/04/2018 officers investigated a Robbery complaint that occurred at Points View, 1619 S 1st St on 09/29/2018. The victim stated he was inside Points View Bar and was jumped by a group of 13-15 males. The victim stated he did not start the fight and does not know why the subjects jumped him. The victim stated he was on the ground and the subjects were kicking him. He stated that security got involved and was assisting the subjects hitting him. He stated security dragged him into the bathroom and pulled off his three gold necklaces from around his neck. The victim was then escorted out of the tavern and he went home to Chicago without calling the Police until 10/04/2018. The victim did sustain injuries that required medical attention. The officers contacted the owner and were unable to view the surveillance video.
- 8. On 11/11/2018 officers were advised of an incident at Point View, 1619 S 1st St, which occurred on 11/09/2018. The complainant stated she was at Point View on Friday 11/09/2018 and was involved in a fight. She stated she was taken out and was outside on the patio when another patron approached her and displayed a gun. She stated that she was not threatened but wanted the Police to know that there are patrons with guns at the bar. The applicant stated he has 3 unarmed security guards inside the business as well as 3 armed Midwest Security

Guards. His security pats down patrons as they enter and does not allow guns in the bar. The officers watched the video from that night. The officers observed the complainant on the patio with security. They observed a subject approach her, and talk with her. The officers did not see a gun in the subject's hands.

- 9. On 12/23/2018 at 1:58am officers were dispatched to a Subject with Gun call at S. 2nd St and W. Lapham Bl, which the officers found to have occurred at Point View. The caller was security who stated they kicked out two subjects. A car came to pick up the subjects and the front passenger displayed a firearm and threatened to shoot up the bar. The security guard told the subject to put the gun away and the two subjects that were kicked out got in the car and left. The applicant and security were cooperative with the investigation.
- 10. On 02/03/2019 at 2:10am, officers were dispatched to shots fired at Point View, 1619 S 1st St. The officer arrested a subject sitting in a car next to Point View in the Scrub a Dub lot. The subject had two firearms and marijuana in his auto and casings inside and outside his auto. The investigation revealed the subject to be 20 years old and he stated he had been inside Point View. He stated he knew the security and had paid the bouncers \$100 several months prior to be let in. He wouldn't identify the security guard. A security guard stated he was outside keeping 2 groups from fighting when he heard several shots fired. The officers interviewed the applicant who stated he was inside when he heard shots fired outside. The applicant stated he does not have cameras outside covering the area where the shots were fired. The applicant was cooperative during the investigation.
- 11. On 02/17/2019 at 12:45am officers were flagged down to investigate a fight at Point View, 1619 S 1st St. The applicant flagged down the officers for two females fighting in the Scrub a Dub lot. The officers could not locate the subjects. Officers walked through the establishment with the applicant to make sure there were no other problems.
- 12. On 03/03/2019 officers were monitoring bar close at Point View, 1619 S 1st St. The officers observed two subjects leaving the tavern arguing. The applicant and his security were attempting to get the subjects to leave. They did finally leave but a fight was called in on S. 2nd St that involved the same subjects. Both subjects appeared to be highly intoxicated. The subjects were cited for Disorderly Conduct. The applicant was advised to refuse service to highly intoxicated patrons to prevent future problems.
- 13. On 04/07/2019 at 4:16am officers were dispatched to St Luke's Hospital to investigate a battery complaint. The victim stated she was at Point View, 1619 S 1st St, when she saw a subject that she has had a feud with for several years. They immediately began fighting. The parties were separated by friends. The victim stated when she left the bar the suspect was waiting outside and hit her with a bottle. The victim received a laceration to her right cheek. She stated security observed the incident and escorted her to her car. She then went to the District Station to report the incident and then to the hospital for treatment.
- 14. On 04/28/2019 at 1:59am officers were flagged down for a Trouble with Subject at Point View, 1619 S 1st St. The applicant stated he was having problems with a patron inside the tavern. The subject left when approached by officers. While on scene two female patrons began to argue and the officer broke it up without further incident. There is an ongoing problem with patron's cars blocking the alley and residents garages. The applicant was cooperative and no tavern violations were observed.
- 15.On 05/10/2019 a meeting was held at District 2 regarding Point View, 1619 S 1st St. The applicant stated that since the 02/03/2019 incident any patrons parking in the Scrub a Dub lot

- needs to supply a photo ID which is scanned in the event of a problem on the lot. The applicant stated he has several fund raisers planned and it was suggested he have a plan in place to prevent any potential problems.
- 16. On 05/19/2019 at 1:45am officers were dispatched to St Luke's Hospital to investigate a battery that occurred at Point View, 1619 S 1st St. The victim stated he was in the bar and bumped into a female, who then threw her drink in his face. He responded by dumping his beer on her head. He stated an unknown male struck him in the head with an object which caused a 1" laceration to his head. The officer contacted the applicant about obtaining the video but they did not receive it at the time the report was written.
- 17. On 05/19/2019 at 4:56am officers were dispatched to an entry complaint at Point View, 1619 S 1st St. The officers cleared the building and observed damaged beer bottles and a damaged TV. They also observed two bullet holes in the exterior wall, one of which went through the wall striking the opposite wall in the bathroom. Officers located bullet casings on Lapham St. The applicant showed the officers video on his phone which showed two subjects enter through the front door, damage the liquor bottles and damage the TV by throwing a bottle at it. The key holder, Eric SUTTON, lives above the bar and he stated he heard two gun shots at about 4:30am. The officers contacted the applicant to obtain a copy of the surveillance video but have not received a copy at the time the report was written.

On MON 07-30-2018 at 2:22 am squad 2390, P.O. Miguel BENITEZ and myself, was dispatched to a report of an Officer Assist at 1619 S. 1st St. the Points View Bar where off duty police officers were detaining a female subject. Upon arrival I spoke to the bartender, identified as Kristina L. NAILEN (W/F, 06-01-86), who stated that the female came in just before 2 am and immediately began harassing other customers and trying to pick fights with them. NAILEN told the subject. later identified as Selena R. PARADA (W/F, 11-28-93) that she had to leave. NAILEN informed me that was when PARADA tried to "jump" the bar. Security and other patrons, who were off duty police officers, escorted PARADA out of the location.

I next spoke to the Agent, who was on scene at the time of the incident, identified as RAMOS-GARCIA, who stated that the female came into the location and tried to pick fights with the patrons and staff. She was escorted out of the bar and that he didn't want to prosecute. I checked the license for the bar which was a class B tavern, license# BTAVN-0205651, Exp. 08-07-2018. I informed RAMOS-GARCIA that a Licensed Premise Report would be filed regarding the incident.

approx. 11:30am, Seth M. Gron, W/M, 12-21-1984, came into the Milwaukee Police District 2 Station to file a robbery and substantial battery complaint.

According to Gron, on 09/29/2018, he and his friends came to the City and County of Milwaukee, WI., up from Illinois, to attend a concert that they found out was cancelled. Instead, Gron and his friends then went to dinner, and then decided to enter the Points View Boîte Lounge, located at 1619 S. 1st St., at approx. 11:30pm. While inside the lounge after approximately a half hour, Gron stated that he went up to the bar to reorder drinks and return to the table with his friends. Upon returning and without prior incident or verbal confrontation, Gron stated that he was attacked by approx. 13-15 H/M suspects. During the attack initially, Gron stated that he was hit in the face with a beer bottle by an unknown H/M suspect, which knocked him to the ground. Once on the ground, Gron stated that all suspects repeatedly punched and kicked him several times. During the attack, Gron stated that he observed the lounge's bouncers intervene and assist in the beat down of him. Gron stated that one of the bouncers then dragged him inside a nearby bathroom and pulled off his three chain necklaces from around his neck, which left marks around his neck in the removal. Shortly thereafter, Gron stated that he got to his feet and was able to flee the lounge, reuniting with his friends outside of the establishment.

Gron stated that both the multiple batteries and robbery was done without his consent. Gron described that the three chain necklaces were 18kt gold chains, two having religious pendants on them, were family heirlooms with an approx. value of \$5,000 total. Gron stated that after he regrouped with his friends, he and his friends headed back to the Chicagoland area. When asked why he did not call police at the time, Gron stated that he just wanted to get back home and attend to his wounds. The next morning, Gron stated that he went to seek medical attention at the Silver Cross Hospital; a hospital near his residence in Illinois. According to the medical staff at the hospital, they concluded that Gron had sustained a broken nose, two lacerations to his left eye lid requiring a butterfly strip to secure one of the lacerations, and a sliced upper left facial cheek which required medical glue to secure. Gron also explained that he had right eye orbital bruised, a bruising and swelling to the left side of his head, and marks around his neck where his chains were pulled from him. I observed Gron's injuries as he pointed them out in explanation. The injuries appeared consistent with how he explained he received the injuries. P.O. Michael Dukat took several pictures of Gron's injuries and filed a supplement report regarding.

Gron also provided me the identification information of two of the friends he was with during the time of occurrence. After gathering all necessary reporting information, I gave Gron a PV-17. Gron stated that despite him living in Illinois, he was willing to help prosecute any/all suspects involved in these crimes against him. Gron simply requested that adequate time be given to him when he needs to appear for both the District Attorney and Court, so he can arrange to take the day off from work to travel back to Milwaukee.

After gathering the information, I notified my shift commander, Lt. Mark Wroblewski, of this incident. Lt. Wroblewski instructed me to file this matter and he would assign a patrol officer to conduct a follow up investigation at the lounge when it reopened at 9pm. Gron was then sent on his way and informed that the Milwaukee Police Department would continue to keep in contact with him during the investigation for any follow up questions and instructions.

*** Interview of Adrian R. Sandoval ***

I contacted Adrian R. Sandoval, H/M, 08-16-1987 via telephone with the information that was provided to me by Gron. Sandoval was contacted by telephone because he lives in Homer Glen, IL. Once I made contact with Sandoval, he confirmed his identity and explained his version of the incident which he witnessed.

According to Sandoval, he was with Gron at the time of occurrence and observed the entire attack, minus the period when the bouncer dragged him into the bathroom and relieved him of the gold chains. Sandoval stated that he was amazed that approx. 10-15 H/M suspects attacked Gron, without previous provocation. Sandoval stated that while Gron was being attacked, he tried to intervene and mediate the attack, but was held back by the lounge bouncers. Sandoval stated that he observed one H/M use a bottle and smash Gron in the face with it. Sandoval stated that he observed a bouncer also join in on the attack and repeatedly punch Gron, and then pulled him into a nearby bathroom. Sandoval stated that once Gron was dragged into the bathroom, he started to gather his friends and exit the bar. Sandoval stated that he rejoined with Gron outside the bar and immediately left the area.

Sandoval stated that the group of friends went to another friend's house over by the Marquette University neighborhoods. After attending to Gron's injuries the best they could, Sandoval stated that they returned to Illinois and dropped off Gron at his residence.

Sandoval stated that both he and Gron were with several friends, but was very limited in knowing additional identification information. Sandoval did provide me with an additional friend/witness by the name of Adrian Moreno and provided Moreno's phone number of (630) 550-0069. Sandoval stated that they also were with his cousin Selena Lopez of Milwaukee, but could not provide contact information on her.

Sandoval informed me that prior to me contacting him, he scanned Facebook to see if he could find any of the assailants from the lounge. According to Sandoval, Points View Boîte Lounge had a Facebook page with several pictures of patrons. Sandoval identified three suspects from past pictures which were posted previously on the Facebook page. I instructed Sandoval to email me the pictures to my official Milwaukee Police Department email account. Sandoval went on to say that it appears that the suspects all belonged to some sort of "car club" according to the pictures and comments left on Facebook. One of the pictures that Sandoval sent was the suspect that he witnessed using a bottle to smash Gron in the face with, causing the laceration that needed to be glued by medical staff. Another picture Sandoval sent was that of the lounge bouncer who dragged Gron into the bathroom, who allegedly removed Gron's three 18kt gold chain necklaces forcefully from his neck. The third suspect picture that Sandoval sent was also witnessed by Sandoval beating Gron during the group attack.

I informed Sandoval to continue to search for any/all suspects he could find and send those pictures on to me for this investigation.

After hanging up with Sandoval, I attempted to contact Adrian Moreno via telephone, but only received a voicemail message. I left message with Moreno identifying me as a Milwaukee Police Officer who was investigating this crime. On 10/05/2018, I attempted to contact Moreno again, but received a voicemail

I checked the CAD Assignment log for that night and no calls for police were made for this establishment regarding this incident.

Officers contacted owner and have not been able to view video to confirm details of incident.

This report is typed by PO Oscar ESPITIA assigned to District Two, Late Power Shift, and Tavern Squad 2464.

On Sunday November 11, 2018 at approximately 2:00 AM PO MUNOZ told me Saturday morning he had a walk in complaint regarding Point View Boite located at 1619 S. 1st St. The complainant identified herself as Maria S. FARIAS (W/F, 04/21/91).

FARIAS told PO MUNOZ she was involved in a fight inside Point View Boite club but didn't wish to be a victim of any crime. FARIAS continued to state the reason she was speaking to the Police was because after the fight while she was standing in the outside patio a unknown subject pulled a hand gun and said something in the effect of "that's why I always have my gun with me". FARIAS stated she just wanted us the police to be aware due to the resent shooting at District Night club. PO MUNOZ advised FARIAS that he would pass on the information to tavern car and wrote down FARIAS information for me.

On Sunday November 11, 2018 at approximately 2:20 AM I spoke to owner of Point View Boite, Marcos A. RAMOS-GARCIA (W/M, 03/01/85), regarding the incident. RAMOS-GARCIA stated he did have a incident on Friday but no one actually hit each other, it was more of pushing and shoving. RAMOS-GARCIA stated there was never any gun inside the club. RAMOS-GARCIA stated he hired 3 Midwest Police armed security guards and 3 unarmed in house security guards. RAMOS-GARCIA stated they pad every patron male and females, check female's purses and card everyone before entering the club. RAMOS-GARCIA told me to meet him on Wednesday November 14, 2018 and he would show me the surveillance footage.

On Wednesday November 14, 2018 at approximately 8:40 PM I meet with RAMOS-GARCIA and watched the surveillance footage of the incident.

The following is what observed in the video footage.

The camera view is labeled as Men's bathroom and the date and time stamp was 11/10/18 12:48 AM. Approximately 50 people were dancing in the dance floor, a unknown, male wearing a light colored sweater dark pant, shoulder length curly hair in a ponytail stands behind a female who was identified as FARIAS and tries to dance with her. FARIAS immediately walks away from the subject and he follows her. It looks like FARIAS begins to argue with the subject, then she pushes him.

The subject then pushes her back and security separates them. FARIAS friend who was identified as Adriana throws a glass beer bottle at the subject and misses. VALENCIA then continues to attempt to fight the unknown subject till her and FARIAS get escorted to the outdoor smoking patio.

I then observe on camera labeled patio, and date and time stamp of 11/10/18 12:55 AM FARIAS and VALENCIA outside talking to a different male subject wearing a brown sweat shirt dark pant, black hair in a hair bun. I also observe 6'00" 300 lbs. wearing a black knitted cap with a the word SECURITY on it standing by FARIA, VALENCIA and the unknown male subject. They talk for approximately 3 minutes and then they are all escorted outside.

RAMOS-GARCIA stated he had both parties kick out. The male subject was asked to leave because he pushed another patron and FARIAS and VALENCIA because they threw a beer bottle. RAMOS-GARCIA

stated he asked both parties not to return.

I spoke to FARIAS via-telephone and asked her what happened. FARIAS stated she has been at Point View Boite several times and never had a incident. FARIAS stated her and her friends never get padded down for weapons. FARIAS stated on the day of the incident a unknown male attempted to dance with her. FARIAS stated she moved away from the subject but he followed her and told her if she knew who he was. She stated they got into a argument and she pushed him away and he pushed her.

FARIAS stated while standing outside in the patio a different unknown male approached her and VALENCIA and apologized to them for his brother actions. FARIAS stated she really didn't pay attention to what the subject was saying but she saw him holding a Black Hand gun. FARIAS stated the subject never made threats or pointed the gun at anyone.

May it be noted I didn't observe anyone holding a firearm on the surveillance footage.

FARIAS told me she just wanted us the police to be aware of the incident.

P.O. POVLICK and I were in full duty MPD uniform and in a marked MPD squad (squad 285) with working lights and sirens. P.O. POVLICK and I are both equipped with Axon body worn cameras.

On Sunday, February 3, 2019, at approximately 2:10 AM, we dispatched to Point View Boite bar (1619 S. 1st St) regarding shots fired heard by Squad 2342 (P.O. Eric ROBILLARD and P.O. Jason STACHOWIAK) while they were on patrol of the 1600 block of S. 1st St.

Upon arrival, P.O. STACHOWIAK and P.O. ROBILLARD observed casing on the ground and in floor board of the vehicle (after the driver door was opened by driver) Jonathan J. RODRIGUEZ (W/M, 7-20-98) was sitting in. RODRIGUEZ was in the driver seat of the vehicle and was the only occupant of the vehicle. RODRIGUEZ was arrested and conveyed to District 2 for processing. Two hand guns were recovered in the vehicle. One under the driver's seat and one on the floor board of the right rear passenger. 13.61 grams a green leafy substance that tested positive for THC was also located inside the vehicle.

During processing RODRIGUEZ stated he knew the bouncer/security that was checking identifications at the door of Point View Boite. RODRIGUEZ did not provide a name for the bouncer/security. RODRIGUEZ stated they did not ask for his identification and just checked him for weapons and let him inside the establishment today.

During a Mirandized interview of RODRIGUEZ performed by Detective Adrian HARRIS, RODRIGUEZ stated he was able to gain entry into the bar because 4 months ago he gave the bouncers \$100. RODRIGUEZ stated on that day it was Isabella URIEGAS birthday party.

Brandon R. LEWIS (B/M, 2-27-93) stated he works at Point View Boite as security. LEWIS stated he was outside the bar because it was bar close. LEWIS stated he was trying to keep 2 groups separated because they were arguing, and to keep them from fighting outside the bar. LEWIS stated one group left towards the parking lot of Scrub a Dub (1635 S. 1st St.) which is next to the bar. Patrons from the tavern use Scrub a Dub parking lot due to the car wash being closed at the time the bar is open.

LEWIS stated he heard multiple gunshot coming from the parking lot, but did not see who shot due to him being in front of the bar. LEWIS stated he made his way towards the parking lot and observed people running and screaming.

The owner/agent, Marcos A. RAMOS-GARCIA (W/M, 3-1-85), stated it was bar close. RAMOS-GARCIA stated 2 groups were arguing outside the tavern. RAMOS-GARCIA stated he was inside the tavern when he heard multiple gun shots outside the tavern. RAMOS-GARCIA stated he kept the people that were in the tavern inside for their safety. RAMOS-GARCIA stated he walked out the rear door and observed police with a subject, RODRIGUEZ, in handcuffs. RAMOS-GARCIA stated possibly the person that discharged the firearm outside the location was not a patron of the bar.

RAMOS-GARCIA stated he only has surveillance cameras inside the bar and in front of the bar. RAMOS-GARCIA stated he does not have any surveillance cameras on the side of the bar facing Scrub A Dub parking lot next to the tavern. RAMOS-GARCIA was advised to consider putting surveillance cameras on the side facing the parking lot due to his patron parking there.

The owner, RAMOS-GARCIA, and the securities of Point View Boite were cooperative during our investigation.

Point View Boite bar has a Class B Tavern License (BTAVN#0206929, Effective date 1-14-19, Expiration date 8-7-19).

Point View Boite bar has a capacity of 99.

RODRIGUEZ-TORRES (W/M, 06-11-98), exit the bar yelling at each other in an aggressive manner. I called for additional squads in case the verbal altercation turned physical. The licensee, identified as Marcos RAMOS-GARCIA (W/M, 03-01-85), was on scene and cooperative. RAMOS-GARCIA and security were assisting with attempting to get the subjects to leave. SANTIAGO and RODRIGUEZ-TORRES argued in the parking lot for approximately 15 minutes before finally getting in a vehicle and leaving the area southbound in the rear alley towards W. Lapham St.

SANTIAGO and RODRIGUEZ-TORRES were heavily intoxicated and appeared to have been over served. Both subjects refused to leave the parking lot after receiving multiple verbal commands from Officers and security guards to leave. I advised RAMOS-GARCIA that his bartenders should refuse service to highly intoxicated subjects who was cooperative.

A fight was called in by a citizen in the 1600-block of S. 2nd St. involving several patrons who were observed leaving the parking lot of the listed tavern. On Sunday, April 7th 2019, at 4:16 AM, we were dispatched to a Battery complaint at St Luke's Hospital, located in the city and county of Milwaukee, WI.

Upon arrival, we spoke to the victim, Melanie M. DeJESUS (W/F, 05/27/88), went to the District Two Station to report the incident and then went to St. Luke's Hospital to receive treatment for her injuries.

DeJESUS stated that she has a toxic relationship with the suspect, Amber M. HERNANDEZ (W/F, 09/22/89), that has lasted years because they once shared the same "baby daddy". DeJESUS stated that she hadn't seen HERNANDEZ in over a year. However, because of the "bad blood" that they've had, as soon as they saw each other today inside the Pointe View Bar, they immediately engaged in a physical altercation. Parties were separated by friends, and DeJESUS stated that when she exited the bar at 2:30 AM, she saw that HERNANDEZ was waiting for her standing on the South side of the building. DeJesus stated that HERNANDEZ was hiding her right hand behind her, and thought it was going to be "round two" of fighting when HERNANDEZ lifted a glass bottle and hit DeJESUS on the upper right side of her head near her forehead. The bottle broke with the impact, causing several cuts on DeJESUS' face. I observed a bump on the right side of DeJESUS' forehead near the hairline that was turning purple along with several small cuts that looked like scratches near the area of the bump on the right side of DeJESUS' forehead. I also observed a 3-4 inch laceration on DeJESUS' right cheek that began near the right eye and ended approximately 1/2 inch away from the corner of the mouth.

DeJESUS stated that the business' security were on scene and observed the incident happen. According to DeJESUS, as soon as she was injured, Pointe View Security escorted her to her vehicle. DeJESUS did not see in which direction HERNANDEZ went. DeJESUS went home and called a friend, who later brought her to District Two Station to file a complaint.

DeJESUS was admitted at 3:45 AM to Aurora St. Luke's Hospital and treated by Dr. HIBERT. DeJESUS received 10 stitches on her laceration.


