Knowledge, skills and abilities necessary to perform the duties of a painter as described above under essential functions. Qualifications as a journeyman painter or have four years equivalent experience.

Must be able to work at heights in excess of 50 ft. Ability to climb and work from scaffolding, above and below grade. Must be able to work in confined areas and areas that are difficult to acsess

Must be able to follow oral and written directions. iii. <u>Certifications, Licenses, Registrations:</u>
Must have a valid State of Wisconsin driver's license.

iv. Other Requirements:

Should be in good physical condition; not allergic to paint chemicals and fumes. Should be industrious, careful, reliable and able to get along with fellow workers. Must be diplomatic when dealing with City and outside agencies and the general public.

13. PHYSICAL AND ENVIRONMENTAL DEMANDS: TOOLS AND EQUIPMENT USED

Pulling: Using upper extremities to exert force in order to draw, drag, haul or tug objects in a sustained motion.
Lifting: Raising objects from a lower to a higher position or moving objects horizontally from position-to-position. Check only if it occurs to a considerable degree and requires substantial use of the upper extremities and back muscles.
Fingering: Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm, as in handling.
Grasping: Applying pressure to an object with fingers and palm.
Feeling: Perceiving attributes of objects such as size, shape, temperature or texture by touching with the skin, particularly that of the fingertips.
Talking: Expressing or exchanging ideas by means of the spoken word. Those activities which demand detailed or important instructions spoken to other workers accurately, loudly or quickly.
Hearing: Perceiving the nature of sounds with no less than a 40 db loss. Ability to receive oral communication and make fine discriminations in sound.
Repetitive Motions: Substantial movements (motions) of the wrist, hands, and/or fingers.
Driving: Minimum standards required by State Law (including license).
