There is a possibility that your application may be denied for one or more committee regarding the application shall be based on evidence presented at the hearing. CO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Partnership applicants must appear by a partner listed on the application or by an attorney. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. Dear License Division,


I am writing to register my opposition to the liquor license application for Quick Stop, located at 2434 W. National Avenue.

neighbors, businesses, and community partners along National Avenue, I am deeply concerned about the oversaturation of alcohol availability on this corridor—particularly cheap single-serve sales, which have well-documented negative impacts on public safety and public health. Our neighborhood already experiences significant challenges related to loitering, public intoxication, and nuisance activity. Adding another outlet selling alcohol would only exacerbate these issues.

While I support responsible local business ownership, I cannot support a license that contributes to conditions proven to negatively impact the well-being of families, youth, and workers who live and travel through this area every day.

This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 07/10/22 at 3:05pm, Milwaukee Police were dispatched to 2423 W. National Avenue for a shoplifter complaint. A subject took items and left the store. Officers could not locate the subject.
- 2. On 08/28/22 at 5:21pm, Milwaukee Police were dispatched to 2434 W. National Avenue for a theft from person complaint. Investigation revealed that a regular panhandler entered the establishment and took a phone from one of its customers. The incident was captured on video surveillance.
- 3. On 08/31/22 at 4:37pm, Milwaukee Police were dispatched to 2434 W. National Avenue for a battery complaint. Investigation revealed that a subject entered the establishment and tried to purchase items but his credit card was declined. When the clerk and subject began to argue and fight over the items, security came over and knocked over the subject. The subject and security engaged in a physical fight, the clerk grabbed a metal pipe and struck the subject several times. Security then grabbed the pipe and struck the subject in the head several times. The subject fled the store and is captured a short time later by the police. The clerk was ordered into the District Attorney's Office and the Security Guard was arrested. The District Attorney's Office declined to issue charges.

- 4. On 01/04/23 at 6:12pm, Milwaukee Police were dispatched to 2434 W. National Avenue for a fight complaint. Three subjects were fighting at the location and broke a door. The subjects fled before police arrival.
- 5. On 03/05/23 at 4:12pm, Milwaukee Police were dispatched to 2434 W. National Avenue for a battery complaint. Three subjects were fighting at the location and threw coffee in the window. The subject fled before police arrival.

#### PREVIOUS PREMISE

The following items pertain to the licensee and business located at 2434 W. National Ave., Kwik Stop Pantry.

This report is written by Police Officer (P.O.) Garrett BONG, assigned to Squad 2230, at District Two, on Early Shift.

On Friday January 24, 2025 at 8:09 P.M. my partner, P.O. Stanislav RABINOVICH (passenger), and I (driver), were dispatched to the location of 2424 W. National Ave (Kwik Stop). Which is located in the City and County of Milwaukee, WI regarding a property damage investigation.

Officers were assigned to squad 2230, car #203, which is a marked Milwaukee Police Department Ford Explorer, equipped with red and blue emergency LED lights, audible siren and squad camera. My partner and I were wearing Milwaukee Police department issued uniforms with our badges and name plates affixed to our outer most garments. My partner and I both had body worn cameras that did capture evidence regarding this case.

#### Observations/Scene

The scene of the incident happened at the front of the store, outside near the west corner. Give a description of the scene or location of the incident. The suspect a (W/M, 5'10, medium build, wearing a black jacket, dark jeans) approached the front of the store from across the street. This area across the street is a McDonald's parking lot located at the address of 2520 W. National Ave.

The listed suspect walks up to the front of the store and proceeds to throw a metal object through the front glass partition of the store. This causing the glass pane to completely shatter. This incident occurred at 5:28 P.M., but I and Officer RABINOVICH were not dispatched for several hours due to the priority of the call. The glass door was observed to already be boarded up with plywood when Officers were on

scene, and the store employees had already cleared/disposed of all the shattered glass.

#### Interview of Victim

The owner of the store was on scene and was identified with a WI driver's license as Jaiswal PUNIT (A/M 12-06-77) stated the incident was captured on video surveillance cameras. Officers reviewed the video surveillance cameras but due to the quality did not download what it had captured. PUNIT stated the glass door will cost approximately \$1,500 U.S. Dollars to replace and if the suspect is located, he will prosecute all charges.

PUNIT has EIRE insurance but stated he would not be filing a claim.

PV-17 issued to PUNIT.

#### VIDEO SURVEILLANCE

Officers reviewed the video surveillance which started at 5:27 P.M. and showed the above listed suspect walking toward the KWIK STOP form the west. The subject is observed to have a metal object in his right hand and as he approaches the business, he throws the object through the glass door shattering it completely. The suspect then walks back westbound toward the McDonalds fleeing the area. The total time of the incident starts at 5:27 PM and ends at 5:29PM with the suspect walking away.

#### **CANVAS**

Officers attempted to retrieve video surveillance of the McDonalds parking lot but due to where the suspect was the exterior cameras did not capture the suspect.

Upon our arrival I observed two Hispanic males standing near the front of the business. These males stated they were security/stockers working at the business.

I spoke to the caller; Juan M. TREJO GONZALEZ called from 414-384-8771. They stated who stated there was a subject standing outside of the store trying to sell drugs. According to the call, the subject was asking customers if they wanted to buy drugs before they entered the store. The suspect was described as a 12-year-old, black male, black hooded sweatshirt, and black pants. TREJO GONZALEZ stated this same subject was at the store a couple of days prior, where he caused a disturbance and was told he was not welcome on the premise. The subject then ran westbound on W. National Av.

The business was cooperative with the investigation.

I reviewed video surveillance footage. The footage showed a black male wearing a black hooded sweatshirt with black pants standing near the front door of the business before running westbound out of the frame.

While on scene, I observed the licenses posted and they were up to date.

During my investigation for Trouble with Subject/Drug Dealing I did not observe any violations in the licensed premise.
