This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/08/2021 at 12:00pm officers were dispatched to an Armed Robbery at Fox River gas station, 9025 W. Appleton Av. The caller stated she was at the gas station at 10:45am pumping gas when she was approached by a subject to purchase marijuana. She made arrangements to meet the subject back at the gas station to make the exchange. When she arrived back at the station she got into the subjects auto. As she attempted to leave his auto, the subject grabbed her backpack and told her to leave it or die. The officers recovered video which the vehicle in the lot but not the interior of the auto.

2. On 03/17/24 at 10:41am, Milwaukee Police were dispatched to St. Joseph's Hospital for a shooting compliant which occurred at 9025 W. Appleton Avenue. Investigation revealed that the victim was at the filling station when the suspect made a few comments to her. When her friend told the suspect she was "taken", the suspect then shot at them multiple times as she was driving out of the parking lot. The victim was shot in the right rear shoulder. The employee at the station said he knew there was a shooting but didn't call police because he had a store full of customers. The police interviewed the applicant over the phone who refused to provide his address and refused to come to the location to show police the surveillance footage of the incident. While checking for the licenses of the filling station, police found them to be affixed to a board 7-10 feet off the ground and could not be read or reviewed.

3. On 03/28/24 at 7:05am, Milwaukee Police were dispatched to 9025 W. Appleton Avenue for a welfare of citizen complaint. Investigation revealed that an employee came to work and found a vehicle in the parking lot with a subject inside. When the employee could not get the attention of the occupant, he called police. Milwaukee Fire Department tried to revive the subject but he died and was transported to the Medical Examiner's Office.

## Narrative (1)

### LICENSED PREMISE REPORT

This report is written by P.O. Jovan PETKOVICH assigned to District 7, Day Shift. On 03/17/24 at 10:41 A.M., squad 7141 P.O. Chad STILES and P.O. Margaret SWEENEY, were dispatched to 5000 W. Chambers St., St. Joseph's Hospital, to investigate a shooting. Jacquesha L. BELL, B/F, 07/14/93, had been dropped off at the hospital for a gunshot wound to her shoulder. When P.O. STILES and P.O. SWEENEY arrived and spoke with BELL, she stated that this incident occurred at 9025 W. Appleton Ave., the Fox River Mart gas station. At 10:49 A.M., my partner P.O. Vince ANDRYSCZYK, and I were dispatched to that location to check for a scene.

Upon arriving at 11:06 A.M., P.O. ANDRYSCZYK and I located 8 spent 9mm casings in the gas station parking lot which proves that this crime occurred here. It should be noted that no calls to the police were made in order to report this incident. When I went into the gas station, I spoke with Adama K. DIALLO, B/M, 10/24/69. DIALLO stated that he has worked at this gas station for the past 8 or 9 years and he is the current manager. He was also the only person working at the time that this incident occurred. DIALLO told me that he knew that a shooting happened in the parking lot. When I asked him why he didn't call the police to report this incident he said that he "had a store full of customers."

Upon asking to see all of the licenses that were issued to the gas station by the City, DIALLO pointed to a cork board that was permanently affixed above the office door. The board was 7 to 10 feet off of the ground and had several City licenses attached to it. It should be noted that the board was so high that none of the licenses could be read or reviewed in order to check for license type and dates of expiration. When I attempted to remove the board from the wall so I could review the licenses, DIALLO said, "Don't do that." It should be noted that the board was so firmly affixed to the wall that it could not be removed. When I asked him how I could review the licenses he said, "Get a ladder."

When I asked DIALLO if we could view the store surveillance video, he said that he would have to call the owner because he does not know how to operate the system. DIALLO then called the owner at which time I spoke with him over the phone. The owner identified himself as Atiq U. REHMAN, A/M, 08/04/74. When I asked REHMAN for his address he told me to use the gas station as his home address. I then informed REHMAN that he does not live at the gas station and I needed his home address due to the Reckless Injury Shooting Investigation that I was conducting. REHMAN then told me, "You must be new." When I asked REHMAN if he could come to the gas station in order to play the store surveillance video that captured the shooting which occurred on his property he told me, "Find someone in the department to do it." I then informed REHMAN that I would be filing a Licensed Premise Report which

would indicate how he failed to cooperate with this investigation.

The victim made the following initial statement: She stated around 10:30AM, she was pumping gas into her 2007 Ford Taurus 4 door at Fox River Gas Station at 9025 W Appleton Ave, when a B/M, subject in his 30's with short dreads, 602/180, approached her. She stated that the male stated "Hey shorty" while she was walking out of the gas station, and he was walking in. After she was done pumping gas, he said something more to her, but it included calling her a "bitch". Victim stated her friend, was the front seat passenger in her car, and her 4 children were in the vehicle. She stated that her friend told the suspect to stop hitting on her and that she is "taken". The B/M then shot at them multiple times as she was driving out of the parking lot of the Fox River Gas Station and the rear driver's side rear window and the back window were shot out. She stated she left her vehicle in the area of W Appleton and Courtland or Fairmount area where it stopped working on her. Victim stated she was shot in the right rear shoulder.

On Thursday, March 28, 2024, at 7:05 am, while in full duty uniform with axon body camera activated and while in patrol car 592, I was dispatched to a Welfare Citizen at the address of 9025 W. Appleton Av, which is located in the County and City of Milwaukee, Wisconsin.

This establishment was labeled as FOX RIVER MART AND FUEL.

Upon my arrival MFD E14 was on scene performing CPR to an unknown b/m laying supine on the ground. MFD Lt T. RIVERA stated that they arrived on scene and had taken the unknown b/m who was unresponsive and not breathing out of the vehicle with a WI plate of AVH-4287 and performed CPR. The unknown subject died and was transported to the medical examiner's office.

I spoke to the caller/ witness identified as Adama K DIALLO (b/m 10-24-69), who stated that he arrived around to work around 5:00 am. He noticed that vehicle that was parked. DIALLO stated that he then went to the window and then tried to get the attention of the driver. DIALLO stated that he then called 911

DIALLO stated that there are cameras that are working but was unable to obtain any surveillance. DIALLO stated that the owner only has access to the cameras. DIALLO is the manager on site. I did not review video surveillance footage. DIALLO stated that I would be able to come back to the gas station to recover video.

This business had 0 security officers on scene.

While on scene, I observed the licenses posted and they were up to date. During my investigation for a welfare check, I did not observe any violations in the licensed premise.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.


