The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/15/21 at 5:30pm, Milwaukee Police were dispatched to 8334 W. Appleton Ave., for a Shots Fired. On arrival officers recovered a spent casing in the parking lot of the establishment. The agent was on scene and cooperative, allowing officers to view video surveillance.

2. On 10/31/22 at 11:34pm, Milwaukee Police were dispatched to 8334 W. Appleton Ave., for a Shooting complaint. Officers arrived on scene and it was determined that the non-fatal shooting occurred in the parking lot of the business. The business was cooperative with police during the investigation and provided video of the incident.
3. On 11/03/22 at 1:35am, Milwaukee Police were dispatched to 8334 W. Appleton Ave., for a Shooting complaint. Officers reviewed the video footage of the business and it was determined the non-fatal shooting occurred in the parking lot of the business. The agent and staff were cooperative with police during the investigation.
4. On 12/20/22, Milwaukee Police were dispatched to 8334 W. Appleton Ave., for a robbery complaint. Officers spoke with the employee who stated that 2 subjects were disruptive in the store, and took items without paying for them. One of the subjects paid for \$50 dollars of gas

but only pumped \$40 dollars worth of gas. The subject then came in the store and demanded a refund of \$45 dollars, the employee stated that they can't do that. The subject then called in another subject and both subjects then left the location with unpurchased items. The employee stated that he only wanted information from the officers regarding obtaining a restraining order.

5. On 03/01/23 at 2:37pm, Milwaukee Police officers checked the CAD System (Computer Aided Dispatched) of the business 8334 W. Appleton Av. The officer was reviewing the CAD because there had been numerous police calls for service at the premise. The dates checked were from 11/01/22 to the date of 03/01/23. The assignments are listed and brief explanation are as follows:

11/02/22: A trouble with subject complaint. Subjects were arguing and trying to fight at location. The caller stated that he will call the police and the subjects left the location.

12/20/22: Robbery complaint

01/18/23: Overdose complaint. The subject was near the gas pumps and required medical attention. MFD arrived and administered narcan to the subject.

2/08/23: Threat complaint. Caller stated that the subject was clenching his fists tight and asking customers for change.

02/25/23: Fight complaint. Caller stated that a fight is in the store and one of the subject was not breathing.

6. On 05/12/23 Milwaukee Police were dispatched to 8334 W. Appleton Ave., for a battery complaint. The caller/employee stated that an unknown suspect struck him in the face causing him pain. The employee received medical attention at the business. The suspect was located and cited regarding the incident. The business was cooperative with officers during the investigation.

On Tuesday, December 20, 2022, P.O. Lamar DENTON and I, Squad 7441 responded to Discount Gas Station, located at the address of 8334 W Appleton Ave, which is located within the City and County of Milwaukee.

Upon arrival to the gas station, I made contact with Sunny C ARIMNUTA (B/M 5-23-1969)

ARIMNUTA explained to me that on December 20, 2022, A male subject paid for approximately \$50 in gas. ARIMUNTA stated that this subject put approximately just over \$40 in gas into his vehicle, and then demanded a refund of approximately \$45. ARIMNUTA stated that he told the customer that he could not do this, and he became irate. ARIMNUTA stated that the customer called a female subject to the location and they became very disruptive and took approximately \$25 in frozen food without paying. ARIMNUTA stated that other customers paid for the frozen food.

ARIMNUTA stated that he only wanted a Community Contact Card and restraining order information.

On Wednesday, March 1st, 2023, at approximately 2:37 PM, I ran a CAD Search (Computer Aided Dispatch) from November 1st, 2022, till today's date of the following address: 8334 W Appleton Ave, Gas Station, which is in the City and County of Milwaukee WI, in regard to the many calls for service addressed to this location. The following are some of the calls for service we have in the system for the above listed address.

11-02-2022: Trouble with subject - **CAD 223060172** - CALLER IS REQUIRING A SQUAD, STATES 2 PATRONS ARE TRYING TO FIGHT AT LOCATION. TC HEARD SUBJECTS ARE ARGUING. CALLER STATES 2 FEMALES ARE GOING FIGHT AT LOCATION, CAN HEAR ARGUING IN BACKGROUND, STATES A MALE IS TRYING TO PUT ONE OF THE FEMALES IN HIS CAR. CALLER IS REQUIRING TO CANCEL STATES HE TOLD THE SUBJECTS THAT HE CALLED THE POLICE AND THEY ALL LEFT.

12-20-2022: Robbery - **CAD 223541389 - IR#223540120** - Officers responded for a Robbery complaint. Report was made and a License Premise report was filed under **22-LP-1048**.

01-18-2023: Overdose - **CAD 230181406 - IR#230180152** - Officers responded for an overdose. Arriving on scene, they observed later identified subject Chad T. GOLIMOWSKI (w/m 04-17-74) lying on the ground of the Southwest pump. GOLIMOWSKI at the time was unconscious and barely breathing who was then being treated by the Milwaukee Fire Department for a suspected overdose. M.F.D. stated that they had administered 1 dosage of Narcan at the time of my arrival. While GOLIMOWSKI was being medically treated by M.F.D., I spoke with caller Keyon J. NELSON (m/b 10-23-92) who had remained on scene. NELSON stated that at approximately 6:52PM he had arrived near the Southwest cluster of gas pumps and observed GOLIMOWSKI lying near them, barely conscious. NELSON stated that he was not aware of what occurred with GOLIMOWSKI but believed he medical attention and called emergency services.

M.F.D. administered a total of 3 Narcan, GOLIMOWSKI then became alert and awake. After standing up, GOLIMOWSKI was observed with a laceration to the back of his head. M.F.D. treated this injury on scene and attempted to transport GOLIMOWSKI to the nearest hospital. GOLIMOWSKI denied. After a few more questions, GOLIMOSKI walked away during the interview.

Officers were able to view video surveillance regarding the incident, at the location of the gas station.

02-08-2023: Threat - **CAD 230390024** - CALLER STATES THERE IS A MALE SUBJECT MAKING THREATS TO PHYSICALLY HARM PEOPLE, BUT NOTHING PHYSICAL HAS OCCURRED. 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
