

180074 A substitute ordinance to further amend the 2018 rates of pay of offices and positions in the City Service.

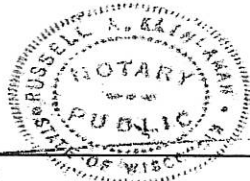
