This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 10/12/23 at 10:01pm, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for a shot spotter complaint. Officer located six spent casing near the gas pumps of the business. The business was cooperative giving account of the two suspects shooting at each other from vehicles. As well as providing video for the investigation.
- 2. On 10/30/23 at 5:44am, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for a trouble with subject. The caller stated that she paid for a 100 dollars with of gas and the clerk wont refund. The police spoke with the clerk who stated that the subject's card was declined at the gas pump, and it was an issue with the credit card company. The original call/complainant was no longer on scene.
- 3. On 12/02/23 at 1:15pm, Milwaukee Police will working in conjunction with WINS Youth Tobacco Prevention conducted a compliance check at 4302 W. Capitol Dr. The 16 year old buyer was able purchase a tobacco product from the location. The officer made contact with the clerk who stated he did not recall the sale. The officer reviewed video which showed the transaction. The agent was cited for the incident.

- 4. On 12/05/23 at 12:33am, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for a battery complaint. The caller stated that she was battered by the security guard at the location. Officers reviewed the video and discovered the complaint to be baseless.
- 5. On 12/09/23 at 5:58am, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for a trouble with a subject complaint. Officers spoke with the employee who stated that a subject was in the area loitering refusing to leave. The subject left prior to police arrival.
- 6. On 12/10/23 at 11:20pm, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for a robbery complaint. Officers spoke with the security at the location, who stated that he heard a vehicle accident outside the location. The security guard then observe one of the drivers of the accident exit his vehicle. The suspect forcible took a vehicle that was parked by a gas pump. The suspect removed the driver from his vehicle, then drove off the property in the stolen auto. The business was cooperative with the investigation providing video.
- 7. On 01/09/24 at 10:00pm, Milwaukee Police conducted a traffic stop on a vehicle at the location of 4302 W. Capitol Dr. Officers observed the vehicle drive through the gas station in attempt to avoid the police squad. Investigation revealed that the vehicle was stolen and both the driver and passenger were arrested. A search of the vehicle revealed items that tested positive as being illegal narcotics, and other items associated for drug distribution. The business was cooperative with the investigation.
- 8. On 01/15/24 Milwaukee Police were dispatched to 4302 W. Capitol Dr., for a damage to property complaint. The caller stated that the business ATM did not properly disperse the correct funds requested and clerk did not help. Officers spoke with the clerk who advised the caller to call the number on the ATM machine. The caller became upset and knocked over items. Officers reviewed the video of the incident. The caller was advised to call the provided number and as escorted off the premise.
- 9. On 01/28/24 at 4:24am, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for a shot spotter complaint. Officers did not locate any casings, victims, or damage form gun fire at the location.
- 10. On 02/12/24 at 6:19am, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for property damage complaint. Officers located a damaged auto at the property with the driver in her vehicle. Officers reviewed video and observed the suspect throwing a brick and garbage can at the parked vehicle. The suspect then walks form the location an boards a city bus away from the location.
- 11. On 03/12/24 at 7:04am, Milwaukee Police were dispatched to 4302 W. Capitol Dr., for trouble with subject complaint. Officers spoke with the employee who asked for a subject to be removed from the location. The subject was located sleeping on a pallet of rock salt outside the location.

The following items are incident or calls for police service at 4302 W. Capitol

- 12. On 07/10/24 at 1230am., Milwaukee Police were dispatched to assist another squad with an investigation regarding an unoccupied vehicle that had fled from an earlier traffic stop. The business was cooperative with allowing officers to view video surveillance, which led to locating the fleeing driver of the vehicle.
- 13. On 07/20/24 at 1027am., Milwaukee Police were dispatched to conduct follow up regarding an Officer Involved Shooting that occurred on 07/17/24 at 1028pm. On the date of the shooting, Milwaukee Police responded to that location regarding a wanted subject who was in the business. Upon seeing the officers, the suspect pointed their firearm at police and began to fire, resulting in officers exchanging gunfire with the suspect. The business called back to advise officers they located additional evidence regarding that incident.
- 14. On 08/09/24 at 107am., Milwaukee Police were dispatched to a Spot Shotter. On arrival officer did not locate any casings, and the employees stated they did not hear anything
- 15. On 08/31/24 at 235pm., Milwaukee Police were dispatched to a Sexual Assault. Investigation revealed a suspect slapped the victim on the butt as they were exiting the store. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

Two suspects approached the victim with a dog while they were pumping gas, pushed the victim and took their car. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

Investigation revealed the caller recovered their stolen auto in the lot, however, left the location and went to the District to have vehicle processed and cancelled. Officers did not make contact with any employees.

Officers were advised of an earlier event in which a suspect pointed a firearm at employees and they currently had them locked in the store. Officers viewed video surveillance of the incident, confirmed it was the suspect and took them into custody.
- 20. On 03/04/25 at 200am., Milwaukee Police were dispatched to a Subject with Weapon. Investigation revealed a suspect entered and was asking for free food. When the cashier denied the request, the subject broke the main entry door and fled the scene. The business was cooperative.
- 21. On 03/14/25 at 424am., Milwaukee Police took a walk-in Stolen auto that occurred at 4302 W. Capitol Dr. Investigation revealed the victim placed their keys on the counter while they

shopped for items. When they returned the keys were gone as well as the vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance, however, it did not capture the incident.

- 22. On 03/21/25 at 910pm., Milwaukee Police were dispatched to a Battery. The business called the police due to a subject assaulting another subject in the store. Both subjects were gone and the business was cooperative, allowing officers to view video surveillance of the incident.
- 23. On 03/29/25 at 5:37A.M., Milwaukee Police were dispatched to a Theft. Prior to arrival the caller stated their wallet fell out of their pocket at the business and someone took it. Officers were unable to locate the caller. An employee stated they did not observe any theft.

Investigation revealed a suspect was observed on video surveillance inside the store with a firearm in their waistband. Investigation revealed a suspect utilized a rock to scratch an exterior window and the business wanted the subject advised they were no longer welcome. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 26. On 04/25/25 at 341am., Milwaukee Police were dispatched to a Threat. Officers were advised a subject was begging customers for money and threatening to damage the employee's vehicle.

On Saturday, August 31, 2024 at 3:03pm, I was dispatched to 4302 W. Capitol Dr (Citgo) regarding a sexual assault complaint.

I spoke to the caller, Nelsy E. VALDEZ-TROCHEZ, w/f, 06-18-03, who was seated in her vehicle near gas pump #2. VALDEZ stated on 08-31-24 at approximately 2:30pm, she was inside the convenience store and was exiting the business when a B/M subject intentionally slapped her on her buttocks over her clothing with his open right hand. These actions were done without consent.

I spoke to licensed premise employee, Amandeep SINGH, A/M 07-16-93. SINGH was able to show me the video surveillance of the incident. I reviewed video surveillance footage. The footage depicts the B/M subject standing at the entry door to the gas station for several minutes prior to VALDEZs' arrival. Video depicts VALDEZ entering the store on 08-31-24 at 2:35pm, walking up to the counter to pay for her items and then walk past the B/M subject holding the door open for her. Video surveillance depicts the B/M subject slap the victim's buttocks with his open hand, over her clothing and smile at her after the incident. VALDEZ then turns around at the subject and leaves the store.

The business was cooperative with the investigation.

The business had 0 security officers on scene.

Casings were found where the subject ran to when the gunshots were heard. The suspect then has trouble getting into the suspect vehicle and finally enters the vehicle, which flees south on N 44th St from W Capitol Dr.
