Dear Mr. Morics:

We are in receipt of your letter dated, December 18, 2006, regarding the issue of the 2006 tax levy for the Milwaukee Public Schools. We are writing to provide clarification as to why our December 15, 2006 letter was addressed to you rather than to the Office of the City Clerk.

On both December 14 and 15, Ms. Michelle Nate had met with, and had several conversations with staff members in the City, including you, Mr. Leonhardt, and Ms. Reavey. Specifically, Ms. Nate had a conversation with Mr. Leonhardt, City Clerk, with regard to the letter we wrote. It was upon his recommendation that the letter was addressed to you.

The purpose of the December 15, 2006 letter was not to file claim but rather to affirm in writing our previously expressed desire to resolve this matter, with our request to be informed of the City's planned resolution.

Should the Milwaukee Public Schools decide to file claim with the City, we will ensure that the requisite procedure will be followed.
