Dear Mr. Dralle:

We have received your claim for the amount of \$492.75 in relation to the vehicle damage you sustained on October 24, 2015 near North 77th Street between West Burleigh Street and West Auer Avenue.

The Department of Public Works reports the sewer maintenance division did not receive a complaint on October 24, 2015 regarding a missing manhole lid on the 3100 block of North 77th Street. The area was inspected after this claim was received and there was no evidence of loose or missing manhole lids.

The damage to your vehicle was not the result of any negligence of the City of Milwaukee and therefore the City is not legally liable for your damage. Accordingly, we are denying your claim.





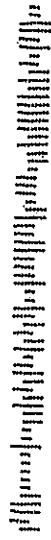
