My Contractor's Perspectives

My contractor wanted me to share that the order from the City of Milwaukee inspector was to repair the porch, **not** to replace it. He said he separated the debris from the wood that he was going to re-use to repair the porch. He had already disposed of the debris and left the good woods to re-use because the order was to repair the porch, not to replace it. Apparently, the City Contractor came and removed the woods.

My Contractor also said the wood that was inside the property/yard should not have been removed. He feels it's like someone trespassing into another person's property. He said the city had already issued an order to repair the porch and gave a time line to complete the work. The order had not expired by the time the wood was removed.

My Contractor said he talked to the inspector and he told him that the fine was for a clean up order. He reasoned that if it were a clean up order, why were some few black bags still left at the property as shown in the pictures.

Lastly my Contractor said he was updating the City inspector Mr. Tim all along. He told him he was waiting to pull permit as he ordered and the cold weather had not allowed him to start work or do anything

From the Owner Ms. Obiora's Perspectives

I am requesting the fine of \$1076.63 be rescinded. There was a police chase, and the person they were chasing ran into my property, causing the damage to the porch. The whole porch of approx. 10 X 15 ft size was damaged/collapsed. The porch will cost a few thousands to replace and to be specific \$4,500.00 I should be compensated for the damage. I am not able to pay the cost of replacing the porch and the fine.

Another point I want to make is that the City normally does not come out to write orders while the temperatures are at zero or below. I will expect an extension until the weather is conducive for outdoor repairs.

There was a notice letter written on 1/10/25 that was sent by the dept of Neighborhood services, notifying me of the clean up order. I was out of the Country from Dec 29th-Jan 20st 2025. I saw the letter on Jan 21st upon my return. I attached my flight itinerary to prove that.

Please I am requesting that the fine be rescinded.
