Dear Mr. Leonhardt:

As indicated by the attached letter from Ms. Julie Penman, there is interest in renaming East Kane Place between North Water Street and North Humboldt Avenue to North Water Street. You are requested to consider this name change under the guidelines outlined in Chapter 113 of the Milwaukee Code of Ordinances.

There are presently 14 properties that abut this segment of East Kane Place; 10 properties are owned by New Land Enterprises, 1 property is a City Sanitation Yard and the remaining 3 are residential properties. New Land Enterprises is requesting this name change because they are currently constructing a condominium complex along the south side of the street where North Water Street meets East Kane Place and addressing the units becomes confusing with 2 different streets abutting the building.
