This office is in receipt of your claim in the amount of \$3,499.00, relating to damage sustained to your vehicle on March 17, 2004 when you collided with a City fuel truck on South 13th Street and West Canal Street.

Our investigation reveals the City fuel truck was traveling eastbound on West Canal Street and you turned left from a service road and struck the rear portion of said truck. The City truck had the right-of-way; and you struck the truck. The primary liability for this accident rests with you, as such, the City cannot accept liability. Accordingly, we are denying your claim.
