This report is written by Police Officer Xavier Benitez , assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/07/2021 officers were dispatched to a Shot Spotter call at Gas N. Go, 1909 W. Hopkins St. The officers located a victim, who stated he was punched to the face several times and hit in the head with a pistol. The officers spoke with the clerk, who stated he heard two pops and saw someone running. The officers watched video surveillance, which did capture the incident. The video showed the suspect hit the victim and run off, pulling a gun and shooting at the victim two times. The victim was not hit by the shots fired.
2. On 03/22/2021 officers conducted a license premise check at Gas N. Go, 1909 W. Hopkins St. The officers spoke with the applicant regarding the Standing Complaint Form Program. The applicant did agree to participate in the program and signed the form.
3. On 04/12/2021 at 9:09pm officers conducted a license premise check at Singh Gas & Food), 1909 W. Hopkins St. The clerk was cooperative and provided all requested licenses.

4. On 02/17/23 Milwaukee Police were dispatched to 1909 W. Hopkins St, for a violation of restraining order complaint. Officers spoke with the caller/manager who stated that the business has a valid restraining order (R.O.) against a known subject. The subject came to the location and stood in the business parking but was now no longer on scene. The subject left prior to police arrival. Officers spoke with employee at the register who stated that the subject

remained outside for approximately 27 minutes. Officers verified that the R. O. was valid and requested a copy of the video of the incident, from the business. Officers checked the area for the suspect.

5. On 03/03/23 Milwaukee Police were dispatched to 1909 W. Hopkins St, for a violation of restraining order (R.O.) complaint. Officer spoke to the employee who stated that a known subject violated the R.O. the business has in place. The employee stated that the subject did come into the gas station and was told to leave. The subject eventually left and was observed walking west bound from the business. The business was cooperative with officers and allowed access of the video footage. Officers observed the subject on the video being on the premise and bothering patrons. Officers confirmed the R.O. was valid and checked the area for the subject.
6. 04/09/23 at 7:21pm, Milwaukee Police were dispatched to 1909 W. Hopkins St, for a fight complaint. Officers spoke to the agent who stated that the two subjects a mother and daughter have been arguing loudly for the past 30 minutes. The agent attempted to stop the subjects but they became more aggressive. Officers are familiar with the two subjects and were able to diffuse the argument. The subjects were then made to vacant the premise. The business was cooperative with the incident.
7. On 08/08/23 at 1:31a.m., Milwaukee Police were dispatched to 1909 W. Hopkins for a Subject with Gun. On arrival the officers observed a subject matching the description given by dispatch. After a short foot pursuit, the subject was taken into custody, however, no firearm was recovered and it was later determined this was not the subject listed in the CAD comments.
8. On 08/12/23 at 12:51a.m, Milwaukee Police were dispatched to 1909 W. Hopkins St., for a Shooting. Investigation revealed a subject was walking to his residence when they heard several gunshots and ran down the alley. The incident did not take place at the gas station; however, the employee did call the police for the victim.

This report is written by PO Tonya BRICE, assigned to District 5, Early Shift.

On Friday, February 17th, 2023, Squad 5241 (PO Brent SLUKA and PO Tonya BRICE) was dispatched to the address of 1909 W Hopkins St, which is located in the City and County of Milwaukee, for a violation of restraining order complaint.

### INITIAL INVESTIGATION

Upon our arrival, squad 5241 spoke to the caller, later identified as Hardip S GILL (M/W, 03/09/1995) who stated he is a manager for Singh Gas (GAS N GO). GILL stated there is a Restraining Order against Terrance G LOUIS (M/B, 01/09/1989).

GILL was spoken to over the phone, and GILL stated that LOUIS was seen on video surveillance at 9:25 pm standing in front of the address of 1909 W Hopkins.

GILL stated that he called police at 9:52 pm, and he was standing in front of the gas station for approximately 27 minutes.

GILL gave the following description of LOUIS:

B/M wearing a black leather jacket, dark pants, a checkered sweater, black hat with white shoes

Prior to police arrival, LOUIS left the scene.

Squad 5241 spoke with the current working employee, identified as Amarjut Singh SANDHU (W/M 04/11/1967). SANDHU stated that he did observe LOUIS on scene prior to police arrival but does not know what time LOUIS arrived on scene. SANDHU stated that LOUIS will come into the gas station, but he did not do that tonight, and he just stood outside the front door.

A record check revealed there was a Restraining Order on File under Milwaukee Court Case #2022CV000553 and LOUIS was served on 09-08-2022. The Restraining Order stated that LOUIS is to avoid contact with Gas N Go and not to be within 100 feet of the premises; LOUIS violated the court order by being on the premise.

On the listed date, PO TERRELL and I were dispatched to the address 1909 W Hopkins St (Gas N Go Enterprises INC) a gas station, for a Violation of Restraining Order Complaint.

Upon our arrival at the listed address, PO TERRELL and I met with the clerk of the gas station, identified as **Amarjit S SANDHU (u/m, 4/11/67)** who immediately provided PO TERRELL with Harassment Injunction paperwork. He stated a male subject, later identified as **Terrence G LOUIS (b/m, 1/9/89)**, who is to remain away from the gas station had arrived on scene bothering customers and "begging".

PO TERRELL and I then checked WI records in order to verify the Harassment Injunction is valid and had been served. PO TERRELL and I confirmed the injunction had, in fact, been served. It had been entered into the system on 1/27/2022. It is valid until 2/9/2026.

At that point, PO TERRELL and I entered the gas station and requested to view surveillance footage of LOUIS on the property of the gas station, ON 3/3/23 AT APPROXIMATELY 9:50pm. PO TERRELL viewed surveillance footage which showed LOUIS knowingly and intentionally standing in front of the gas station's main entrance. LOUIS can be observed approaching several patrons, in what appeared to be an attempt at panhandling. Several patrons can be observed walking in a fast pace, past LOUIS to their vehicles. LOUIS can be seen approaching patrons' vehicles, as well, before entering into the gas station building, without consent. Once inside of the building, LOUIS was told to leave. LOUIS did not immediately exit the location. He walked around the gas station and requested patrons give him money or buy him food. SANDHU then informed the gas station manager who ultimately called police. SANDHU stated LOUIS left just prior to officers' arrival on scene. SANDHU stated he last saw LOUIS walking W/B on W Burleigh St then S/B in the alley between N 20th St and N 21st St.

PO TERRELL and I then provided SANDHU with a PV-17.

While at the location, PO TERRELL checked the licenses to ensure they were/ are valid.

PO TERRELL and I then left the location in an attempt to locate LOUIS in the area. We were unable to locate LOUIS.

SANDHU was cooperative and pleasant with officers. He assisted officers with viewing surveillance footage and showed us where the licenses were posted.

This report is written by PO James TERRELL, assigned to District Five Late Power Shift, squad 5468 with PO Nora BURLO.

On Sunday, April 9, 2023 at approximately 7:12PM, I was dispatched to a fight at 1909 W Hopkins St (Gas N Go Gas Station), which is located in the City and County of Milwaukee.

Upon arrival I observed subject who was identified as Beatrice JOHNSON (F/B, DOB 09/22/1964) inside of the location arguing with her daughter "COCO" (B/F). COCO is paralyzed and uses a motorized wheelchair for transportation. District Five Police Officers are very familiar with the two subjects. JOHNSON'S residence has become a nuisance property due to 911 abuse. COCO appeared intoxicated and she had pulled the plug to her colostomy bag causing her urine to drain on to the floor mats inside of the premise. PO BURLO and I were ultimately able to diffuse the argument between the two subjects as the two separated away from each other and left the location. I spoke with the agent at the premise who was identified as Sandeep GILL (M/W, DOB 12/11/1990) who stated JOHNSON and COCO were inside of the location arguing for approximately 30-40 minutes. GILL stated he hoped the argument would diffuse itself and the two subjects would leave but instead it became more aggressive, so he called for police services to have the two subjects removed from the premise. GILL stated he works at the location every day from 4:00 PM-10:00P. GILL was cooperative in this investigation.

On Tuesday, August 8th, 2023, at 1:31 AM, Squad 5372, P.O. Chad Boyack and P.O. Ryan Clementz, was dispatched to 1909 W Hopkins St for a Subject with Gun Complaint.

CALLER: MALE CALLER- (414) 444-7638

The caller stated that a male subject wearing all black had displayed a firearm.

Upon officers' arrival they observed a black male subject wearing all black standing near the gas station and upon the subject noticing their squad car he fled on foot. After a short foot pursuit, the subject, Antoin ROBERTSON (M/B 3/13/06) was taken into custody. It was later determined that ROBERTSON was not the subject noted in the CAD comments and he was issued a citation for resisting. No firearm was recovered.

It was later determined that the vehicle involved in the incident was a white Infiniti QZ occupied by two black males. The first was a heavysset black male who was the driver and the subject who was armed the a passenger described as a black male, skinny wearing stonewashed jeans. The vehicle was last seen going northwest on Hopkins St.

This report was generated based off of CAD comments and citation narrative from this incident.
