Since 1985, Ruan, Inc., a truck-leasing firm, has maintained a facility of about 2.5 acres at 1050 E. Bay Street on Jones Island. Its lease terminates on December 31, 2001 and they pay an annual rental of \$23,945.

In 2000, the Board, at staff's recommendation, decided to maintain Ruan (a non-essential Port tenant) on short term, year to year lease, with a view to reutilizing the property in a more Port oriented operation, such as the relocation of the container yard at some future date.

Ruan has requested their current lease be extended through 2002. Staff recommends this short-term extension.
