Report on the Renewal Application of the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Claiborne M. B. Green, for the premises located at 906 South Barclay Street in the City and County of Milwaukee, Wisconsin ("The Point").

- 1. Claiborne M. B. Green (hereinafter "the Licensee") is the holder of a Class "B" Tavern and PEP Licenses for the premises located at 906 South Barclay Street in the City and County of Milwaukee, Wisconsin ("The Point"). Said license expires at midnight on July 16, 2017.
- 2. An application to renew said license was filed with the Office of the City Clerk on June 9, 2017.
- 3. Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On June 9, 2017, the Milwaukee Police Department responded with a report that could from the basis for nonrenewal of said license.
- 4. On June 16, 2017 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 68, 85 and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on June 27, 2017, commencing at approximately 10:30 a.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was represented by Attorney Vincent Bobot.



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On February 17, 2017 Milwaukee Police Department officers responded 906 S. Barclay Street to investigate a pedestrian struck by a vehicle. The investigation revealed a security guard was attempting to speak to the driver of a vehicle, when the vehicle suddenly drove off causing the guard to fall to the ground. The security guard was not injured. Subsequent investigation revealed that the Licensee had not obtained the proper permit to host this event.
 - B. On March 17, 2017 at 11:05 p.m. MPD officers responded to trouble with subject complaint at the intersection of S. Barclay Street and W. National Avenue. The officers found a large group of juveniles that had left an underage event at The Point that ended at 10:00 p.m. The juveniles were running in and out of traffic, yelling profanity at the police and participating in small fights. Four subjects were detained and cited. The Licensee was also cited. Subsequent investigation revealed that the Licensee had not obtained the proper permit to host this event.

C. On March 31, 2017 MPD officers were monitoring the area near The Point due to an underaged event. The event ended at approximately 10:45 p.m.. Approximately 100-150 juveniles began running in and out of traffic, throwing rocks at moving vehicles, and fighting. The juveniles then went to a nearby gas station causing the business to lock its doors. Some juveniles in vehicles were cruising in the area creating traffic congestion. A total of 17 officers responded to restore order. The officers found that the applicant had hired a promoter for the event and had not obtained the proper license for this event.

D. On April 10, 2017 a meeting was held with the Licensee regarding the recent underaged event held at The Point, Also present at the meeting was Travis Chambers of Fresh Productions, who was the promoter that organized a recent underage event at The Point. He

stated the hours of the future events would change from 7:00 pm-11:00 p.m. to 4:00pm-8:00 p.m. He has roughly 30 staff who "wand" attendees and he will have them conduct "pat downs". He stated that he would have staff track attendance to remain under the maximum capacity of 385. He is requested to increase off-duty officers from 4 to 8 and will increase security to cover S. 1st St.

- E. On April 17, 2017 at 7:50 p.m. MPD officers were assigned to monitor a juvenile event at The Point. The officers secured the event at 11:15 pm without incident.
- F. On April 20, 2017, MPD officers received a complaint of naked women dancing at an event at The Point on April 15, 2017. The officers interviewed the Licensee who stated there was a private event on April 15, 2017. He stated a couple of women stripped down to bikini tops and bottoms. The Licensee indicated he was aware full nudity is not allowed. The officers asked to view the video surveillance for that night and the Licensee told them he did not know how to operate the surveillance system at that time. He stated he would contact the building owner and advise when the footage was available.
- G. On May 12, 2017, the Licensee met with representatives from MPD, the City Attorney's Office, and Alderman Jose Perez at Milwaukee Police District 2 regarding the incident outlined above in paragraph F. During this meeting, the Licensee explained that he observed things during the event that he knew were incorrect but he took no action to correct them because he was scared. Additionally, the Licensee denied that there was a collusive agreement between himself Robert Smith and Patsy James. It was suggested that he not use promoters, attend another PIVOT training, and that he provide an events list to the district. The Licensee agreed to replace or repair the camera system, attend another PIVOT training, only use the establishment for special events, and provide a list of events for the district.
- H. At the hearing Atty. Vincent Bobot stated that the event organizers threatened to sue the Licensee if he did not honor the contract for the event referenced in Paragraph F. Prior to the event, Licensee met with security he hired, the promotor's security team and agreed on ground rules for the event. The Licensee stated he has stopped taking bookings from promotors since the above referenced incident. Atty. Bobot stated that the licensee made a mistake and had no prior discipline, there will be no promoters in the future, and the Licensee will be in control.
- I. Milwaukee Police Department District 2 Captain Heather Wurth presented surveillance video of the event to the Committee. Captain Wurth indicated that there is no full nudity on the video but

it would depict the type of conduct takes place at the establishment. She stated that a meeting was held with the Licensee but has concerns about his apparent lack of knowledge about the requirements of his licenses. He failed notify the police department of two underage events and was cited for not doing so. She stated that there was a lot of manpower used to respond to the above referenced incidents.

- J. Ald. Zielinski stated that the applicant did not take the advice of the officer to add security.
- K. Ald. Coggs asked the Licensee about the content of the video. She asked how the Licensee's contracts have changed, and whether there is any language in the contract that states he can cancel the contract if there are violations of the rules. She asked how many security guards were on staff, why there was no intervention by the Licensee's security staff, and why the security guards continue to hold positions at the establishment.
- L. Ald. Lewis asked the applicant why he moved forward with the event when he noticed it was a negative event. She pointed out the fact that Atty. Bobot stated that the security was there for each dancer indicated that the applicant had some foreknowledge of what was taking place on the night in question. She asked Mr. Robert Hamilton, who worked security the night of the event referenced in paragraph F, if he witnessed the incident involving underage patrons. She asked Ms. Lena Cole, a citizen who testified in support of the Licensee, to explain the difference between a promoter and a consultant.
- M. A discussion was had between the Chairman of the Committee and Atty. La Keisha Butler, City Attorney's Office regarding the broadcast of potentially explicit content on public television. The Chairman offered citizens in the room the opportunity to leave the room before the video was shown and decided not to show the images on the recording on camera.
- N. Ald. Perez asked the Licensee how the event on the video fit in with the category of "Special Event".
- O. Robert Hamilton, 904 S. 1st Street, stated that he is in support and the neighborhood has been quiet since the applicant has been in operation.
- P. Derek Collins, 2124 N. 61st Street, stated that he held his wedding at the establishment last year and is in support of the Licensee.

- Q. Lena Cole, 1830 N. Hubbard Street, stated that she has partnered with the applicant, helped promote events, now consults, and is in support. She explained that the applicant asks her for advice on what type of event to hold to bring in a particular crowd, whereas promoters put the entire event together and often do not respect the rules of the establishment.
- R. Tacorey Edwards, 5702 N. 92nd Street, stated that she provides security for the Licensee and is in support. She stated that she was present on the day of the incident but was at the door checking for weapons. She stated that a briefing was held and it was made clear that no nudity was allowed and should be addressed immediately if it occurs. She stated that when drunken behavior is displayed patrons are redirected. She further explained that she checks female patrons at the door, checks restrooms, the exterior of the premises, and general areas of concern.
- S. Brandon King, 8814 W. Lynx Avenue, stated that he works security, has not had any issues at the location, and is in support. They have briefings for events to have understanding of events before they occur.
- T. Homer Blow, 2003 W. Capitol Drive, stated that security was not doing best job at this particular event, but the establishment should still be able to operate. He has witnessed positive events there and is in support. He stated that a penalty is warranted but not nonrenewal.
- U. Ald. Perez moved approval with a 30 day suspension based on the police report and videos.

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 85 and 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Claiborne M. B. Green, has not met the criteria to allow renewal of his Class "B" Tavern and PEP licenses without a 30 day suspension.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and PEP licenses of Claiborne M. B. Green for the premises located at 906 South Barclay Street in the City and County of

Milwaukee, Wisconsin ("The Point") with a 30 day suspension based upon the police report and videos.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes. And two (2) excused and recommends that the Class "B" Tavern and PEP Licenses of Claiborne M. B. Green for the premises located at 906 South Barclay Street ("The Point") in the City and County of Milwaukee, Wisconsin be renewed with 30 day suspension.

The suspension is in effect between 12:01 a.m. on July 17, 2017 until midnight on August 15, 2017.

- 1. Jerud G. Sagorac (hereinafter "the Licensee") is the holder of a Class "B" Tavern, Food Dealer, and PEP Licenses for the premises located at 2204 W Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("Coach Sagorac's BIG TIME Pub of Greatness"). Said licenses expire at midnight on July 19, 2017.
- 2. An application to renew said license was filed with the Office of the City Clerk on May 8, 2017.
- 3. "Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On June 8, 2017, the Milwaukee Police Department responded with a report that could from the basis for nonrenewal of said license.
- 4. On June 14, 2017 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 68, 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on May 16, 2017, commencing at approximately 9:45 a.m. in 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was represented by Attorney Brian Randall.



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On February 10, 2017 at 2:10 a.m. Milwaukee Police Department officers responded to a ShotSpotter call at 2204 W. Forest Home Avenue. The officer did not find any casings. Later a second caller called back stating he had video of the incident showing a patron of Coach Sagorac's Big Time Pub of Greatness exiting the bar and firing one shot towards Muskego Avenue. The officer spoke with the Licensee who was cooperative and allowed the officer to view the surveillance video. The video showed a group exiting the tavern at the time and location ShotSpotter recorded the gun shot.
 - B. On March 8, 2017 MPD officers responded to a battery complaint at Coach Sagorac's Big Time Pub of Greatness. The Licensee was the caller and stated a male struck him several times and he did not strike back. The officers observed the video which showed the suspect getting in the Licensee's face and attempting to strike the Licensee. The Licensee pushed the suspect away in self-defense. The rest of the altercation occurred outside of camera view. The suspect was cited for Assault and Battery.
 - C. On March 18, 2017 officers responded to Coach Sagorac's Big Time Pub of Greatness. The Licensee stated there was a fight inside the tavern and he was able to break it up and get all subject out of the tavern. A few minutes later there were shots fired outside. ShotSpotter recorded two shots fired, one in front of the premises and one approximately two blocks away. The Licensee was cooperative.
 - D. On April 17, 2017 at 4:00 a.m. MPD officers conducted a license premise check at Coach Sagorac's Big Time Pub of Greatness. The officers heard loud music coming from inside. They looked in the window and saw at least three patrons sitting at the bar with drinks. When the officers knocked they observed the Licensee let people out the back door of the tavern into the connected upstairs apartment. One officer observed at least 5 people going to the back of the bar. After several minutes the Licensee let the officers in. The Licensee was evasive and appeared heavily intoxicated. The Licensee did let the officers upstairs. The officer found two people who the Licensee stated were his employees, who were both under the age of 21. One of the rooms in the apartment was locked from the inside and the Licensee stated he did not know what was in the room. The Licensee was issued the following citations:

- E. On April 21, 2017 at 12:42 a.m., officers went to Coach Sagorac's BIG TIME Pub of Greatness to deliver citations to the Licensee. Upon entering the business the officers observed numerous customers leave. The Licensee was not cooperative with the officers. The officers advised a supervisor of their observations while in the tavern. At 12:55 a.m. officers returned to the establishment to conduct a licensed premise check. The officers located two underage subjects in the tavern and one of the subjects was armed with a gun and required force to subdue. The Licensee was on scene and when the officers asked to see the security footage he led them downstairs. The system showed only exterior cameras. The officers followed the interior cameras cable to the second floor. The Licensee was not forthcoming with this information and became defensive when asked. The Licensee was cited for two counts of Presence of Minor at Licensed Premise.
- F. On April 28, 2017 officers responded to the premises for a ShotSpotter call. The officers found 47 shell casing in the intersection of West Grant Street and West Forest Home Avenue. The officer conducted a check on Coach Sagorac's BIG TIME Pub of Greatness. The Licensee was on scene and stated he heard a noise outside the looked but did not observe anything. The officers viewed the video from the exterior cameras, which showed the group involved in the shorts fired exited the tavern shortly before the incident. The DVR for the interior cameras was not functioning. The Licensee was cooperative.
- G. On April 30, 2017 at 2:35 a.m. officers observed patrons inside Coach Sagorac's BIG TIME Pub of Greatness. The officers conducted a licensed premise check and counted nine patrons in the bar after hours. The Licensee was on scene and stated the patrons refused to leave but he was not serving alcohol. Also in the tavern was a 17 year old who stated she worked at the bar. The minor stated she was the niece of the Licensee and she was paid to work. The Licensee stated she worked for "tips". The Licensee could not produce proof of employment for the minor. Officers observed video from Sagorac's cellular device, which showed the 17 year old conducting herself as a bartender.

An underage Police Aide and a Police officer working in plain clothes were able to gain entry to Coach Sagorac's BIG TIME Pub of Greatness through the front door. Inside Aide was able to purchase a Miller Lite beer from the bartender, who was identified as the Licensee. He was cited for Sale of Alcohol to Underage Person.

- I. Atty. Brian Randall submitted a plan of action in response to MPD, and presented a copy to the Committee at the hearing, notice of nuisance premises. He stated that the Licensee made improvements to the bar, and agrees to close Sunday through Thursday at 1:45 a.m. and 2:15 a.m. Friday through Saturday and will not employ anyone underage. He stated that an ID scanner will be implemented, all patrons will be carded, and employees are expected to follow the rules. Ald. Lewis moved to enter into the record Exhibit #1, the plan of action, in response to MPD notice of nuisance premises.
- J. Alderman. Donovan stated that the previous owner had equipment installed before selling to the Licensee. He stated that he is concerned, because he has attempted to set up multiple meetings with the Licensee after which the Licensee then failed to follow up. Ald. Donovan stated he is very disappointed. Ald. Donovan submitted a paper view of the crime activity in and around the neighborhood since the sale of the establishment to the current Licensee that he obtained from the police. Ald. Perez moved to enter into the record Exhibit #2 a view of the crime activity in and around the neighborhood since the opening of the establishment.
- K. MPD District 2 Captain Katherine Wurth stated that the plan was accepted because it is a solid plan but has concerns with the gun violence and shots fired in the neighborhood since the Licensee began operating the establishment. She also stated that incidents involving the premises continue to drain resources.
- L. Ald. Lewis asked the Licensee if he has access to the database program that alerts bars of those using fake identifications. The Licensee stated he was not familiar with the program.
- M. Ald. Perez asked the Licensee why he failed to communicate with the police. Ald. Zielinski stated that his concerns are that the Licensee does not appear to know about things a bar owner should know. He observed that the Licensee failed to contact his alderman and has reports of constant problems throughout the year. Ald. Zielinski stated that he fails to see a path to improvement in the future.
- N. Ald. Coggs asked if any of the underage mentioned in the police report, former students. The Licensee stated that some of them were.
- O. Ald. Zielinski moved denial based on the police report, aldermanic, and police testimony.

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 68, 85, 90, and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Jerud G. Sagorac, has not met the criteria to allow renewal of his Class "B" Tavern, Food Dealer, and PEP licenses.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment not to renew the Class "B" Tavern, Food Dealer, and PEP licenses of Jerud G. Sagorac for the premises located at 2204 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("Coach Sagorac's BIG TIME Pub of Greatness") based upon the police report, aldermanic, and police testimony.

- 1. Mohammad S. Siddique (hereinafter the "Licensee") is the holder of a Class "A" Malt and Class "A" Liquor and Food Dealer licenses for the premises located at 616 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("AVENUE LIQUOR"). Said licenses expire at midnight, July 6, 2017.
- 2. An application to renew said licenses was filed with the Office of the City Clerk on March 22, 2016.
- 3. Pursuant to Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation.
- 4. On June 14, 2017, the City Clerk's Office provided notice to the Licensee pursuant to Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report and neighborhood objections, and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on June 27, 2017 at 1:30 p.m. in Room 301-B of the third floor of City Hall. The Licensee was represented by Atty. Vincent Bobot.



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Atty. Vincent Bobot stated that the Licensee is participating in the secret shopper program, lives in a condo above the store, and installed a security camera system three months ago to monitor littering and loitering. He asked Mr. Stewart when he purchased the condo. He asked if Mr. Benner has been asked for money.
 - B. Alderman Bauman was present at the hearing and asked the Licensee how many hours is he at the store daily. He asked Ms. Decker if she has witnessed patrons from the store throwing liquor bottles. He stated that this has been an ongoing issue with this establishment. He further explained that this has been a persistent issue at the licensed premises. He asked Dr. Tim if the issues are constant at this establishment.
 - C. Sherry Decker, 606 W. Wisconsin Ave #305, stated she has concerns with littering, loitering, public drunkenness, and harassment. She stated that she does not feel safe and has witnessed patrons throwing liquor bottles. Ald. Bauman asked her if she personally witnessed patrons of the store littering. She stated that she has personally witnessed this, as well as public drunkenness and harassment of citizens. She stated that she is in opposition.
 - D. Jordan Stewart, 606 W. Wisconsin Ave #305, stated that he has witnessed littering, harassment, and public drinking of alcohol on the street in front of the establishment by patrons of the establishment. He stated that he purchased the condo in March of 2017 and is in opposition.
 - E. Dr. Linda Tim, 606 W. Wisconsin Avenue #1301, stated that she has lived in the building for 11 years and is in opposition. She stated that she has personally witnessed the issues that takes place in front of this establishment and has not contacted the proprietor of the establishment. Ald. Coggs asked Dr. Tim if she believed a change in the operation of the establishment would help. She stated that there is loitering and littering constantly in the immediate area of the establishment. She suggested it will take assertive action to correct the problems at the location, including active patrolling of the premises and reducing the amount of alcohol being sold. She stated that the community is working together to improve the area.
 - F. David Benner, 606 W Wisconsin Avenue, stated that he has lived in the downtown area for 30 years and is in opposition. He stated that he is concerned with the loitering outside of the establishment and has been asked for money several times.

- G. Shyama Chauhan, 1760 Wimbledon Ct, Lake Forest Illinois, stated that she is the sister of the Licensee, daughter of the deceased owner, and part owner of the establishment. She stated that the staff is trained to monitor and address loitering. She stated that she is present at the premises 1 to 2 days a week at random times. Ald. Zielinski asked how she can effectively monitor the daily activities at the location if she is only in Milwaukee once or twice a week.
- H. The Licensee stated that he lives on the premises. He spends a large amount of time upstairs of the premises at this store and the nearby Dunkin' Doughnuts, which he also owns. He stated his employees are instructed to clean up daily as needed. He explained that he has been contacted by neighbors about something that fell from the top of the building, but never about littering or loitering. He stated that they have received numerous green success cards under the Respect 21 program. In response to a question from Ald. Zielinski, the Licensee stated that he asks people loitering to move two or three times a day. In response to a question from Alderman Bauman, the applicant clarified that he spends one to two hours inside the store daily.
- I. Ald. Zielinski moved approval of the Change of Agent. The motion prevailed 4-0.
- J. Ald. Zielinski moved approval with 10 day suspension based on aldermanic and neighborhood testimony. The motion failed 2-2, Ald. Coggs, Lewis voted no.
- K. Ald. Zielinski moved approval with 20 day suspension based on aldermanic and neighborhood testimony. The motion prevailed 3-1.

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 68, 85 and 90 of the Milwaukee Code of Ordinances.
 - 2. Based upon the above facts found, the Committee concludes that the Licensee, Mohammad S. Siddique who holds a Class "A" Malt and Class "A" Liquor license for the premise located at 616 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("AVENUE LIQUOR") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to renew the Class "A" Malt and Class "A" Liquor licenses. The Committee finds the neighborhood and aldermanic objections as stated above to be true. The Committee based the renewal with a twenty (20) day suspension on aldermanic and neighborhood testimony.

3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Food Dealers license and renew the Class "A" Malt and Class "A" Liquor license for the premises located at 616 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("AVENUE LIQUOR") with a twenty (20) day suspension. The Committee based its recommendation on aldermanic and neighborhood testimony. The Committee approves the Change of Agent.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of **three (3) ayes, one (1) noes, and one (1) excused** recommends that the Class "A" Malt and Class "A" Liquor license held by Mohammad S. Siddique for the premises located at 616 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("AVENUE LIQUOR") be renewed with a twenty (20) day suspension.

Said suspension to be in effect from 12:01 a.m. July 7, 2017 through midnight July 26, 2017.

- 1. Robert F. King (hereinafter "the Licensee") is the holder of a Class "B" Tavern and PEP Licenses for the premises located at 789 North Jefferson Street in the City and County of Milwaukee, Wisconsin ("Bad Genie"). Said licenses expire at midnight on July 25, 2017.
- 2. An application to renew said licenses was filed with the Office of the City Clerk on June 1, 2017.
- 3. Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On June 2, 2017, the Milwaukee Police Department responded with a report that could from the basis for nonrenewal of said license.
- 4. On June 14, 2017 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 68, 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on June 27, 2017, commencing at approximately 1:45 p.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report.



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On February 1, 2017 a Milwaukee Police Department officer conducted training at Bad Genie, 789 N Jefferson Street, for the staff on how to identify fake ID's.
 - В. On February 1, 2017 MPD officers investigated a battery complaint at Bad Genie. The victim stated he was upstairs with friends when someone spilled a drink on him and he verbally confronted the person. He stated that the same person approached him later as he was walking to the bar to get a drink. The person hit him knocking him to the ground and continued to strike him while he was on the ground. The victim stated he was then escorted out of the bar by the bouncers. The suspect was identified as Sam Curro, who is employed by Bad Genie. A witness identified Curro from a photo array. That witness observed Curro strike the victim. The witness further observed Curro speak with security guards who then escorted the victim out of the establishment. On February 15, 2017 officers spoke to the manager, Elias Jimenez, who was unaware of the incident. The manager did not have the ability to access the video. On February 16, 2017 the officer interviewed Ryan Bonen, part owner. He stated he was working that night and did not remember any fights. He stated Curro is his photographer and sometimes worked security. The officer observed the video and did not observe any fights in areas covered by the cameras. The suspect was arrested and charged with Substantial Battery by the Milwaukee County District Attorney's Office.
 - C. On February 23, 2017 at 1:15 a.m. MPD officers observed a large number of patrons inside Bad Genie. The officers conducted a count as the patrons left and had a total count of 267 patrons, which is 85 over the listed capacity of 182. There were three people working as bartenders and none had a Class D Operators license. The Licensee was cited for the violations.

- D. On March 7, 2017, a meeting was held with the Licensee and other employees of Bad Genies regarding the incident on 02/23/2017. When asked what the Licensee was doing to prevent issues in the future; he stated all bartenders had applied for a bartender's license, and that he was going to install more cameras. He explained that he had already increased his security staff on busy nights.
- E. On March 31, 2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Bad Genie but was denied entry by security at the door.
- F. Ald. Bauman asked if there was a fight at the establishment in accordance with the police report. The Licensee indicated that the matter is currently set for trial in the Milwaukee County circuit court system, and he is expected to testify in support of Curro. Ald. Bauman stated that he would support a suspension.
- G. Ald. Coggs asked if the witness was connected to the person referred to as the victim in the police report. The Licensee stated that he was.
- H. Ald. Zielinski asked the Licensee if he was aware of the issues that exist with the photographer that he employed and a specific MPD officer. The Licensee stated he became aware of these issues after the incident described in paragraph B above. He also explained that the photographer has since been fired from the establishment
- I. Ald. Zielinski moved approval with 10 day suspension based on the police report and aldermanic testimony.

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 85,90, and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Robert F. King, has not met the criteria to allow renewal of his Class "B" Tayern and PEP licenses without a 10 day suspension.

J. 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and PEP licenses of Robert F. King for the premises located at 789 North Jefferson Street in the City and County of Milwaukee, Wisconsin ("Bad Genie") with a 10 day suspension based on the police report and aldermanic testimony.

 - B. Alizar Lopez, 3203 S 13th Street, stated that he has concerns with disturbance of the peace, trash, noise and has complained to police and Alderman Zielinski. He stated that the people are patrons of the establishment.
 - C. Jose Garcia, 3202 S 13th Street, stated that has witnessed litter, dirty underwear, cars burning rubber, and racing. He stated that he has complained to the police about the violence such as fights and gun shots.
 - D. Alderman Zielinski stated that he has received several calls on fights, violence, gunshots, underwear, and litter near this premises.
 - E. Ald. Zielinski moved denial of any additional licenses based upon the police report and neighborhood testimony.

Said licenses expire at midnight on July 21, 2017.
- 2. An application to renew said license was filed with the Office of the City Clerk on May 11, 2017.
- 3. Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On May 11, 2017, the Milwaukee Police Department responded with a report that could from the basis for nonrenewal of said license.
- 4. On June 14, 2017 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and the neighborhood objections. The matter was scheduled for a hearing on the police department report on June 27, 2017, commencing at approximately 11:00 a.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report.



- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On January 1, 2017, members of the Milwaukee Police Department were dispatched to a shooting at 7420 West Villard Avenue, "Dee's Elegance", the licensed premises. Officers discovered the shooting victim inside the tavern. The Licensee was on the scene and cooperated with the investigation. Milwaukee Police Incident Report #170010043 was filed.
 - B. On January 1, 2017 MPD and Alderman Johnson met with the Licensee and additional parties at 7420 West Villard Avenue, "Dee's Elegance". The Licensee stated she hired a new security company, posted the age limit as 30 and older, and will change the music if the crowd is getting too comfortable. She is also looking into purchasing an ID scanner and a door frame metal detector. The Licensee was advised to post "No Firearms Allowed" signs on the exterior doors.
 - C. Ald. Chevalier Johnson was presented at Committee and stated that after the incident occurred he met with the Licensee and the Captain of the police district on how to strengthen the plan of operation. He stated that the meeting included discussions about contacting the police if issues escalate, limiting reentry into the establishment, searching patrons upon entry and reentry, purchasing a wand, and the use of ID scanners. He also stated that to his knowledge there had not been an incident since the incident on the police. He stated that there has been warning letters in the past so he recommends a 30 day suspension.
 - D. Licensee accepted a motion by Ald. Perez amend the plan of operation to include the age restriction of 30 and up after 8 p.m. The motion prevailed 4-0.
 - E. Nakenie Triplett stated that her son's father was the victim of the incident that occurred at the establishment, and the incident would have been prevented if there was a thorough search by security. She stated that a thorough search was not done and from her understanding it was because the shooter and his friend are close associates of the Licensee. She is not in support.
 - F. Homer Blow, 2003 W. Capitol Drive, stated that he is in support and that the Licensee runs a friendly establishment. He stated that the incident that occurred is unfortunate, he offers his condolences to the family of the victim, and it does not represent what type of establishment the Licensee operates.

- G. Shaquille Madison, 8247 W. Bender Avenue, stated that he is a disc jockey at the establishment, previously worked as a security at the establishment, and there was a breach in the security the night of the incident. He stated that the shooter was searched and it is impossible to check every crevice. He stated that different measures are being taken to ensure security, he offers his condolences to the family of the victim, and he is in support.
- H. Donnell Claire, 1137 W Vliet Street, stated that he works as a disc jockey at the establishment and it has always felt safe and family friendly. He stated that New Year's is a night when unfamiliar patrons enter, it is difficult to know when something is going to happen, and measures are being taken to ensure security. He stated that he is in support.
- I. Regina Boston-Dixon, 5716 W. Brooklyn Place, stated that she has a law enforcement background, feels safe in the establishment and is in support. She stated that her heart goes out to the family and the Licensee has taken steps to prevent this from happening again.
- J. Darlene Williams, 4679 N. 75th Street, stated that the security is phenomenal. She explained that her family visits the establishment regularly, and she is in support.
- K. Sheila Milton, 2521 N. 37th Street, stated that she is the mother of the Licensee and raised her daughter to be very respectful. She stated that it is disturbing that someone entered the club with a firearm, understands the hurt caused by the loss, and offered her help to the mother of the victim's child. She supports her daughter and would do what is necessary to help her in securing the establishment.
- L. Brandon King, 8814 W. Lynx Avenue, stated that he is the owner of the new security team at the establishment and is in support. He stated that he is working with the Licensee and his staff to make sure security takes the necessary steps to prevent future incidents.
- M. Lena Cole, 1830 N. Hubbard Street, stated that she had words with security on a different date than the shooting, was sought out by the Licensee to discuss the issue. She stated that the Licensee has a passion for what she does and is in support.
- N. GiGi Humphrey, 2719 N. MLK Drive, stated that she is a bartender at the establishment, the business is family-oriented, community-involved, and she is in support. She stated that her condolences go out to the family of the victim.

- O. Darryl Jackson, 4734 N. 72nd Street, stated that his condolences go out to the family, the establishment has never been problematic and participates in neighborhood events. He stated he is in support.
- P. Lewis Gamble, 3835 N. 27th Street, stated that he is a security guard at the establishment and they have taken steps to prevent future incidents, and that he is in support.
- Q. Patrice Green, 4408 N. 92nd Street, stated that she is a bartender at the establishment, the incident was unfortunate, and measures are being taken to prevent this from happening again, and is in support.
- R. Ald. Coggs asked the Licensee how it was a breach in security. She also asked the Licensee if she knew the shooter.
- S. Ald. Lewis stated that she can attest that the environment feels comfortable, but the Licensee should not become relaxed on security.
- T. Ald. Zielinski stated that the licensee attracts a certain crowd and the patrons that are in support shows her character.
- U. Ald. Perez stated that if another incident occurs the penalty will be beyond a suspension.
- V. Ald. Lewis moved approval with 30 day suspension based on the police report and aldermanic testimony.

Report on the Renewal Application of the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses with Change of Hours on Sun from opening at 2 P.M. to Opening at 12 P.M. and Change of Entertainment Removing Four Amusement Machines of Corine S. Wilson, for the premises located at 1008 West Center Street in the City and County of Milwaukee,

Wisconsin ("Wilson's Club").

- 1. Corine S. Wilson (hereinafter "the Licensee") is the holder of Class "B" Tavern and PEP Licenses with Change of Hours on Sunday from opening at 2 p.m. to Opening at 12 p.m. and Change of Entertainment Removing Four Amusement Machines from the premises located at 1008 West Center Street in the City and County of Milwaukee, Wisconsin ("Wilson's Club"). Said licenses expire at midnight on June 30, 2017.
- 2. An application to renew said license was filed with the Office of the City Clerk on April 5, 2017.
- 3. Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On April 6, 2017, the Milwaukee Police Department responded with a report that could from the basis for nonrenewal of said license.
- 4. On June 15, 2017 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on June 27, 2017, commencing at approximately 2:15 p.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee failed to appear.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:



A. Ald. Lewis moved denial based on second nonappearance.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 85, 90, and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Corine S. Wilson, has not met the criteria to allow renewal of her Class "B" Tavern and PEP licenses with Change of Hours on Sunday from opening at 2 p.m. to Opening at 12 p.m. and Change of Entertainment Removing 4 Amusement Machines based on her second nonappearance.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment not to renew the Class "B" Tavern and PEP licenses with Change of Hours on Sunday from opening at 2 p.m. to Opening at 12 p.m. and Change of Entertainment Removing 4 Amusement Machines of Corine S. Wilson for the premises located at 1008 West Center Street in the City and County of Milwaukee, Wisconsin ("Wilson's Club") based on her second nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of **four (4) ayes, zero (0) noes, and one (1) excused** and recommends that the Class "B" Tavern and PEP Licenses with Change of Hours on Sunday from opening at 2 p.m. to Opening at 12 p.m. and Change of Entertainment Removing 4 Amusement Machines of Corine S. Wilson for the premises located at 1008 West Center Street ("Wilson's Club") in the City and County of Milwaukee, Wisconsin not be renewed based on her second nonappearance.
