To Whom it May Concern,

I was sent a notice for a hearing for the above rooming house license renewal, but I am unable to attend due to my work schedule. (I work a full time job in addition to my job as a building manager at the Astor Place Apartments.)

We have had issues with St. Catherine's residents over the years. They loiter on our Knapp St. stoop preventing our tenants from entering and exiting the building. They smoke Marijuana, and yell in this same area, or along the sidewalk surrounding our building; all hours of the day. (I have had several tenants move because of the loitering and smoking.)

The week of August 15, 2022 I called the police several times. One incident was two women (I think mother and daughter from the black Town & Country minivan that had been parked for days; all day long, with people coming and going from it.) walking North and South on Astor St. In front of our building. They started screaming at each other, and I thought they were going to fight. (Since I work from home now I'm a witness to it all.) I have had to "shoo" people away that are sitting and smoking on our front stoop now too this summer. (I don't even allow our tenants to do that because our property is a non smoking property.) I'm constantly picking up trash and litter that people leave on our property.

You can check with the police department. I'm constantly calling; that is if I can get through to dispatch. (Sometimes it takes 20 minutes to get through, and the longest response time I believe was 3 hours. This is unacceptable.) I always ask my tenants to call if they see something, but they too get frustrated with the hold times and hang up.

I have also sent emails in which I have addressed these issues with city officials. As I stated in a previous email I have contacted St. Catherine's / Mercy Housing, but it's a contact form, and they don't respond; which means I don't have copies.

2nd picture is a homeless guy that followed a tenant into the building.




Picture 6 are women that are loitering on our stoop. (We have a no loitering sign with the city statute posted that they disregard.)



Hello Officer Felix,

I hope this email finds you well.

I have been made aware that there is an increase in people loltering on our back stoop. (The Knapp Street entrance to the building.) Usually it starts after the sun goes down, and lasts until the early morning hours. (I've been told it's an all day occurrence on the weekends.) My tenants are often woken up by these people, and are unhappy.

This week, Tuesday morning (approx 5:50am) I had to ask a woman to remove herself from the area because I was taking the recycling bins down to the curb. There was also a black car idling on the Knapp Street side of our building (purple running lights underneath the chassis). Unfortunately I didn't get a license plate number, and when the driver noticed I was outside for a while they drove off. When I got back inside the building there was a homeless man sleeping in the vestibule, I asked him to leave, and told him he couldn't sleep there. He cussed me out, but did move.

I called MPD and asked them to send a patrol car to the area.

ו כמוופס וארָט and asked them to send a patrol car to the area. I'm now requesting increased patrols in the area, I'm tired of asking people to move when our sign clearly states no loitering. I've had multiple noise complaints from my tenants; as well as the smell of Marijuana usage outside my tenant's windows on the first floor, Knapp Street side of the building.

I would also like to know the status regarding the St. Catherine's properties and them being declared a public nuisance.

If you could follow up with me I would appreciate it.

> Hello Mr. Bauman,

> I Believe you are the alderman for my district. I am the building manager for the Astor Place Apartments located at 1302 N Astor Street Milwaukee, WI 53202.

> I'm writing to you because after almost a month of requesting repair to burnt out city lights at the NE, SE, and SW corners of the intersection at Astor and Knapp Streets no work has been completed. (Reference DPW work order 10751003).

> One of my tenant's vehicles was stolen on Knapp Street right next to our building (thankfully it was recovered). Two of my tenant's car windows were also broken on Marshall Street by St. Paul's Church and Lincoln School. (For one of the tenants this has happened twice.)

> I believe an inexpensive deterrent to these "quality of life crimes" would be replacing the burnt out street lights, but no one seems to be able to complete this job. (I've even made several comments on my initial request.)

> I'm hoping you can help with this issue. One of my tenants also said that in his 8 years of living here crime has only gotten worse.

> In addition to the above I have noticed a drug operation in the neighborhood. One of my previous tenants, that I tried to evict for almost a year, was a main supplier (the police department knows about him) Now that he is gone I still see his "co-workers" hitting other buildings on Knapp Street. (The Empire Apartments, the apartment building East of that, St. Catherine's Transitional Housing, and the building just West of that to name a few.) My tenants on the first floor of the Knapp Street side of the building complain about Marijuana smoke going into their open windows.

> I've also had to ask random people not to sit on our stoop at the Knapp Street entrance to our building, there is a sign on

the door stating the City Ordinance Violation number for loitering and prowling. This stops people for awhile, but then they're back at it. I have contacted St. Catherine's to complain because it is usually their tenants; but I'm tired of cleaning up litter, seeing drug deals (yes I have called the police on multiple occasions, but there has been little they can do), and our neighborhood is turning into a less than desirable location. This is Yankee Hill, and it used to be a great place to live; now it's deteriorating rapidly.

> As our alderman I'm asking you to do something about these issues. It's obvious that a citizen like myself isn't getting very far with this city's many bureaucracies. If you are not my alderman please forward this email to the correct party.

> I don't want excuses about budget cuts, staffing shortages, etc. Just get the job done please.

PO Molly PLUMLEY and myself are your new CLO's. PO FELIX has transferred to another unit.

Shopping carts can become a real nuisance to neighborhoods and especially the handicapped who rely on sidewalks to get from point A to point B. So much so, a long time ago the City of Milwaukee introduced Municipal Ordinance "110-36 Shopping Cart Management". It sounds like you did the right thing by contacting the City regarding this, and the store.

The ordinance states some helpful information on how this matter should be addressed:

-Police have discretion to cite anyone who is caught removing from an establishment or abandons a shopping cart.

-Shopping cart owners are supposed to make reasonable efforts to promptly return the carts to their premises.

-After the City Department of Public Works receives information of abandoned shopping carts, any carts not promptly returned to its owners, shall be, at the sole discretion of the department of public works, be deposed either by returning them to the store, or dropping them off at a self help center for the store to pick up.

-If the city records 100 or more carts recovered by the City department of public works on 12 months, the store must implement anti-theft measures to prevent this in the future.

I will talk with my CLO partner PO Molly PLUMLEY to see if there is anything further Police might be able to do.
