2	PRESIDENT HINES: For the next several
3	items, we will use the services of the court
4	reporter. Let the record reflect that the court
5	reporter has been sworn in. Will the city clerk
6	please identify the next items before the Council?
7	CITY CLERK: Item No. 2: The Licenses
8	Committee recommends approval of File No. 091260
9	motion to approve the recommendations of the
10	Licenses Committee relative to licenses. Included
11	in the file are the following recommendations:
12	Renewal with a ten-day suspension based
13	on a police report of the Class B Tavern and
14	Tavern Amusement Licenses of Hussein P. Govani,
15	agent for Homestyle Restaurant Group, for the
16	premises at 721 South Cesar Chavez Drive known as
17	Club International in the 12th Aldermanic
18	District. No written objections have been filed.
19	Nonrenewal based on a police report and

20	testimony from the local alderman and neighbors of
21	the Tavern Amusement License of Samer L. Asad,
22	agent for Lounging Around Incorporated, for the
23	premises at 715-717 South 5th Street known as Envy
24	Lounge and Nightclub in the 12th Aldermanic
25	District. Written objections have been filed.

2	Class D Bartender License of Christopher L.
3	Sidling. No written objections have been filed.
4	Nonrenewal based on nonappearance of the

7	Nonrenewal based on nonappearance of the
8	Class D Bartender License of Roger C. Gordon. No
9	written objections have been filed.

11	Class D Bartender License of Benjamin J. Fetters.
12	No written objections have been filed.
13	And renewal with a 25-day suspension
14	based on a police report of the Class D Bartender
15	License of Nicholas J. Moyles. No written

17	PRESIDENT HINES: Have the members of
18	the Common Council read the reports and the
19	recommendations of the Licenses Committee and

20	exceptions filed in this matter? Will the city
21	clerk please call the roll?

1	PRESIDENT HINES: 14 ayes, 1 excused.
2	CITY CLERK: Are either of the following
3	or their counsels present, and if so, do they wish
4	to address the Common Council: Samer L. Asad?
5	Counsel is present; Kevin M. Schwabe? Not
6	present.
7	PRESIDENT HINES: Alderman Bohl moves
8	that the Common Council resolve itself into the
9	Committee of the Whole for the purposes of hearing
10	licenses and oral arguments on behalf of the
11	licenses in opposition to the report and
12	recommendations and a statement presented by the
13	city attorney. Are there any objections? Hearing
14	none, we are now in the Committee of the Whole.
15	Each side shall be limited to five
16	minutes, and the arguments shall be limited to the
17	subject matter of the report and the
18	recommendations and the written exceptions.
19	With that being the case, please

20	approach the microphone and identify yourself and
21	go into your presentation, please.
22	ATTORNEY GERIN: Thank you, Mr. Chair,
23	members of the Common Council. Thank you for
24	taking the time to hear me. I am, my name is
25	Michael Gerin, G-E-R-I-N. I'm a lawyer with the

1	law firm of Gimbel, Reilly, Gerin & Brown. And I
2	am here on behalf of on March 8th the Common
3	Council, the Committee denied the Tavern Dance
4	Renewal License for the premises at 5th and
5	National Avenue. Mr. Asad, the licensee, is
6	present. But on March 8th the Committee approved
7	the renewal of the Class B License but denied the
8	Tavern Dance License.
9	Our office filed the appropriate
10	objections. And without belaboring the objections
11	that are set forth in there, I am respectfully
12	requesting that the Committee as a Whole consider
13	sending this back to the Committee because a
14	review of the transcript by me and my office, and
15	I believe a fair reading of it, is that there were
16	several items that were not considered.
17	One of the things that was discussed at
18	some length was whether or not Mr. Asad had made
19	an appropriate representation as to the type of

20	business he had. He represented that he had a
21	business plan that he had submitted to the
22	alderperson and to the Committee. For some
23	reason, that was not available either by the
24	Committee, not available to the Committee, and Mr.
25	Asad and his counsel did not have that at the

1	present time, at that particular time. I reviewed
2	it, it seems pretty consistent with the way it
3	operated. I think even if he sat down and visited
4	with the alderperson, there may be a different
5	view on that particular issue. I realize there
6	are some other issues that are confronting it, but
7	if you look through the objections, three or four
8	of them are stolen purses. The man has cameras
9	all over the place, nobody ever told him when the
10	purses got stolen in the place. He would have
11	been able to find that out. He has a purse check
12	in the operation.
13	It's a very responsive well, in any
14	event, should the Committee, should the Committee
15	as a Whole, Common Council, agree to send this
16	back to committee, you have a licensee who has
17	been in business for three years, and who I think
18	under anybody's version, has done his best to run
19	a decent operation. He is concerned about guests'

20	safety. He didn't implement some things that
21	should have been implemented prior to that
22	committee meeting. Since that time, he has done
23	an awful lot because he is going to continue in
24	operation with just a Class B. But, if you were
25	to send it back, clearly, he would not have a

1	license for at least 30 days. He would it
2	would, in fact, be a revocation. He has never had
3	a warning of any of these items that were in here
4	before. We objected to the or counsel didn't
5	object, but there was some testimony that was
6	brought in that was clearly hearsay. There was no
7	substantiation that some of these things occurred.
8	The one fight involves a party bus parked outside.
9	Another objection was a fight broke out by two
10	women over a man; it wasn't the guy. But there
11	was just a lot of little, several of these things
12	that really never were pinned precisely to the
13	operation of the club.
14	The Committee voted 4 to 1 to deny the
15	renewal. I ask respectfully, suggesting if the
16	Committee as the Whole has any questions of Mr.
17	Asad, he's here to answer those. He does have an
18	interest in being a responsible owner.
19	I, as a city of Milwaukee resident,

20	agree that economic development is important in
21	our community as long as we have responsible
22	business leaders. To allow places to just die
23	makes no sense to me. I think he should have been
24	given the opportunity to have a warning about
25	this, or a progressive discipline is something

1	that I thought the Committee followed. In this
2	particular case, it was not.
3	So that's my request. If anybody has
4	any questions, I'll be pleased to answer any of
5	those questions. Mr. Asad is also present, and he
6	would be happy to answer any of the questions.
7	PRESIDENT HINES: Thank you, Attorney
8	Gerin. Are they any questions at this time of the
9	attorney or the applicant? If not, thank you,
10	sir.
11	We will now hear from the City
12	Attorney's Office, Assistant City Attorney, Bruce
13	Schrimpf.
14	ATTORNEY SCHRIMPF: Thank you, Mr.
15	President. Bruce Schrimpf from the City
16	Attorney's Office.
17	During the course of the hearing in this
18	matter, a number of neighbors came forward to
19	complain about the activities of the patrons,

20	particularly at closing time: noise; litter;
21	public urination; that kind of thing. The
22	Committee considered those matters.
23	There was a great deal of testimony
24	about the change in the plan or change in the
25	format of the entertainment. 90-35-7 requires

1	that if there is an intent to change the
2	entertainment, that notice of that be filed with
3	the city clerk. I do not know, I do not
4	personally have knowledge of what the plan of
5	operation and entertainment was that was filed
6	with the renewal of the license. The license
7	office has those particular documents. And I
8	don't really know if at the time of renewal a
9	change of entertainment was officially filed with
10	the city.
11	Whether or not you adopt this
12	recommendation, of course, is reposed to your
13	sound discretion. As counsel indicated, the
14	recommendation is renewal of the Class B and
15	nonrenewal of the Tavern Dance License.
16	Certainly. I'm satisfied that the record is
17	sufficient to support that particular
18	recommendation. But whether or not you send it
19	back to Committee for further elucidation of the

20	change of entertainment and the change of format
21	that the place wants to put in, that's reposed to
22	your sound discretion. And whether or not you
23	renew the Tavern Entertainment License with a
24	suspension or without a suspension is, again,
25	reposed to your sound discretion.

1	If you have any questions, I'd be happy
2	to try to answer them.
3	PRESIDENT HINES: Thank you, Attorney
4	Schrimpf. Are there any questions of the
5	attorney? The chair recognizes Alderman Puente.
6	ALDERMAN PUENTE: Thank you, Mr.
7	President. Was there a change of operation that
8	they were operating prior to giving notice? Is
9	that what you meant by what you just said?
10	ATTORNEY SCHRIMPF: I am trying to check
11	that. I have ordered the transcript of last
12	year's hearing. And because there was a
13	recollection on the part of at least two
14	individuals, I believe, Alderman Witkowiak, and, I
15	believe, Alderman Kovac, that last year a
16	lounge-type of format was represented to the
17	Committee. And it was pretty evident that what
18	has happened is that it has turned into a
19	club-type of format with a lot of dancing and that

20	kind of thing. And it was the belief of a number
21	of the objecting neighbors, some of whom, by the
22	way, were businesses, that if that feature of it,
23	the dance club feature of it, is what is causing
24	the problems: the noise; the litter; the public
25	urination; disorderly patrons at closing time;

1	that kind of thing. I do not know what was
2	actually reflected in the paper that was filed
3	with the licenses office. Certainly, if there was
4	a Tavern Dance License, then there was an
5	indication of what kind of music they were going
6	to have and that kind of thing, so. And I didn't
7	have a chance to compare the two, and I'm ordering
8	the transcript from last year's hearing to find
9	out what was actually represented to the Committee
10	in terms of what the format was going to be. So
11	that's as best as I can answer that question.
12	ALDERMAN PUENTE: Would that information
13	help you if they contest this? I mean, is that
14	something we should wait to see?
15	ATTORNEY SCHRIMPF: Well, if there was a
16	representation that this was going to be a lounge
17	format and there was a deviation from that, yeah,
18	that might be information that the Council might
19	find helpful. Then again, they obviously applied

20	for a Tavern Dance License. And when you apply
21	for a Tavern Dance License, you have to put down
22	some kind of music that you're going to be
23	playing, and you have to put down basically the
24	hours that you're going to be playing it, and
25	perhaps even the days that you're going to be

1	playing. And all of that is designed to help the
2	Committee and the Council decide whether or not a
3	particular license should be granted or not.
4	ALDERMAN PUENTE: Refresh my memory, the
5	special permits, what is it, 20 a year?
6	ATTORNEY SCHRIMPF: There are 20 a year.
7	ALDERMAN PUENTE: That does not impact
8	this?
9	ATTORNEY SCHRIMPF: Well, it would
10	impact in this sense: If this council takes away
11	the Tavern Dance License, then there is no
12	eligibility to get those 20 permits for the one
13	year.
14	ALDERMAN PUENTE: Okay. Thank you.
15	Thank you, Mr. President.
16	PRESIDENT HINES: Thank you. Are there
17	any additional questions of Attorney Schrimpf?
18	Thank you. Thank you, Attorney Schrimpf.
19	ATTORNEY SCHRIMPF: Mr. President, may I

20	make one additional?
21	PRESIDENT HINES: You have two minutes
22	left.
23	ATTORNEY SCHRIMPF: I don't think it
24	will take two minutes. Thank you, Mr. President.
25	I was just advised by counsel that there is no

1	change in the license application from last year
2	to this year. So whatever was on the license
3	application last year is on the license
4	application for this year. Counsel asked me to
5	make that comment.
6	PRESIDENT HINES: Yes, thank you. With
7	no subsequent questions or additional information
8	to be provided, Alderman Bohl moves that the
9	Committee now rises. Hearing no objections, so
10	ordered. Are there any motions relative to these
11	matters? First, the chair recognizes Alderman Jim
12	Bohl.
13	ALDERMAN BOHL: Thank you, Mr.
14	President. I have two procedural requests:
15	First, members should have on their desks a
16	procedural motion that is outlined. At this
17	point, Mr. President, I would move to return the
18	Class D Bartender Renewal application for Kevin M
19	Schwabe to the Licenses Committee, Mr. Schwabe

20	did not attend a hearing, it was his second
21	nonappearance. At the time, I believe he was in
22	court and had outstanding obligations that he did
23	rectify on that day. He has provided further
24	evidence of that to the Licenses Division. And
25	for that reason, we would, I would request this

1	matter be referred back to Committee.
2	PRESIDENT HINES: That is an appropriate
3	motion, quite simple. Is there any objection to
4	the motion put forth by Alderman Bohl? The chair
5	recognizes
6	ALDERMAN BOHL: Mr. President.
7	PRESIDENT HINES: There is one
8	objection. You wanted to clarify something?
9	ALDERMAN BOHL: No, I just had two
10	requests. I didn't know there was an objection
11	PRESIDENT HINES: There is an objection
12	to the referral back to Committee for Mr. Schwabe.
13	No additional objections? Okay. The chair
14	additionally recognizes Alderman Jim Bohl.
15	ALDERMAN BOHL: Thank you. Mr.
16	President, I would ask on two matters to be listed
17	as a "no" vote. The first matter would be the
18	renewal with the ten-day suspension for the
19	Homestyle Restaurant Group, LLC, for the premises

20	at 721 South Cesar Chavez Drive known as Club
21	International. And also listed as a "no" vote on
22	the renewal with a 25-day suspension based on the
23	police report for the Class D Bartender License of
24	Nicholas J. Moyles. Those requests would be to be
25	consistent with my vote in Committee.

1	PRESIDENT HINES: Thank you. Let the
2	record reflect Alderman Bohl's objection to those
3	two items consistent with his Committee vote. The
4	chair recognizes Alderwoman Coggs.
5	ALDERWOMAN COGGS: To be consistent with
6	my vote in Committee, I would like to be
7	recognized as a "no" vote for what the Committee
8	recommended for Envy.
9	PRESIDENT HINES: Which club was that
10	again?
11	ALDERWOMAN COGGS: Envy.
12	PRESIDENT HINES: Of course. Let the
13	record reflect Alderwoman Coggs' request to be
14	consistent with her vote at the Committee hearing,
15	objection to the Envy outcome.
16	Any additional motions, any additional
17	comments at this time? If there's no further
18	discussion, I'd request a vote of those council
19	members present to approve the recommendations of

20	the Licenses Committee as contained in File No
21	091260. Will the city clerk please call the roll?
