Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. 

#### Additional Details/Narrative

Truck #696 was found on 1/16/24 operating without water – which means that employees had been preparing food without first washing hands. Handwashing alone can prevent up to 50% of foodborne illness so it is absolutely required that mobile food establishments have running water for handwashing. If lines freeze or water becomes unavailable at the handwash sink, the truck shall cease operations immediately and return to their base without posing risk to the public by serving food made by contaminated hands. This hearing shall also serve as notice that if the truck is found without water within the licensing year a citation will be issued.

The Milwaukee Police Department's investigation regarding this application revealed the following:

 On 03/22/23 at 8:02p.m., Milwaukee Police conducted a License Premise check of El Carboncito Food Truck parked at 1104 S. Cesar Chavez. No violations were found and the employees were cooperative.

2. On 08/01/23 at 12:54am, officers were dispatched to area of 1104 S. Cesar Chavez, for an armed robbery complaint, which occurred to the El Carboncito Food Truck. Officers spoke with employee of the food truck who stated that they were robbed at gun point. The suspect obtained money and fled the area on foot.

The following items pertain to the business located at 830 W. Greenfield Ave., El Carboncito.

3. On 09/16/25, at 2:30 p.m., officers were conducting checks of several food trucks parked in the 1300 block of W. Burnham St., a restricted area. Employees were advised they were in a posted temporary "No Parking" zone. An employee stated they were informed by an alderman they could park in the area. Officers advised them of the city food truck ordinance and provided information regarding parking restrictions. All of the food trucks moved from the area. A

This report is submitted by Sgt. Kevin BOLYARD, assigned to District Two, Early Shift. On Tuesday, September 16th, 2025, at approximately 2:30PM, Sgt Guadalupe RAMIERZ-CERVANTES and I went to the 1300 block of W. Burnham St.

#### **ISSUE**

The area of W. Burnham St in the 1300 block is a location that is restricted as to where food trucks are able to park. In addition to the food truck ordinance restriction, this area was designated as a no parking area and was posted as such at the time of the contact. The location was a "Temporary No Parking" zone due to the Mexican Independence Day celebration and the possibility of street takeovers that take place in the area.

area. We spoke to the responsible parties for each vehicle and advised them that they needed to move their trucks. Sgt RAMIREZ-CERVANTES advised all three of the food trucks that they were restricted from parking at the location by ordinance. Sgt RAMIREZ-CERVANTES showed the individuals we spoke to the map that was in the food truck regulations booklet that is available on the City of Milwaukee Website. Sgt RAMIREZ-CERVANTES advised them the could not park at the location and would need to move.

Each of the individuals we spoke with stated they had called Alderman PEREZ and sat down to meet with him. Each of the individuals independently stated they were at a meeting with Aldermen PEREZ when he advised them that they were able to park at the location after previously being told they had to move. Sgt RAMIREZ-CERVANTES explained to all three that the law was still there and they would need the common council to change the law. All three food trucks received their final warning regarding this issue. All three were more than helpful and understanding. All three trucks moved to park on S. 14th St where there was no restrictions.

#### **FOLLOW UP**

Sgt RAMIREZ-CERVANTES and I went inside the El Rey location where we were advised by their management that the food trucks are a nuisance for them. We were advised that they have told the food trucks several times not to have their customers park in their parking lot. The managers of El Rey stated this was an ongoing issue that makes it difficult for their customers as they take up all the spaces along the southern and western portion of the property. El Rey has a food truck that is located on their property and they have permission to sell on their property.

#### **OF NOTE**

At the time of the contact there was no security and the individuals at each food truck was cooperative. There were no further issues observed at the time of the contact.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
