If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 1. On 01/30/22 at 12:02a.m., officers were dispatched to were met by the manager, who stated two subjects were however, already left in a vehicle.	

- 2. On 02/17/23 at 1:32a.m., Milwaukee Police were dispatched to a Suspicious Person at 3636 S. 27th St., which was called in by the manager of the business. On arrival officers conducted a field interview of a subject in an auto who stated they were homeless and thought it was ok to park there for the night. The subject willingly left the location and the business was closed for the night.
- 3. On 02/18/23 at 12:08a.m., Milwaukee Police were dispatched to a Threat at 3636 S. 27th St. Investigation an argument took place between employees and threats were made. The agent was made aware of the situation and came in from home to resolve the matter.
- 4. On 03/18/23 at 9:19p.m., Milwaukee Police were dispatched to a Trouble with Subject at 3636 S. 27th St. Investigation revealed 3 patrons entered the establishment, ordered food, then left without paying. The employees were cooperative with the investigation.

- 5. On 06/16/23 at 1:36a.m., Milwaukee Police were dispatched to a Trouble with Subject at 3636 S. 27th St. Investigation revealed an employee that had been fired was hiding in the back of the building, causing employees to fear for their safety. The subject was gone on police arrival.
- 6. On 07/06/23 at 9:33p.m., Milwaukee Police were dispatched to a Reckless Use of a Weapon at 3636 S. 27th St. On arrival officers observed the agent physically blocking a patron from leaving. Investigation revealed the customer had placed an online order and received the wrong items. The customer called the store and was hung up on two times before physically coming to the store to rectify the situation. The customer admitted to throwing the food, when they claimed the agent tried to take it. The agent admitted to hanging up on the customer because the customer was using profane language. The agent requested citations be issued to the customer for battery and disorderly conduct, however, when asked about injuries the agent stated "well let's see, will you take her way if I'm hurt? Then yes I'm severely hurt and I will be going to the emergency room". Due to the actions of both parties no citations were issued and the patron was told they could not return.

On Saturday, February 18, 2023, at 12:08AM, Squad 6330 (myself and P.O. Ana ROMERO-PEREZ, both in full duty uniforms, equipped with BWCs, and operating a marked MPD squad #615) was dispatched to 3636 S. 27th Street (Buffalo Wild Wings) for a Threat complaint.

Upon arrival, we spoke with the parties involved, who were all still on scene and calm. General Manager, Scott D. PAGE (W/M, 04-07-68), Manager, Valeria M. ALMARAZ (W/F, 06-24-93), Cook/subject 1, Marquail D. STREETER (B/M, 02-20-97) and Server/subject 2, Naomi G. COTTON (U/F, 11-27-03) were all present.

PAGE stated he had come in from home, due to the incident between COTTON and STREETER, when his manager, ALMARAZ told him that STREETER was asked to leave, but was still there.

An apparent argument ensued between STREETER and COTTON, when STREETER told COTTON to pick up her order from the prep area. Both COTTON and STREETER became argumentative, and both apparently threatened to "call people." This caused STREETER to wait for police to arrive before going outside, for his own protection. STREETER stated that he had seen COTTON's father outside and was concerned about what he might do.

According to management, STREETER was the first to make a "threat," by stating "we can handle this."

PAGE stated that pending an investigation, it appeared likely that STREETER might be fired as a result of this incident.

Staff was cooperative, and STREETER left with another employee, after our arrival.

I wear the camera affixed to my upper right outer vest carrier pocket. This was done in accordance with the Milwaukee Police Department Standard Operating Procedure regarding Body Worn Cameras.

On 3/18/23, at 9:19 pm, my partner P.O. Manuel Lucena-Martinez, and I, while on squad 6231, were dispatched to Buffalo Wild Wings (3636 S. 27th St.) for a trouble with subject call.

Upon arrival, I spoke with the manager Anna Maria A. Acevedo who stated that around 8:50 pm, three black females, early 20s, came into the location and left without paying a \$130.00 bill. Staff was unable to provide names or a vehicle plate regarding the subjects.

Acevedo showed me the licenses on the wall display case, and they were all valid and up to date.

BWW does not have security at the location. Since December 2022 there has been 11 calls for service at this location which were designated as trouble with subject calls that did not pay their bill.

On Friday, June 16th, 2023, at approximately 1:36AM I, was dispatched to a Trouble W/ Subject at 3636 S 27th St (Buffalo Wild Wings) in the City and County of Milwaukee.

The dispatched call came in stating an employee that was fired today was in the back of the building. Staff was able to see the subject later identified as SKENANDORE, Roberts hiding (W/M, dark hooded sweatshirts, dark pants). Caller did not feel safe leaving the building.

Upon arrival I made contact with the caller/manager DEBRASKA, Isaiah (W/M 12-30-96) outside of the building (3636 S 27th St) and he stated subject had left the premises, possibly seen walking southbound on S 27th St. I observe DEBRASKA safely get in his vehicle and leave premises.

While on scene, I did not observe the licenses posted due to not going inside the building, I did not review video of this incident.

During my investigation for Trouble W/ Subject I did not observe any violations in the licensed premise.

On Thursday July 6, 2023, squad 6230, PO Nicholas CARSTEDT and I in full duty uniform equipped with department issued axon body worn camera and operating marked MPD squad vehicle 574, was dispatched to a Reckless Use of Weapon call for service at the Buffalo Wild Wings located at 3636 S 27th St within the City and County of Milwaukee WI.

Upon initial arrival I observed the manager/licensed agent identified as Scott D PAGE (M/W 4-7-68) to be standing inside the business actively blocking/deterring the suspect identified as Schwanda WINSTON (F/B 10-14-84) from leaving the business. WINSTON was standing with her back against the west wall inside the entrance with PAGE standing in front preventing WINSTON from leaving.

WINSTON was cooperative with officers on scene and was able to come outside of the business to provide a story of the incident that occurred. WINSTON stated she had placed an online order and when the door dash had delivered the order, it was noted to be the incorrect items placed. WINSTON stated she attempted 2 call backs and was hung up on by the staff at the business. WINSTON stated when she arrived at the location and disputed the order received, the staff attempted to take the food away from her in which she had already paid for. WINSTON stated that she grabbed the food that she had purchased and threw it towards the door. WINSTON stated that PAGE then began to push her and "get in her space" and was not allowing her to leave. WINSTON stated she had no intentions on leaving and wanted a refund or for the order to be corrected. WINSTON was issued a slip of paper stating she is not allowed at the restaurant anymore.

While on scene PAGE stated that WINSTON called the business and was upset about the order and began to use profane language, so he hung up on WINSTON. WINSTON then showed up at the business and was yelling at the staff and became loud inside the store. PAGE stated he wanted citations issued regarding battery and disorderly conduct and when asked regarding injuries, PAGE stated "well let's see, will you take her away if I'm hurt? Then yes I'm severely hurt, and I will be going to the emergency room." PAGE did not have any visible injuries on scene and did not request medical attention regarding this incident. After being advised that this conversation was recorded, PAGE did not make any further mention regarding a battery citation.

Due to the situation and actions by both parties on scene, no citations were issued, and WINSTON was advised not to return to the location.

The business' licenses were posted properly and were all valid.

This location has had four calls for service since 04/07/23.

On 07/07/23, at approximately 6:55 PM, I was tasked with addressing a trouble with subject call by telephone, originating from the Buffalo Wild Wings located at 3636 S 27th St. The nature of the complaint was in relation to two patrons who allegedly left the establishment without settling their bill.

Upon initiating the phone call, I spoke directly with the manager, Michael S KINGSBURY (W/M 05/07/78). KINGSBURY recounted the events, specifying that the two subjects in question dined at the restaurant around 6:20 PM. During their visit, these individuals raised concerns about the quality of both the food and the service they received. While the establishment made efforts to rectify the situation to the satisfaction of the diners, KINGSBURY emphasized that they still expected payment for the consumed items.

However, KINGSBURY was unable to provide the exact monetary amount owed by the patrons. Given the absence of a precise bill amount an official police report could not be filed.

KINGSBURY described the two individuals as a black male, mid-40s, wearing a red t-shirt and a black female, mid-40s, with poufy hair, and a heavy build.

Additionally, the duo was reported to have departed in an older model silver sedan. A notable feature of this vehicle was the visible damage to its front passenger side. Although KINGSBURY was able to relay a potential license plate number, HXU859, subsequent checks on this information yielded results that did not align with the given vehicle description. The likelihood is high that the plate details were inaccurately recalled.

Before concluding, a routine verification was performed, confirming the validity of all business licenses associated with Buffalo Wild Wings.

On Monday, September 4, 2023, at 9:27pm, I responded to 3636 S 27th St, (Buffalo Wild Wings) for a report of a workplace injury. According to the CAD the caller indicated one of the managers had a projector fall on his causing him an injury.

Upon my arrival I spoke with Annamaria A ACEVEDO (W/F, 2/25/89) who stated that she was the manager on duty. ACEVEDO stated that her coworker, Michael S KINGSBURY (W/M, 3/13/78), also a manager, had been "Knocked out" by a falling projector. ACEVEDO stated that members of the fire department arrived on scene evaluated him and suggested that he be seen by medical professionals. They also advised that there was a long wait for an ambulance to respond and suggested having someone drive him to the emergency room.

It should be noted that when I arrived on scene MFD had already left the location.

I then spoke with KINGSBURY regarding the incident. KINGSBURY stated that he went into one of the closets to retrieve additional rags and while picking them up a large projector fell and struck him on the head and caused him to lose consciousness. KINGSBURY stated that he also had pain to his right arm and shoulder from where he fell. KINGSBURY stated that he would have a friend or relative drive him to St. Luke's Hospital for treatment in the near future.

Officer GUTOWSKI arrived on scene and took 8 photos of the area and of KINGSBURY at 9:45pm. The photos were later uploaded to evidence.com.

I did not review security camera video at this location as the location where the incident occurred is not captured on camera.

The agent was not notified by law enforcement but was notified by ACEVEDO of the incident.
