Charles Burgess, assistant manager, at the table with the applicant.

Alex Runner from Ald. Hines' office present at the table.

The applicant says that the building violations are being addressed with court dates. Regarding the underage event, Ms. Martin says the alderman's office told her that she did not need any permits, but she later discovered that was not true. Mr. Burgess says

they were told later that they needed to contact Sgt. Chet Ulickey to provide notice to the police.

Ms. Martin says they have taken measures to keep bottles of liquor from being contaminated, and says that the invoices for the alcohol were on premise but were locked up. Mr. Burgess says that now invoices are kept in a book at the bar at all times.

Mr. Burgess says the the police come in three or four times a week, which is bad for business. He believes that the police are viewing the establisment based on the location's previous staff and history. Mr. Burgess also says that they are trying to make the bar a safe environment. He says a totally new staff has replaced that of the previous incarnation of "Leoric".

Mr. Burgess says that there is security that is licensed to carry firearms, but are not allowed to because the owners don't want firearms on the premises.

The background investigation reveals that there is an eviction in process for the applicants at the business location. Having a lease for a business operated by someone else is not allowed.

Alex Runner, Staff Assistant for President Hines. Says Hines' office was told that the applicant had not met with the Business Improvement District. Pres. Hines believes that there is a public relations problem with the establishment and that perhaps the name of the establishment should be changed.

Ms. Martin says that they have met with the BID and the community planning council.

No neighborhood objectors present.

Ald. Hamilton asks whether the application can be heard without verification of a lease. Sgt. Ulickey says the main concern is with residency. Asst. City Atty. Bruce Schrimpf states that there is not a specific requirement for a lease, but there is a requirement that the license holder have control of the premises.

Mr. Burgess states that efforts to change the crowd from that of the previous incarnation of the establishment, including security cameras and closing early, have been made.

Mr. Runner says that Hines' office prefers the applicant to the current owner of the establishment, a Mr. McKenzie.

The applicant prefers thirty and above as an age restriction, but is requesting age twenty-five and over. Ms. Martin and Mr. Burgess also said that they want to change the name, but were told that they could not. Rebecca Grill clarifies that a request for a name change can be put in the application; the change just cannot be made to the establishment while it is licensed by someone else.

Ald. Wade at the table. He says that he has seen a much better clientele now that the new applicants have taken over.

Ald. Bohl requests the transcript.

Ald. Zielinski moves that the application be held to the call of the chair. Ald. Bohl wants it scheduled for the next cycle. Prevailed 5-0.

Atty. Andrew Arena at the table with the applicant.

Atty. Arena says that the shooting incident under item #8 was reported incorrectly by the media. He also says the incident is on video taken by bar security cameras. He says a group of patrons came in and stayed for about two hours playing pool. The two individuals involved in the shooting had no contact in the bar prior to the shooting according to the video.

The bar now has metal detectors and a device for scanning IDs. Atty. Arena says that the owners run a tight ship.

No neighborhood objectors present; supporters are present.

Dennis Reding, 2538 S. 6th St.; says it's the only pool hall in the area with more than two tables, which helps eliminate conflict. He says the type of patrons in the bar is much better than that of the previous establishment. He says it's a great establishment.

Juan Ruiz, 1547 S. 30th St.; says the place is much better than the previous establishment. He was there the night of the shooting and says he never saw the two people involved in the shooting conversing before the incident.

Niah Laska, 8601 W. Dakota St.; is a bartender at the establishment and was present the night of the shooting. She says she feels safe there and that the owners are great.

ALd. Zielinski arrives at the table at 8:46.

Janine Oshkenaniew, 1234 S. 23rd St.; was also a patron of the previous establishment. She says she feels safe at the location and has witnessed no other fights. Goes two or three times a week.

Victor Balistreri, 3130 W. Lincoln; has been patronizing for about two years. Has never seen any trouble there and feels confortable there. Was a patron of the previous establishment and sees a change for the better.

Jon Lusz, 3481 Bristol Creek Dr.; son of the applicant. He says the place is very safe and that patrons tell him that they enjoy going to the establishment.

George Crandall, 2355 S. 33rd St.; wasn't there for the incident, but had a retirement party there two weeks earlier and was impressed with the security at the bar. There were no incidents whatsoever while he was there. He also witnessed a person without

identification refused service at another time.

Ald. Donovan agrees with the testimony given by the supporters. He was not in support of the licensee at the beginning because of the issues at the previous location. He says that by all indications the applicant has turned things around. Ald. Donovan also says he saw the video of the shooting incident and saw no indication of any conflict between the shooter and the victim. He appreciates the video surveillance provided by the bar. He believes the applicants have done the best they can and does not hold the applicant responsible for the shooting incident.

Ald. Zielinski asks about preventing guns from getting into the establishment. The applicant says she obtained a detection want, an ID scanner and signs right after the shooting.

Atty. Arena says the the ID scanner is very instrumental in keeping problem people out of the establishment.

Neighborhood objectors present:

Commissioner Jeannetta Simpson-Robinson of the Juvenile Justice Commission and founder of Career Youth Development; lives one door away from the establishment and has for over 40 years. She is in support of the establishment as a grocery store, but is not in favor of the malt license. She points out various crimes committed by intoxicated people in the neighborhood and states that an alcohol outlet is not good for the community. She says the has experienced intoxicated people urinating on her

flowers and entering her home and has witnessed intoxicated people creating disturbances and drinking beer openly in groups.

Charles L. Walton, 2916 N. Mother Simpson Way, son of Jeannetta Simpson-Robinson and Deputy Director of CYD. Also lives next door to the establishment. Has witnessed loitering and other problems related to alcohol consumption in the community.

The applicant says about 35 percent of his sales are liquor sales.

Ald. Coggs asks about loitering and litter at the establishment. Mr. Eid says he calls the police if he witnesses any problems and takes care of issues.

Neighborhood supporters:

Carl Martin, 2729 N. 4th St., lives about four blocks from the establishment. Says he never sees any violence at the establishment and that he does buy beer at the establishment. He says he has not witnessed any loitering, although he does say that sometimes people in the neighborhood try to converse with people waiting at the bus stop.

Lorraine Otis, 910 W. Locust St., lives next door to the store. She says that she has never had any problems at the location. Says she has not noticed any loitering, littering or prostitution at the location. She also says she has never witnessed sales to intoxicated persons.

Mr. Cherella says that the neighborhood objections cannot be attributed specifically to the establishment's liquor license.

Linda Mistele, 822 E. Burleigh St., about 500 yards from the location. She is objecting to the liquor license. She believes that there is plenty liquor in the area. She says there are homeless people and panhandlers in the neighborhood. She also does not want a lot of noise early in the morning. Ms. Mistele thinks more alcohol would be a detriment to the neighborhood.

Ald. Zielinski asks Mr. Johnson why he believes the establishment needs a liquor license to serve breakfast. Mr. Johnson says he doesn't believe the establishment will survive without a liquor license.

Ald. Hamilton asks Ms. Mistele whether it would make a difference to her if the establishment closed at midnight instead. She said not really. She is considering the safety of her teenage daughters.

Neighborhood objector:

Michelle Burke, 3128 N. Fratney St., directly west of the bar. She believes that the business will take away from the flavor of the neighborhood, which is now quiet. Ms. Burke believes that Mr. Kelly is an absentee landlord. Says she was not able to attend a neighborhood meeting, but submitted a written objection. Capt. Donald Gaglione present in the Chief of Police's stead. He is the district commander for District 6.

Vickey Mendez present at the table. Atty. Narciso Aleman present as counsel for the applicant.

Ald. Donovan also at the table. Asst. City Atty. Tom Miller is at the table replacing Asst. City Atty. Bruce Schrimpf due to a relationship with one of the neighborhood objectors. Ald. Bohl says that all testimony must be restricted to events that occurred after the license was renewed in February unless they had not been brought before the committee previously.

Ald. Hamilton moves to make all of the documents in the file part of the official record. Prevailed 3-0 (Alds. Zielinski and Kovac excused).

Capt. Gaglione read from the official police department complaint. Sgt. Ulickey read from the police report items that occurred since the renewal of the license in February of 2008.

Officer Todd Bohlen from District 6 appears to testify regarding the undercover investigation during the month of March.

Alderman Bohl instructs testimony relating to gang related activity alleged by an informant struck from the record.

Atty. Aleman objects too consideration of testimony based on items in the police report that deal with charges against Joseph Mendez, son of the applicant.

Officer Bohlen is asked about the information he received from an undercover officer who made a drug purchase in the establishment.

The testimony of the officers is based on standard operating procedure by the police department with regards to review of police reports and information from an undercover officer. The name of the undercover office is included on the police report of the drug buying incident.

Officer Evelyn Lazo, District 2, was involved at the time of the report with the anti-gang unit. On March 1st she was one of the officers that did a tavern investigation in "The Last Chance".

Neighborhood objectors:

Claire Zellner, 3224 W. Scott St., lives across the street from the establishment. She says she has witnessed loud music, car alarms going off due to loud noise. She also saw on one occasion someone push fighting patrons out of the establishment and lock the doors, leaving the neighborhood to deal with the problem. She also says she fears for her safety.

On Friday, April 18, Ms. Zellner witnessed patrons drinking on the sidewalk in front of the establishment and a band playing right outside the tavern's front door on Scott St.

Valdemar Gonzalez, Jr., 3234 W. Scott St., across the street from the establishment. He says he has witnessed the issues stated in the police complaint.

He says that he is the complainant about the noise in paragraph three of the police complaint. He also witnessed the graffiti problems and noise problems listed on specific dates in the police complaint. Mr. Gonzalez, Jr. also says he witnessed a loud fight on January 23rd involving the Mendez family. He also says he witness a physical fight out on the street and he has experienced patrons urinating in his yard and on his porch on three occasions. Mr. Gonzalez, Jr. says he saw the persons urinating on his property come out of "The Last Chance".

Ald. Bohl states that the objector's testimony about the Mendez family calling about the graffiti must be stricken from the record since he did not have direct knowledge of the calls.

Recess 8:00 p.m. Resume 8:11 p.m. Atty. Aleman requests that the meeting be adjourned and held for another meeting due to the late hour and the loss of neighborhood supporters. City Atty. Tom Miller reminds the committee that the police department, which is the complainant, has not rested its case.

Mr. Gonzalez, Jr. says that he has talked to the licensee twice since February 5, 2008. The rest of the half a dozen times that he has talked to someone, it has been with the husband of Vickey Mendez.

In response to questions from Atty. Aleman, Mr. Gonzalez, Jr. says he talked to Mr. Mendez yesterday in the presence of a property owner, Mr. Cardenas. Mr. Gonzalez, Jr. says that Mr. Mendez was standing outside of his property before they talked. Mr. Cardenas was handing a letter to Mr. Mendez, and Mr. Gonzalez, Jr. informed Mr. Cardenas that any neighborhood objectors had to appear.

Mr. Aleman asked Mr. Gonzalez, Jr. if there is any other establishment in the neighborhood that could be the source of noise and litter. Mr. Gonzalez, Jr. said no. He also said there are no other taverns on the block.

Officer Carlos Felix, assigned to District Six Community Prosecution. On April 6, 2008, the officer was instructed to talk to Manuel Mendez regarding graffiti on the side of his establishment. He let Mr. Mendez know that the tagging on the building was a sign of disrespect from a rival gang. Ofcr. Felix spoke with Mr. Mendez regarding the graffiti and Mr. Mendez told the officer that a neighbor may have seen the perpetrator. The officer then went to interview the neighbor.

In response to questions from Atty. Aleman, Ofcr. Felix says that Mr. Mendez filed a report regarding the graffiti.

Mr. Aleman requests that the item be held because of a health issue of his and the fact that some neighborhood supporters had to leave.
