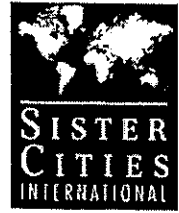

Dear Peace Education Project of Peace Action Wisconsin :



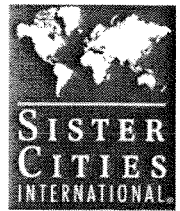


