Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, lilegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. Hello, I've looked through all four records/locations for this business, and only one record has food trucks on it (551 W Mitchell St), but does not currently have any other DPW objections on it. Are we able to verify their peddler unit permit number? I ask because FPMREST 1687 with Permit Number 0957 has a different place (SJ7941), and FPMREST 1935 with Permit Number 0458 has no plate number or VIN nor has this information ever been listed on the original or renewal applications for this vehicle, and the itinerary lists this vehicle as operating in Racine (as of the renewal we received in September.)

Also, the peddler units are not aligned with themselves nor either are aligned to the BTAVN and FREST licenses. Should I add the objection to FPMREST 1935 or should I add to the BTAVN and FREST license?
