Ok, so I talked to the driver from this incident. He has been driving with us since 2012 and does this for a side job. He is a college graduate and works full time as an operations manager with another company. He uses the money from the Pedal Tavern job to work on his start up business which produces an organic fertilizer called worm castings. With that said, I find him very smart and a safe, cautious driver. He has always done an excellent job as a Pedal Tavern driver and we have never had an incident with him in the past.

Isaac (our driver) was headed west on St. Paul and turning left (south) onto Water St. Doors Open Milwaukee was going on this day and the Third Ward was very very busy. People and cars were all over the place. He had a green light and proceeded to turn left as no cars were headed east on St. Paul. As he was turning, an ambulance was driving North in the south bound lane on the west side of Water St. Because there was so much traffic, the ambulance was only able to travel the wrong way to get around all the vehicles.

Once Isaac saw the ambulance, his first reaction was to slow down. Since he was turning, he ended up slowing down in the middle of the intersection, and as soon as he realized the ambulance needed to head north he told his group to pedal, and they immediately pedaled fiercely to get out of the way allowing the ambulance to swiftly get through the intersection.

The ambulance driver acknowledged Isaac and even gave him a smile and Thumbs UP!

Isaac's Pedal Tavern slowed down the ambulance by a few seconds. I would assume that all ambulances will slow down when they are running a red light.

Our Employees will confiscate suspicious fluids (Just like Brewers on summer-fest)

What are your plans to ensure amounts in excess of that allowed by law (36 ounces per person) will not be brought on the pedicab? Head count X 36 ounces - Then count ounces in cooler. Passengers

will not be allowed to purchase beer at convenience stores during ride.

What are your plans to ensure amounts in excess of that allowed by law (36 ounces person person) will not be consumed by any one individual on the pedicab?

We will post ordinance on Pedal Taverns and ensure everyone follows ordinance.

Also, riders are not allowed to grab extra beers after we depart.

What are your plans to ensure glass beverage containers will not be carried upon the pedicab?

**NO GLASS!** Emails/phone calls/signs. We have been enforcing this since we started and it has not been a problem.

What are your plans to ensure no underage persons are on the pedicab when fermented malt beverages are present?

- 1) All passengers must be 21+ when fermented beverages are on board. We ID everyone.
- 2) Our starting bar ID's everyone before they enter.

How will disorderly and/or intoxicated patrons being addressed?

If a passenger shows up intoxicated, they will not be allowed on (similar to an airport). We enforced this a few times last year.  
 If rider becomes disorderly during ride, said passenger will be kicked off and one other rider must escort them.

How will patrons be notified of the restrictions on alcohol beverages?

Conspicuous posting of a notice of restrictions  Other:

Plus we notify pre-tour with phone/text/email

What types of beverage carrying containers will be allowed on the pedicab?  Cans  Plastic Bottles

We encourage cans but do not want to limit riders preference.

Where will the patrons store their fermented malt beverages?

They will bring their own cooler or rent one from us.

Riders will NOT be allowed to play music while vehicle is idle (this will limit excess noise)

Easiest way is to turn down music and tell people to be neighborly.
