We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the Police Officers on whose behalf this claim was filed.

CONCLUSION:

On July 11, 2000, Police Officers Gilbert CARRASCO and Christopher BLASZAK came upon two juvenile boys fighting in the street. A crowd of about 20 to 30 people gathered to watch. The officers used their squad loud speaker to order the crowd to disburse, but the boys kept wrestling in the street. The officers ordered the juveniles to stop fighting, attempted to separate them and then struck them several times with their batons to stop the fight. These blows were observed by numerous citizens and the crowd became hostile, causing the officers to flee with the two #6

LOGGIN was treated at St. Luke's Hospital for a contusion to the elbow and recommended Tylenol for pain.

On Thursday, August 17, 2000, this case was reviewed in the District Attorney's office by Deputy District Attorney Jon REDDIN. In reviewing the case Deputy District Attorney REDDIN declined to issue criminal charges against the officers because it appeared that the officers used objectively reasonable use of force in separating the two juveniles. Therefore, this case is cleared as warrant refused.
