On Wednesday, February 3, 2021, my partner Police Officer Michael WARD and I, assisted the City of Milwaukee Health Department, Environmental Health Specialist Leslie WROBLEWSKI issue a citation to listed agent of Petro Mart located at 702 W. Oklahoma Avenue. The citation was issued by the Health Department for violation of the Mask Mandate, City of Milwaukee city ordinance 62-8-1.

Upon arrival, we were met by the listed owner/agent Khawar A. KHALIQ (a/m, 04/18/83). I observed there to be "mask" signs posted on the front entrance/exit doors and on their glass windows visibly displayed. These signs indicated that masks must be worn and some signs were also translated in Spanish. Officer Ward heard KHALIQ advised a patron who entered the business without a mask, that he needed to put on a mask if the customer wanted to enter. The customer did comply and exited the business to retrieve a mask.

WROBLEWSKI explained to KHALIQ that he was going to be issued a citation for the listed offense, citation number 6165293-1. KHALIQ was provided a Milwaukee Police Issues Community Contact Card. Let it be noted that KHALIQ was very cooperative during the course of our encounter.
