Upon arrival I was met by the caller, who verbally identified himself as Maruthi M. LANKIREDDY (A/M 10-06-1999). LANKIREDDY stated that he called because two males entered the store at approximately 8:05 P.M, and one of them stole five 20oz bottles of sprite soda. LANKIREDDY stated he was in the back of the counter when he observed a black male, wearing a white t-shirt and gray pants, with bottles of soda hanging out of one of the rips in his pants. LANKIREDDY stated he confronted the male and told him that he could not take the soda and he should put them back. LANKIREDDY stated the male told him what he was talking about. LANKIREDDY then stated that the male told him that if he thought he took something he should come and remove the property from him. LANKIREDDY stated he then left the back counter and approached the male, removing one of the sprite bottles from his pants. LANKIREDDY stated the male then grabbed him by the collar of his shirt and shoved him against one of the snack racks and told him he was going to "beat him". LANKIREDDY stated he broke free and ran back behind the counter and called his manager. LANKIREDDY stated that male then left with another male in a black Jeep Compass, bearing Wisconsin plate# AZG-3671, heading Eastbound on W. Capitol Drive from the location. LANKIREDDY stated the male left with approximately five sprite sodas, valuing approximately fifteen dollars.

LANKIREDDY was cooperative during the entirety of the investigation. LANKIREDDY allowed us to view video regarding the incident.

On Thursday, October 2, 2025, Police Officer Adrian Daniel (024924) and I were dispatched to a "Shots Fired" complaint at 7609 W Capitol Drive in Milwaukee.

Upon arrival, I, Officer Lockhart, spoke with the caller, Gurpreetpal Singh (I/M 05/20/2001), who reported that at approximately 12:40 AM, he heard approximately 4 to 5 gunshots while working at the Shell Gas Station located at 7609 W Capitol Drive.

Singh, an employee at the Shell Gas Station, described an incident involving a Black male approximately 6'0" tall with a slim build, wearing a gray jacket, blue jeans, and gray and white shoes. The suspect entered the store to purchase some items and repeatedly asked Singh to come behind the counter where the cash register is located. Singh believed the suspect was attempting to rob him, as he kept requesting access to that area.

Singh allowed me to review video footage of the incident. I observed the same suspect enter a black four-door SUV parked in front of the service station. The suspect could be seen in the driver's seat waving at Singh to come outside while holding a black firearm.

Approximately 20 minutes later, the suspect returned to the service station, again waving for Singh to come outside from behind the register. After firing multiple gunshots at Singh, the suspect fled the scene in his vehicle. I was unable to capture the license plate number of the vehicle.

The suspect fired from the driver's side of the vehicle through the passenger window, striking the building. Multiple witnesses were present at the scene. I located two fragments inside the business behind the counter where Singh was standing. Officers observed multiple shots fired at the Shell Gas Station windows on the north side of the building. There is clear video footage of the incident. Witnesses fled the scene after hearing the gunfire.
